Introduction

ClayTools offers the advantage of unconstrained creative exploration without the need to think about the more technical aspects of modeling. A model generated in ClayTools can be used as a foundation for building the more technically complete model for the downstream production pipeline. Modelers can optimize the polygonal density and flow using the ClayTools model as a touchable reference within ClayTools or Maya. In addition, the detail from the ClayTools model can be extracted in the end to produce high quality normal/bump/displacement maps.

There are a number of workflow approaches within Maya for building the technical model using the ClayTools model as a 2D/3D reference. In a way, the model from ClayTools serves as a “virtual maquette.” Unlike a real maquette, all of the design intent already exists in a digital form. Therefore, the virtual maquette can be leveraged to build the technical model for the digital content pipeline. In addition, the HapticExtender/MY plug-in offers a number of powerful capabilities to assist in building the technical model, such as feeling the reference model while editing a low-polygon mesh or even placing spline or curve points.

This document contains several workflows that show how a user can either start in Maya and then use the ClayTools application to add details (sometimes referred to as working from low-resolution to high-resolution) or using ClayTools as a front-end for the Maya digital content pipeline by creating high-detailed models in ClayTools and then using a variety of techniques to derive a low-resolution model for texture mapping (high-res to low-res).

Both workflows involve using ClayTools to generate a model with a high-level of detail which is then baked down to normal maps, bump maps and displacement maps using TextureKiln™.

- **Start with Maya Software**

In this workflow, a new or existing low-poly Maya model is imported into ClayTools where it is transformed into virtual clay and details are added. Then, the ClayTools TextureKiln is used to bake the clay details into texture maps to be applied to the low-poly model for downstream use.

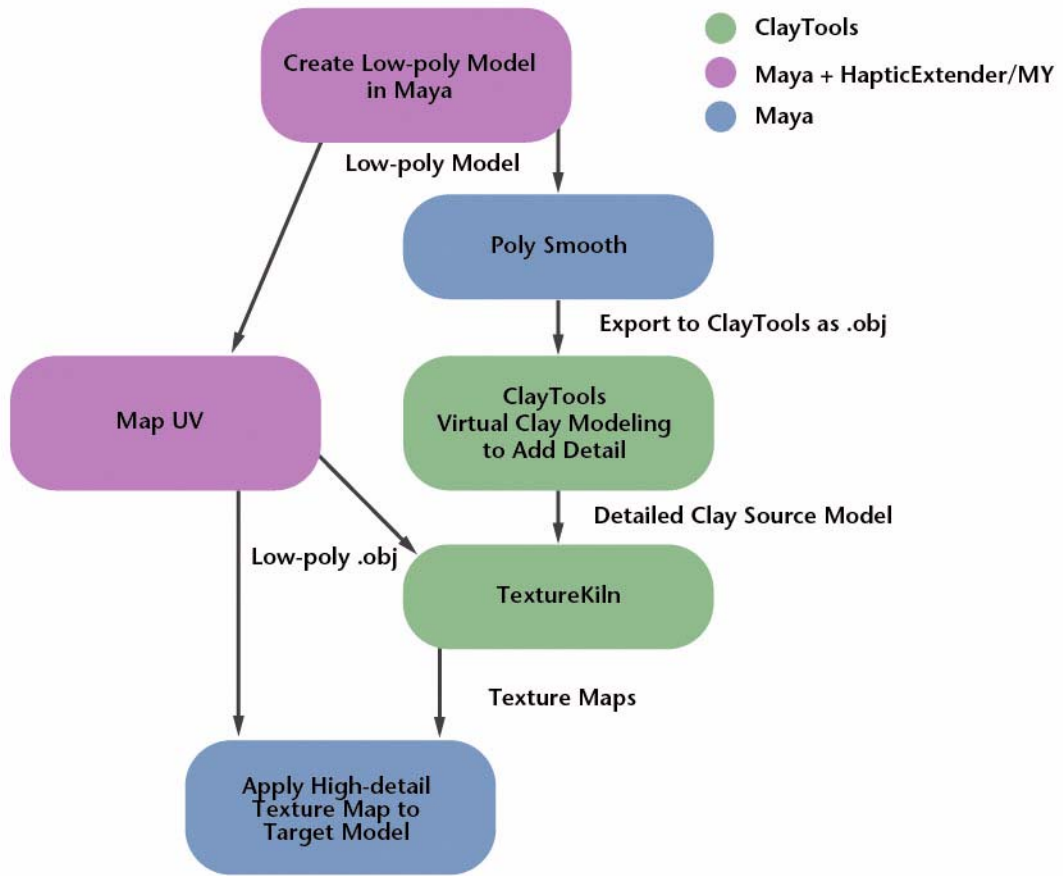


FIGURE 1-1. Low-Resolution to High-Resolution workflow

- **Start with the ClayTools System**

This workflow leverages ClayTools for testing out multiple concepts and rapidly creating a high-detail virtual maquette. Then choose from a variety of methods to derive a low-poly production model. Lastly, the ClayTools TextureKiln is used to bake the clay details into texture maps to be applied to the low-poly model for downstream use.

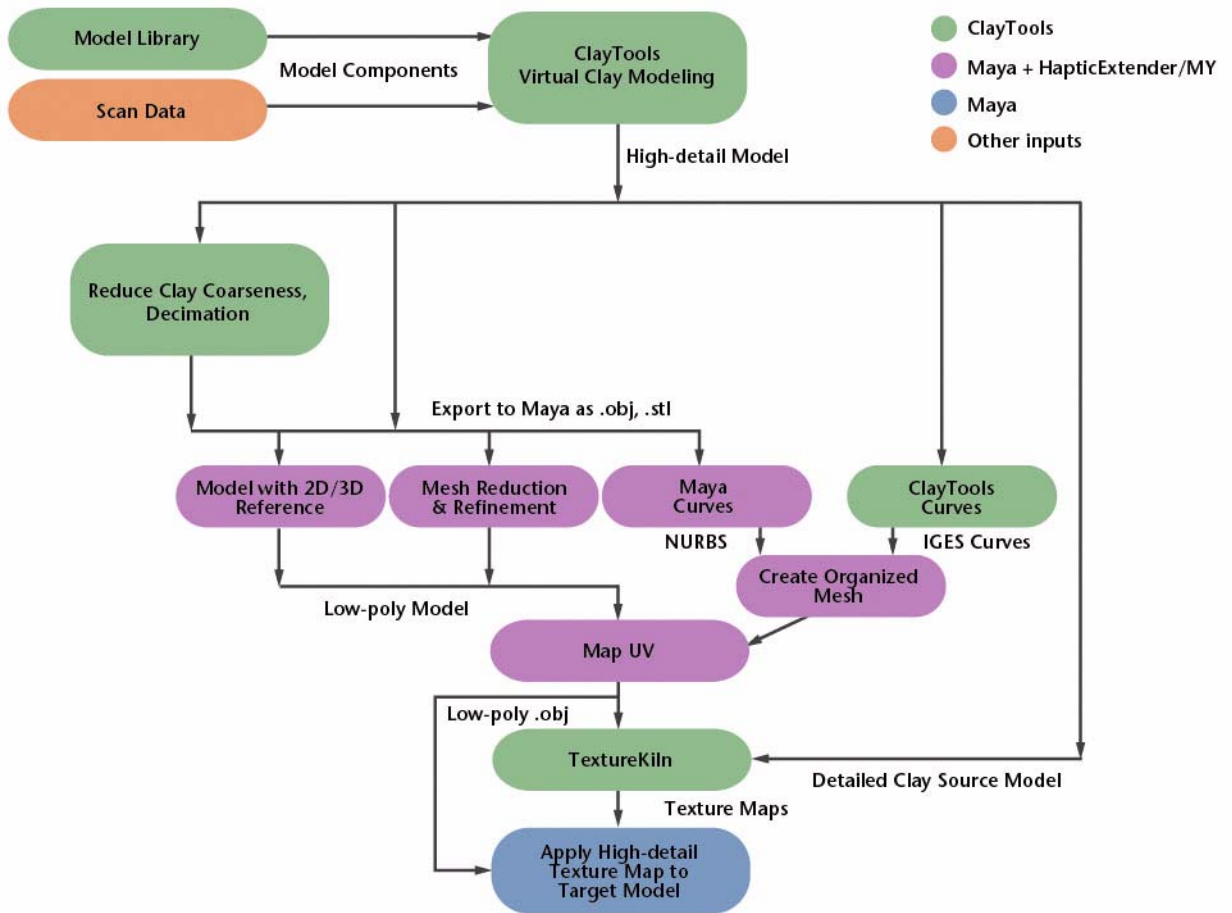


FIGURE 1-2. High-Resolution to Low-Resolution workflow

Maya to ClayTools

Creating A Game Character Model with Maya and ClayTools



This workflow goes through the process of working from Maya to ClayTools to create a game character model with normal maps. Sample files can be found on the product CD if you want to follow along. Note that not every step is explained in detail. This is not intended to be a step-by-step tutorial.

The core principle of this workflow is to create high resolution models from tessellated game models and generate normal maps from them. In this workflow, we will first export a lo-res game model from Maya to ClayTools. Next we will increase the resolution of the geometry in ClayTools. Finally we will generate normal maps using TextureKiln and apply the normal maps to the original game model in Maya.

Part 1: Exporting Objects from Maya and Importing into ClayTools

Step 1: Preparing to export the game model from Maya

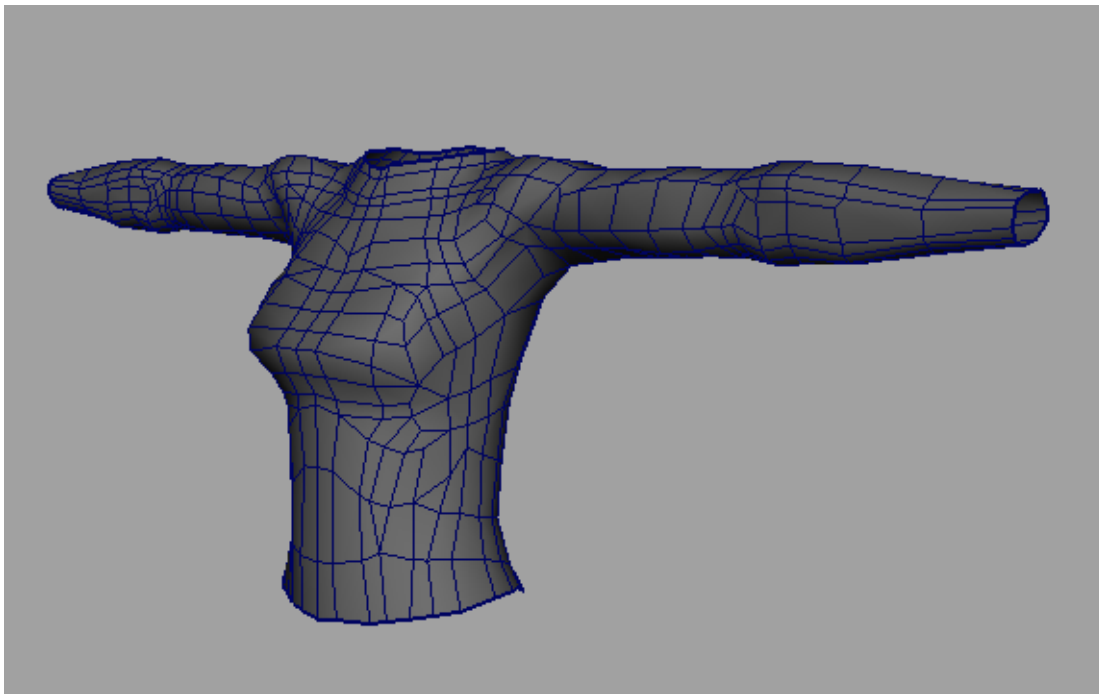


FIGURE 2-3. Model in Maya

World units must be consistent

Both Maya and ClayTools should be set to consistent world units in order to avoid unnecessary rescaling of units. In ClayTools, this option is found under Options. In Maya, this setting is found under the main toolbar heading Windows > Settings/Preferences > Preferences > Settings.

- 1 To follow along, in Maya, open **bodyStart.ma** file, which can be found on the product CD.

Before exporting the polygon geometry to ClayTools, you need to smooth the model using the smooth node in Maya. This is important because ClayTools converts geometry to clay (voxels), so even though you make the resolution of the geometry high, ClayTools will respect the form of the imported geometry and represent it more smoothly.

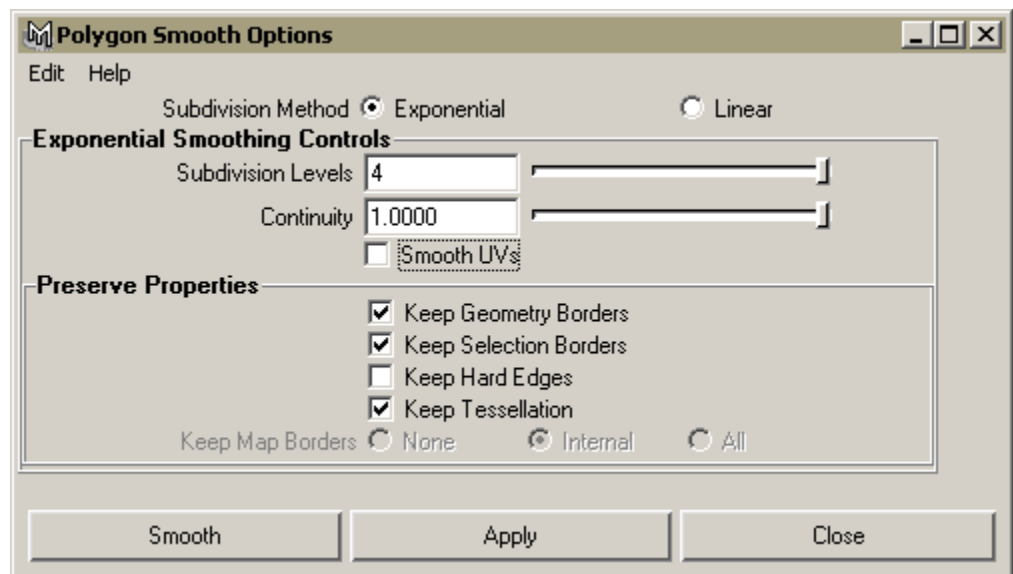


FIGURE 2-4. Maya Polygons Smooth Options dialog

- 2 Select the polygon geometry (bodyGeo) and go to Modeling > Polygons > Smooth Options (Figure 2-4).
- 3 In the Polygon Smooth Options dialog, set following:
 - a Subdivision Method to Exponential
 - b Subdivision Levels to 4
 - c Continuity to 1
 - d Make sure Keep Geometry Borders is checked on as without this option, the geometry will shrink and it will cause problems during the normal map generation process in ClayTools.

- 4 After all the options are set, click Apply.

The geometry with subdivision level 4, may look overly tessellated, but it is important to have a dense poly mesh to get a smooth clay model in ClayTools.

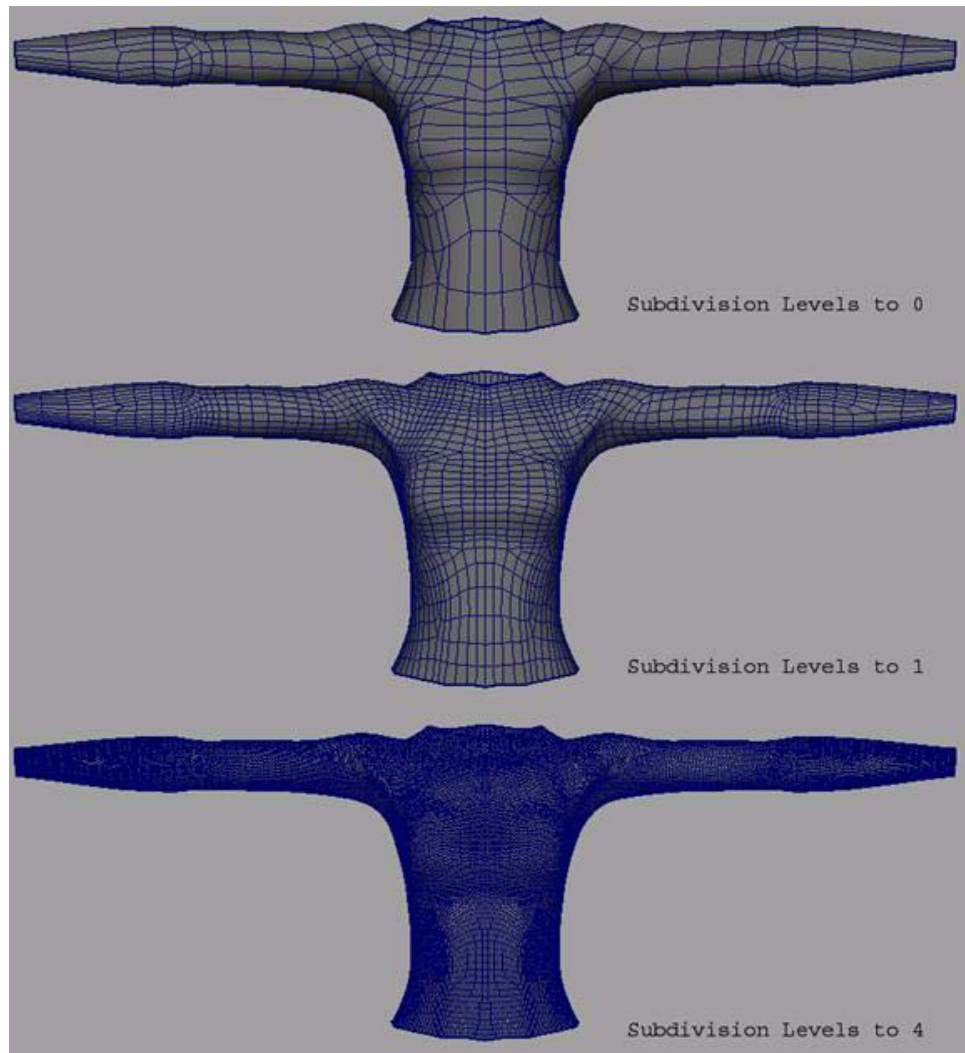


FIGURE 2-5. Geometry shown with various subdivision levels

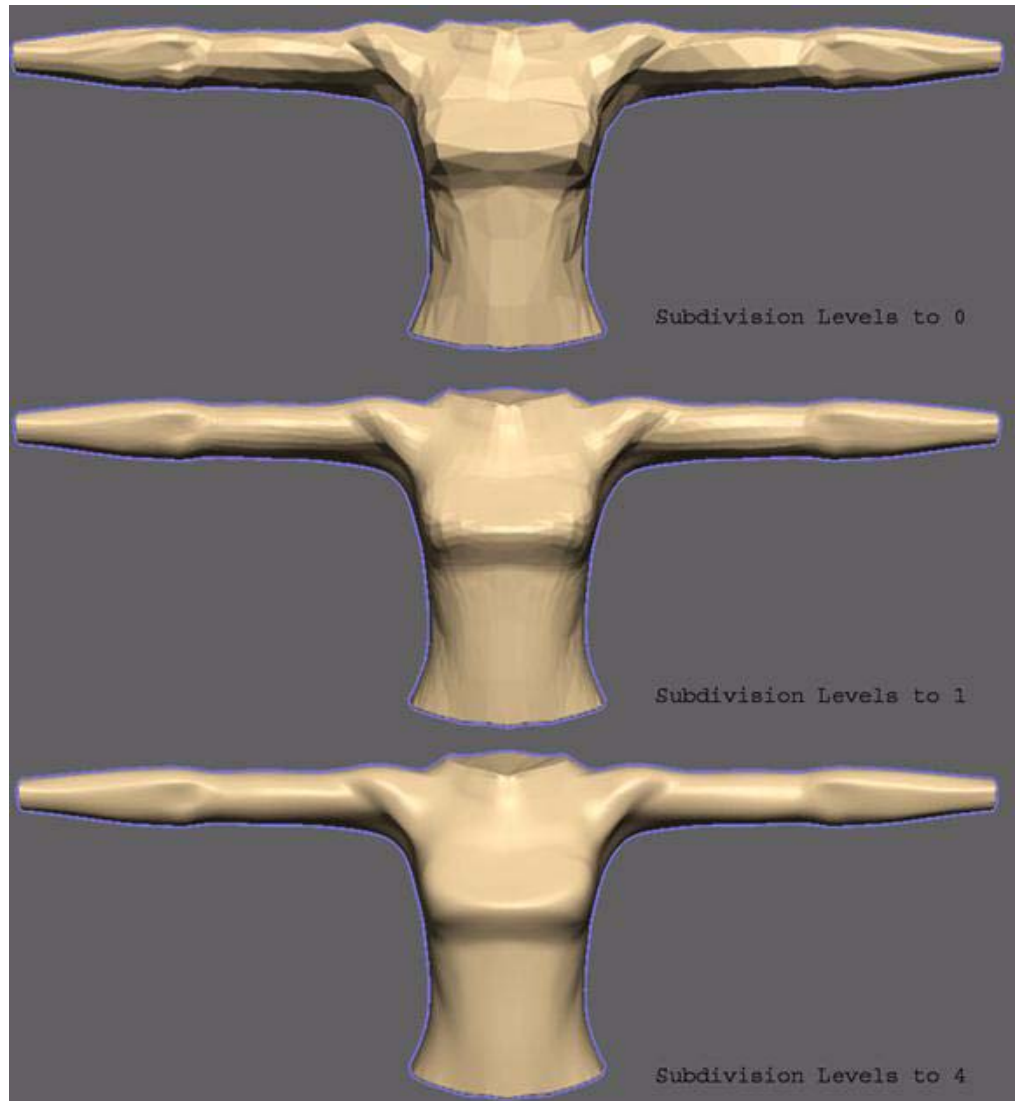


FIGURE 2-6. Clay shown when converted from various subdivision levels

Step2: Exporting the tessellated geometry from Maya

ClayTools supports the Wavefront Object format (.obj). An OBJ exported comes with Maya but it is not loaded by default.

To load the OBJ exporter,

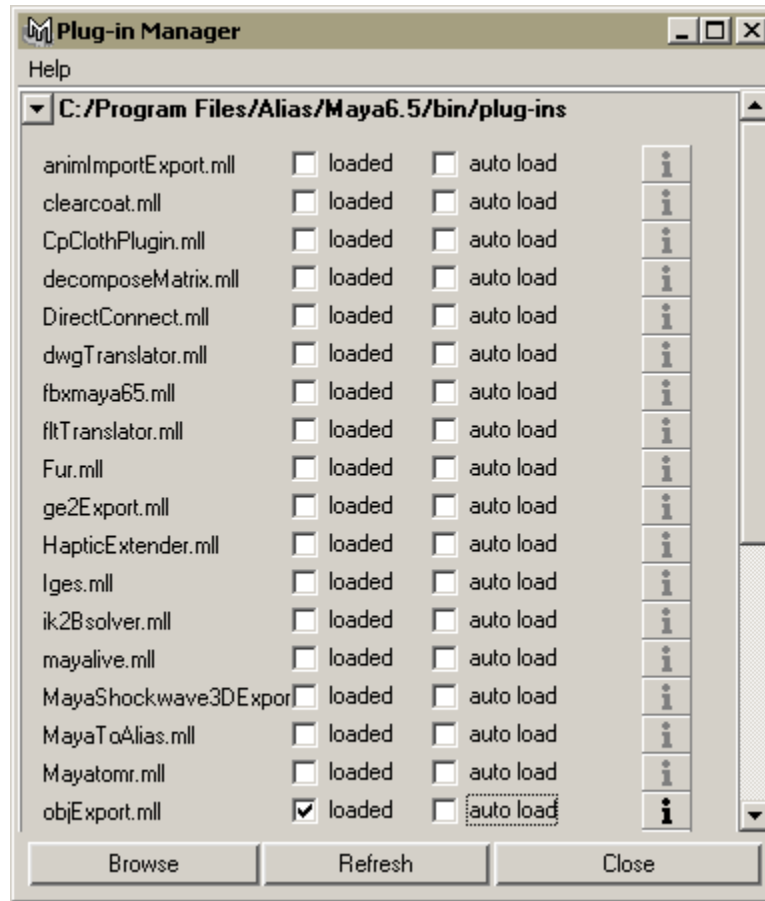


FIGURE 2-7. Maya Plug-in Manager with obj exporter selected.

- 1 Go to Window > Settings/Preferences > Plug-in Manager (Figure 2-7).
- 2 Turn on the loaded check box for objExport.mll and this will load the exporter.

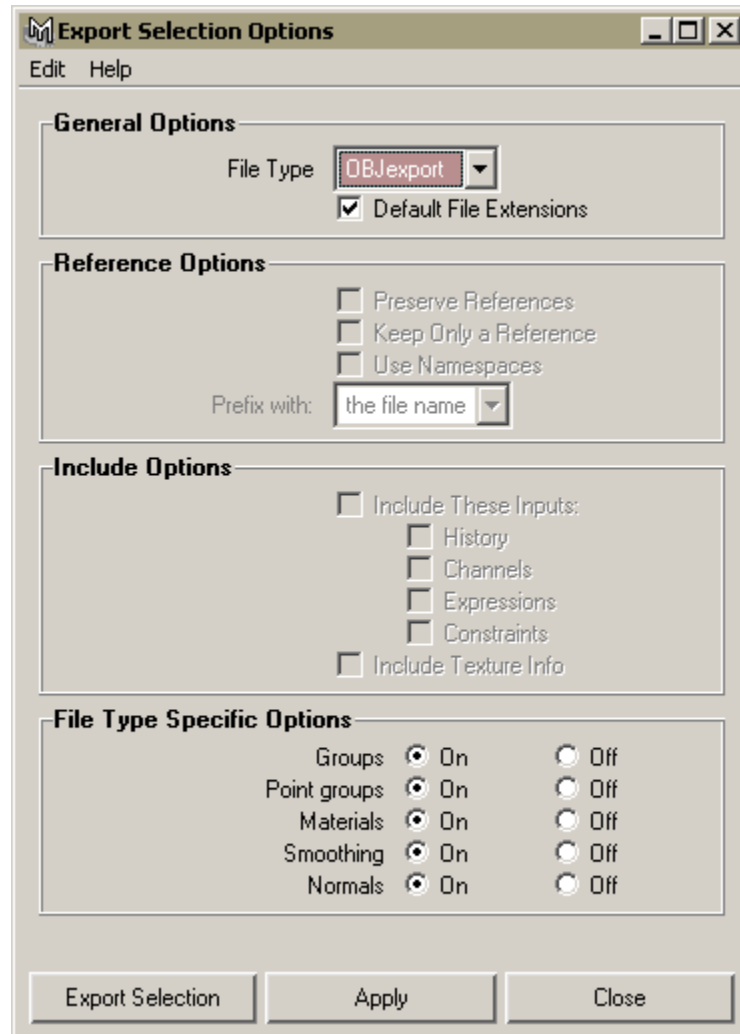


FIGURE 2-8. Maya Export Selections dialog with OBJExport selected and all File Type Specific Options on.

- 3 Select the geometry (bodyGeo) and go to the File > Export Selection Options (Figure 2-8).
- 4 Change the File Type to OBJexport in the General Options and make sure all the file type specific options are turned on.

- 5 Click **Apply** to export. Name the file torso.obj.

Step 3: Importing tessellated geometry to ClayTools

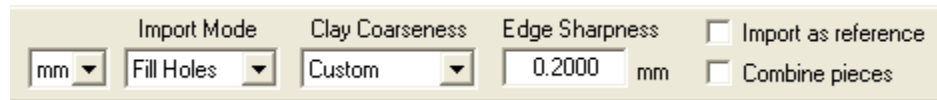


FIGURE 2-9. Import Model dynabar

In ClayTools, select File > Import > Model and load the OBJ file (torso.obj) that you exported from Maya. Before converting polygons to clay, the import model dynabar appears in the bottom of ClayTools window (Figure 2-9) giving you options to set for the import.

- 1 In the Import Model dynabar set the following:
 - a Set Size to mm,
 - b Set Import Mode to Fill Holes
 - c Set Clay Coarseness to Custom
 - d Set Edge Sharpness to 0.2mm.

The clay coarseness used in this example is particular to models of this resolution and is typically used when importing high resolution models. In most cases, you can start with the default “add detail” or “add fine detail” clay coarseness.

- 2 Click Finish and ClayTools will convert the polygonal model to clay.

Tip In ClayTools, do not reposition or scale the piece as the polygons and Clay need to be overlapping to generate normal maps using TextureKiln

Part 2: Modeling High-Resolution Model in ClayTools

Step1: Adding definition to the model

The Attract tool in ClayTools is similar to the Maya sculpt polygon tool.

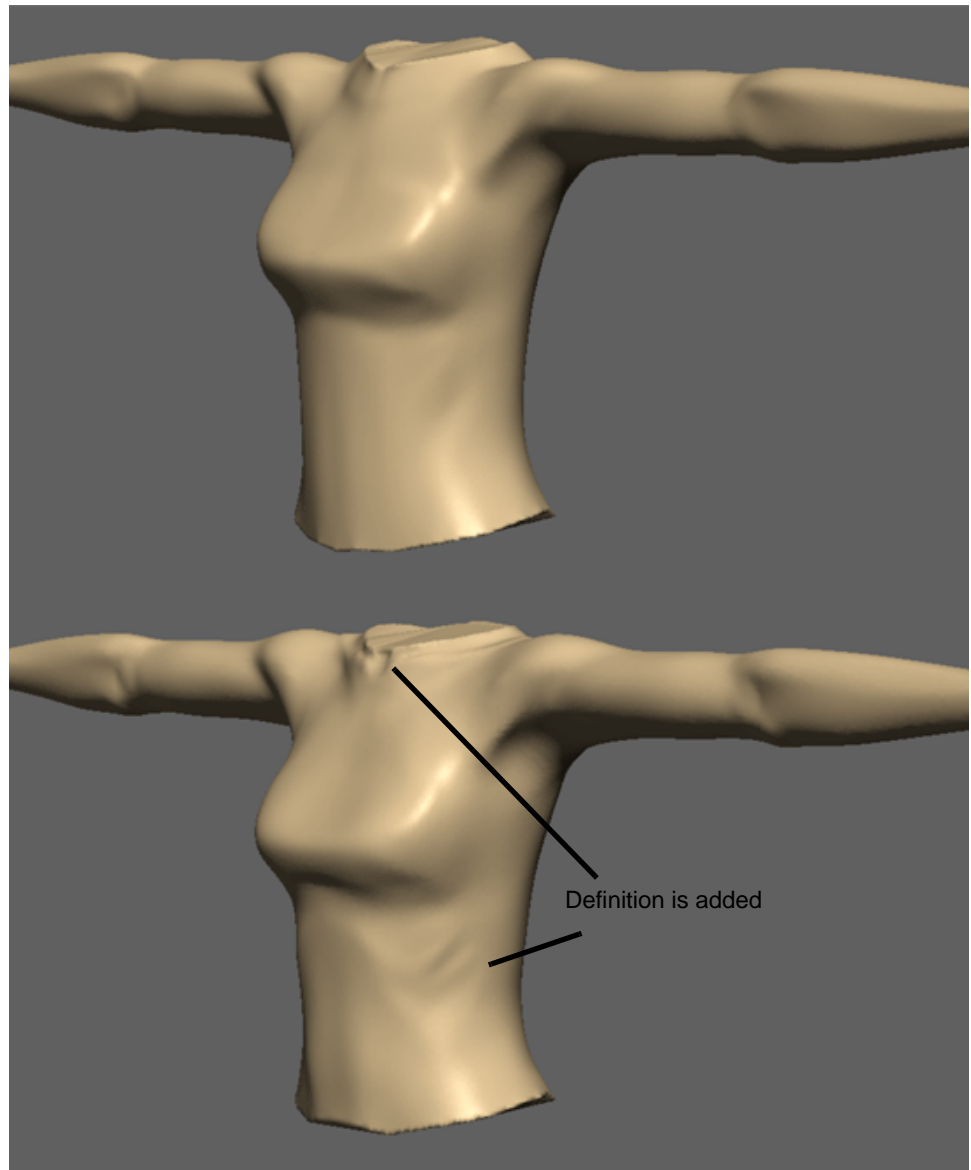


FIGURE 2-10. The model shown on top is as imported. The one on the bottom shows the beginning of some definition that was created using the attract tool

Use the attract tool to add definition to the geometry (Figure 2-10 and Figure 2-11)

The basic processes of adding definition are pushing and pulling using the attract tool and smoothing by using the smooth tool.

Tip Use the Batch Mirror or Interactive Mirror for symmetrical models.

Step 2: Adding details on the clay surface

Before adding details to the clay, you need higher resolution clay to get good results. To change clay coarseness:

- 1 Go to Pieces > Clay Properties > Clay Coarseness. Make Edge Sharpness to 0.1, smooth on and click OK.

You will begin adding details, starting with the chest armor section. You will create this detail by embossing the clay object. The ClayTools emboss tool works with a closed curve on the clay.

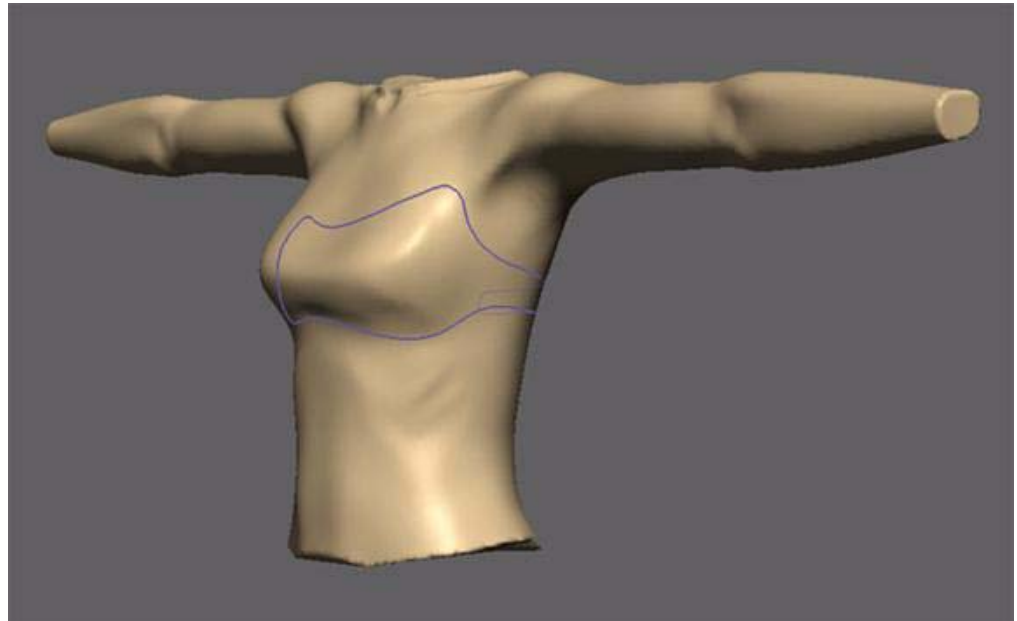


FIGURE 2-12. A curve is drawn to outline the bodice of the chest armor

- 2 Draw a closed curve on surface using the Draw Curve tool that outlines the shape of the bodice. Use Figure 2-12 as a guide. The Draw Curve tool is similar to Maya's curve on surface tool.

Tip Make sure that you are feeling the surface with the Omni device when you are placing the edit points. It is also important to enable the “Fit on Create” option of the Curve tool in the dynabar.

- 3 Go to the Emboss tool and then select the closed curve that you just created.
- 4 Once you select the curve, touch the clay inside the curve loop and pull the clay out.

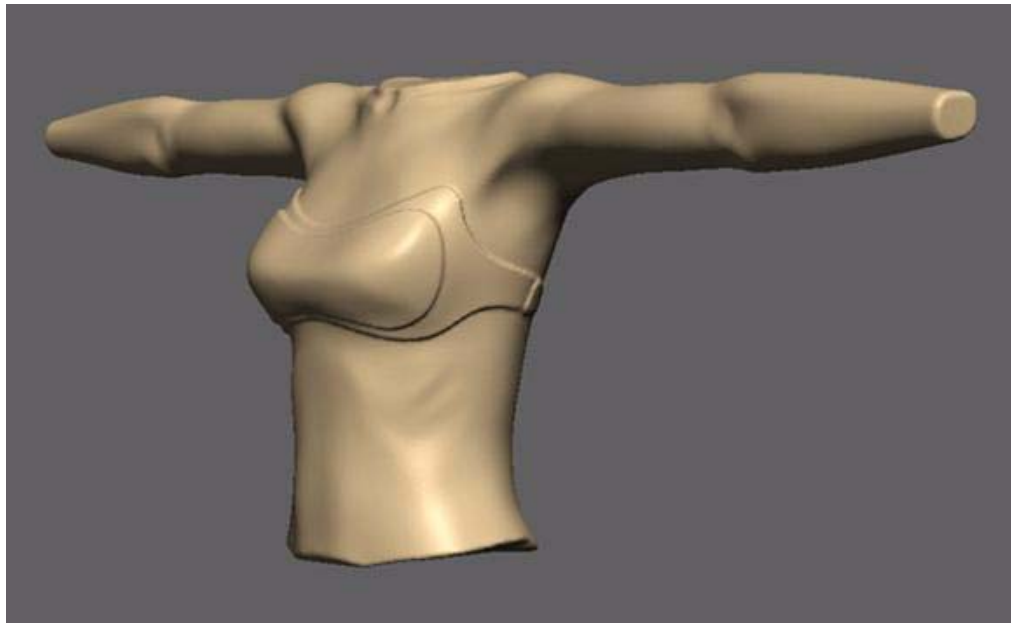


FIGURE 2-13. Emboss is used to create the bodice

The Emboss Area tool allows you to use alpha images to define the emboss area on the clay surface. ClayTools supports bmp, jpg and psd formats for alpha images.

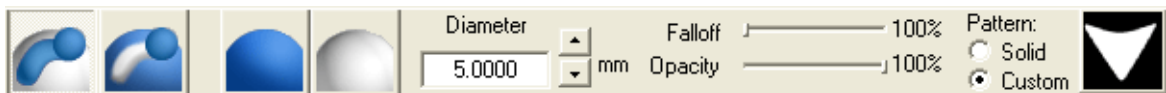


FIGURE 2-14. Emboss options in the dynabar with a custom pattern displayed in the thumbnail

- 5 Go to the Emboss Area dynabar (Figure 2-14) and select the Custom Pattern option.
- 6 Click on the checkerboard image next to the Pattern control to load the custom alpha image.
- 7 Navigate to and open the desired image. The triangleAlpha.bmp is used in this example.

- 8 Reduce the Diameter setting on the Emboss Area Dynabar until the image is approximately the size displayed in Figure 2-17.
- 9 Stamp the triangle alpha image on the clay. Figure 2-17 shows several embosses as well as several stamps in process.

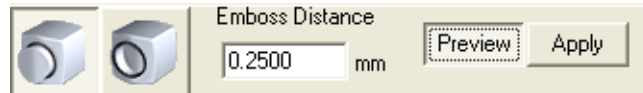


FIGURE 2-16. Raise option is selected in dynabar and Emboss Distance is set to 0.25

- 10 Before embossing the area, set the dynabar option to “Raise” clay and set the Emboss Distance to 0.25 and click Apply (Figure 2-16).

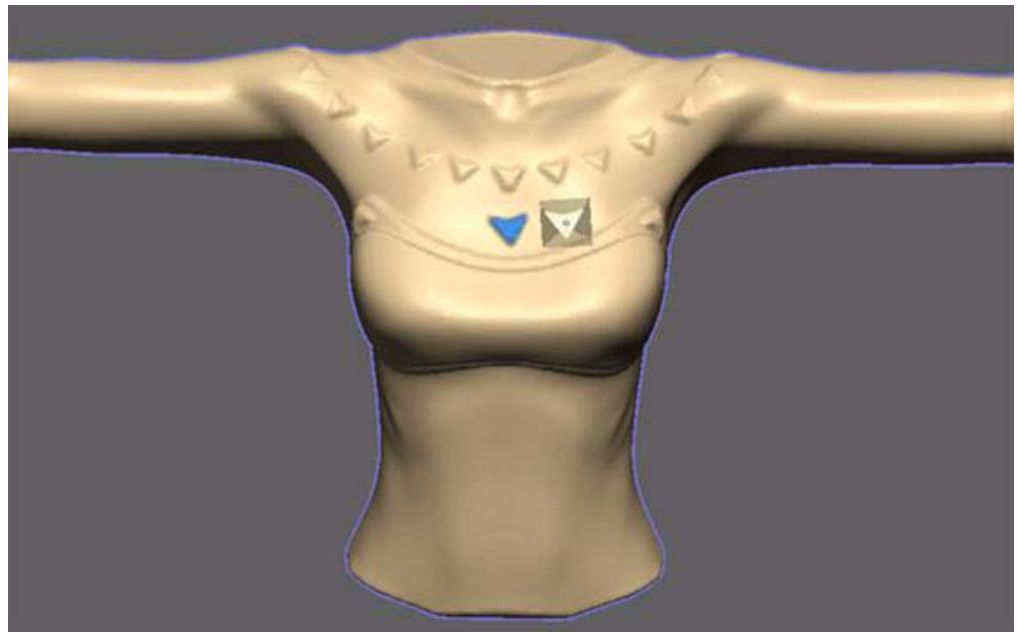


FIGURE 2-17. Upper row of triangles have been embossed. Another row is being stamped.

The Mask tool lets you create a mask on the clay by directly painting on the clay or using alpha images.

Note When you are in the mask mode, only deformation tools work on the masked surface.

- 11 Click on the Mask tool.

- 12 Set your Mask options on the Mask dynabar
 - a Select Custom Pattern (Figure 2-18).

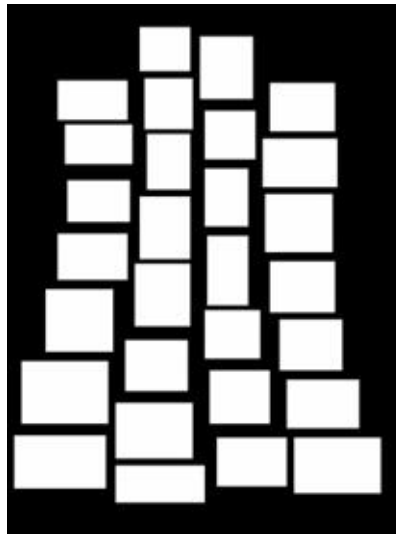


FIGURE 2-19. armorAlpha.bmp

 - b Click on the image next to the Pattern and navigate to desired image, here armorAlpha.bmp (Figure 2-19) in the alpha folder in the project directory.
 - c Set the Falloff to 0%

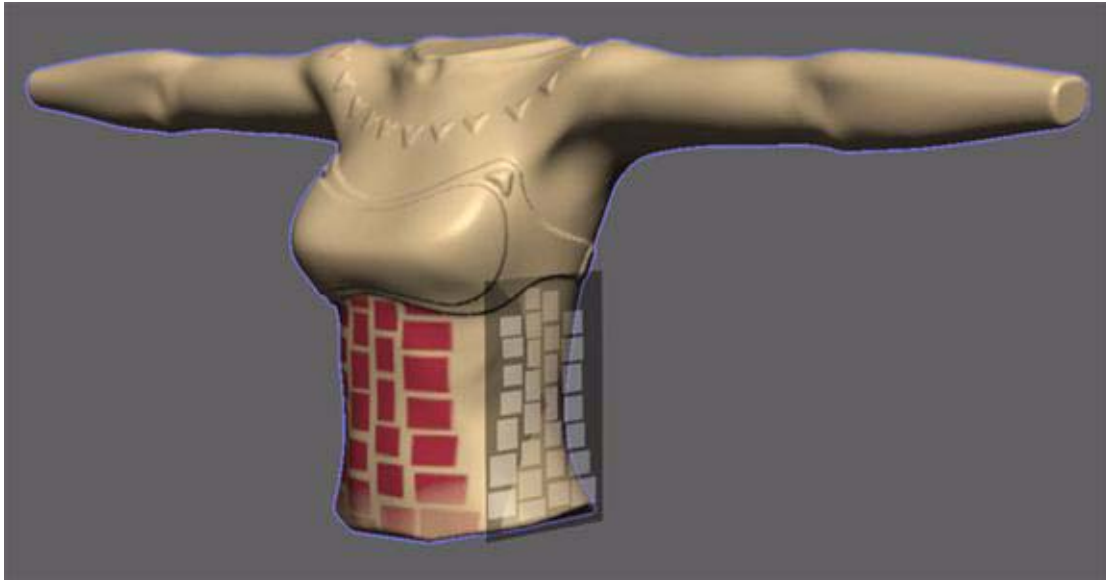


FIGURE 2-20. The armor image is stamped on the clay.

- 13 Paint the armor alpha on the clay (Figure 2-20). Note you must be touching the clay to apply the mask.

The Red color means that the clay is masked so the deformation will not affect that area. However you want the currently painted area to be the unmasked area and the rest to be masked. To do this you need to invert the selection.

- 14 Select Edit > Invert Selection to invert the mask (shortcut is Ctrl+I)
- 15 Select the Tug tool and pull the clay out.
- 16 Click Apply on the dynabar to complete the operation.

The other parts of the character can be created using the same workflow. To add more finer details on the clay, you need higher resolution clay to get finer details. This is managed by changing the Clay Coarseness.

Part 3: Generating Normal Maps

Step 1: Creating UVs in Maya

To generate a normal map, you need UVs define on the polygon model (fig 20)

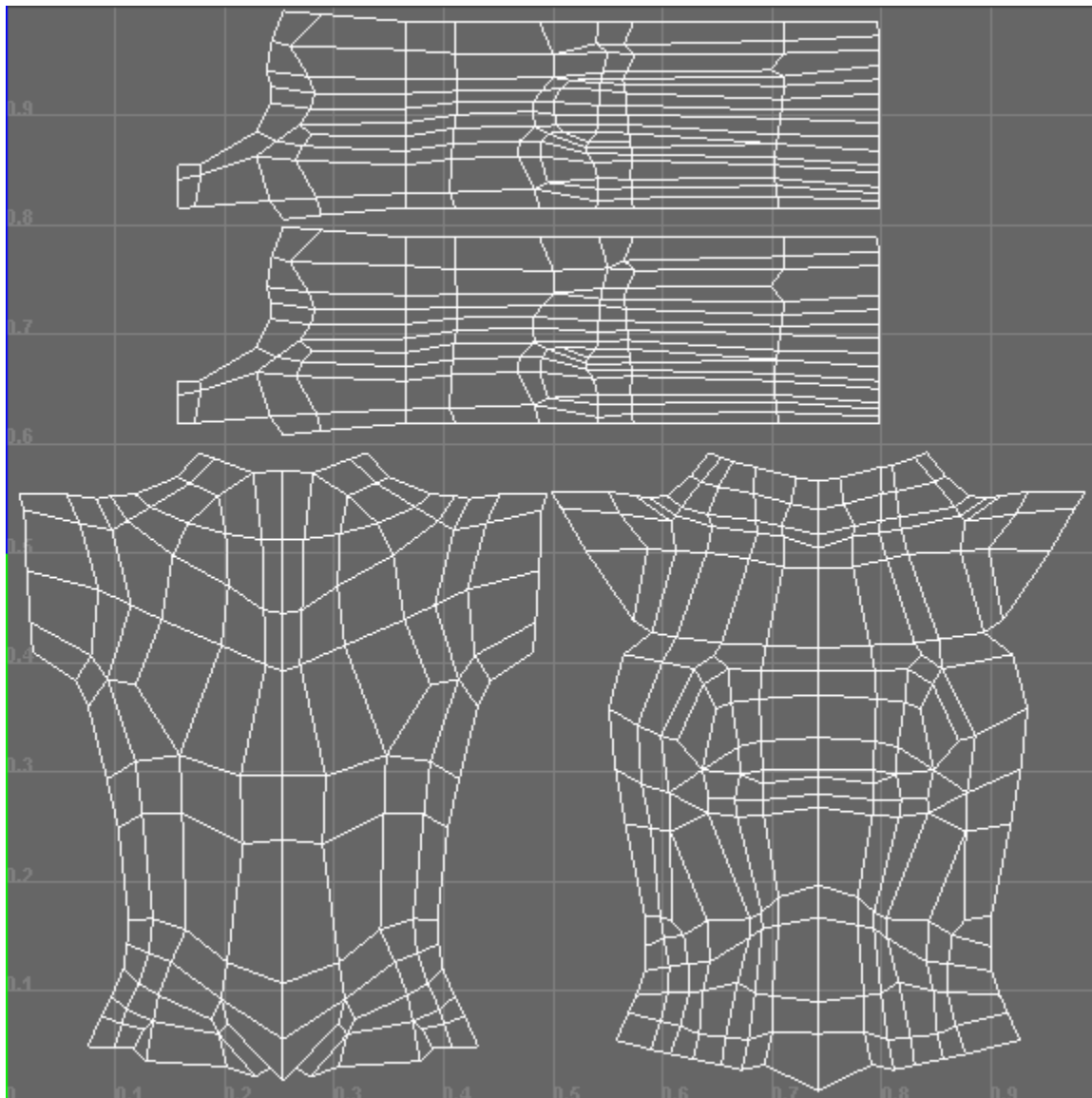


FIGURE 2-21. UVs in Maya

In Maya we open bodyStart.ma, which already has the UVs created on it. For those already familiar with UV mapping, skip ahead to “Step 2: Generating the Normal Map” on page 19

Example: Creating UVs

Though the UVs already exist in the sample model, this section of the tutorial goes through the process of creating those UVs in Maya.

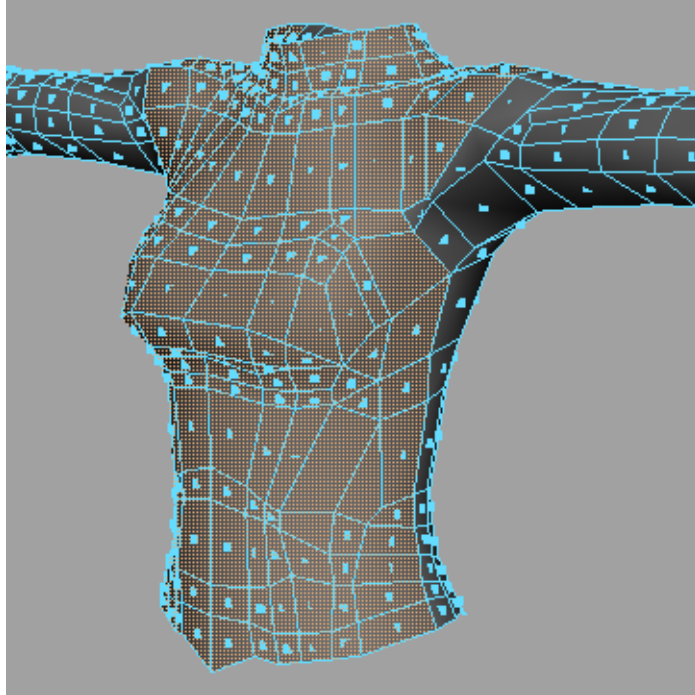


FIGURE 2-22. Front polygon faces are selected

- 1 Select the front polygon faces of bodyGeo (Figure 2-22)

- 2 Select Edit Polygons > Texture > Planar Mapping
- 3 Select Window > UV Texture Editor
- 4 Select the polygon faces in the UV Texture Window then select Polygons > Relax UVs option box.

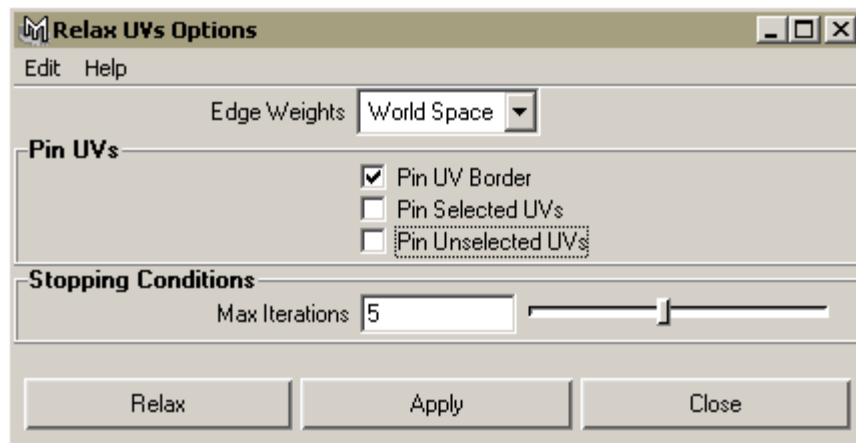


FIGURE 2-23. Relax UV Options dialog

- 5 In the Relax UVs Option box, Figure 2-23,
 - a Set Edge Weights to World Space
 - b Turn on the Pin UV Border check box
 - c Set Max Iterations to 5

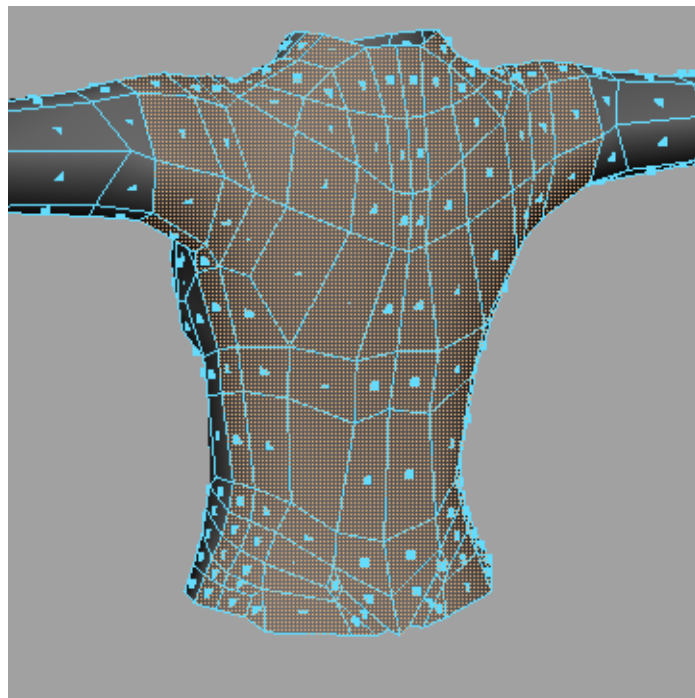


FIGURE 2-24. Back polygon faces are selected

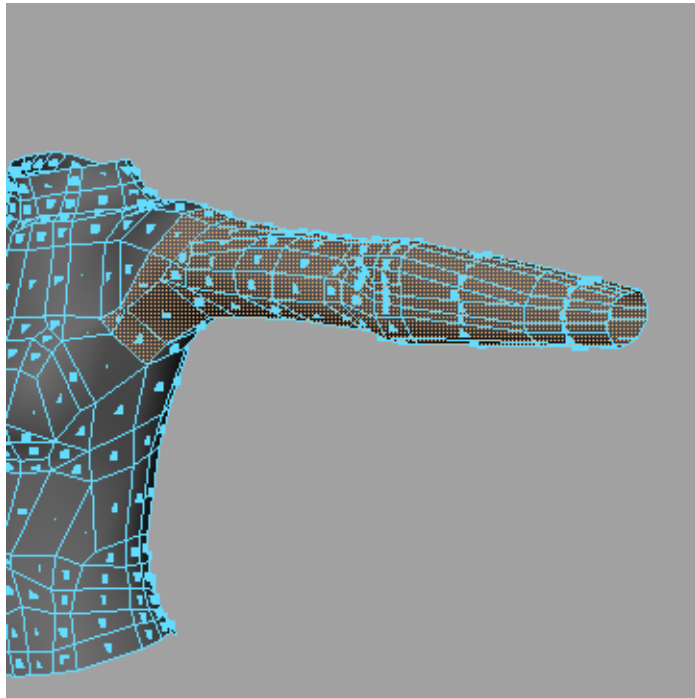


FIGURE 2-25. Polygon faces on the arms are selected

Apply the same process to the back side of the polygon faces and the arms (Figure 2-24, Figure 2-25). As for the arms' UV, use Edit Polygon > Texture > Cylindrical Mapping to start the process.

- 6 Export the model to bodyUV.obj.

Step 2: Generating the Normal Map

In ClayTools, open the clay file you created in Part 2. You can generate normal maps in ClayTools using TextureKiln.

- 1 Go to **File > Export > TextureKiln**.

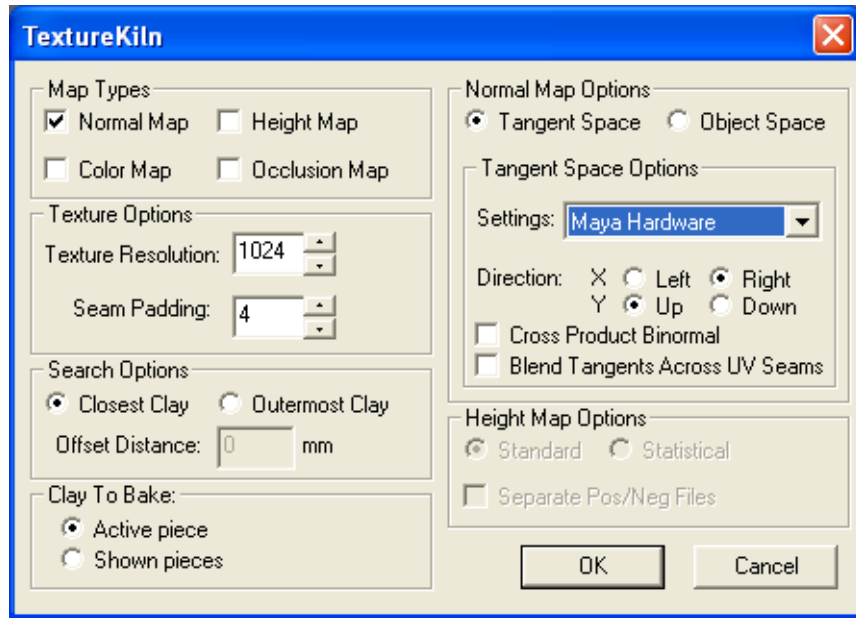


FIGURE 2-26. TextureKiln settings

- 2 In the TextureKiln Options dialog, set the following (see Figure 2-26):
 - a Map types to Normal Map
 - b Normal Map Options to Tangent Space
 - c Tangent space options to Maya Hardware settings

- d Texture resolution to 1024.

- 3 Press the OK button. You will be asked to choose a polymesh file with the UVs. Select the bodyUV.obj file you created previously. When TextureKiln is done creating the normal map you will be asked to save the file.

Part 4: Applying the Normal Map and Previewing Normal Map in Maya

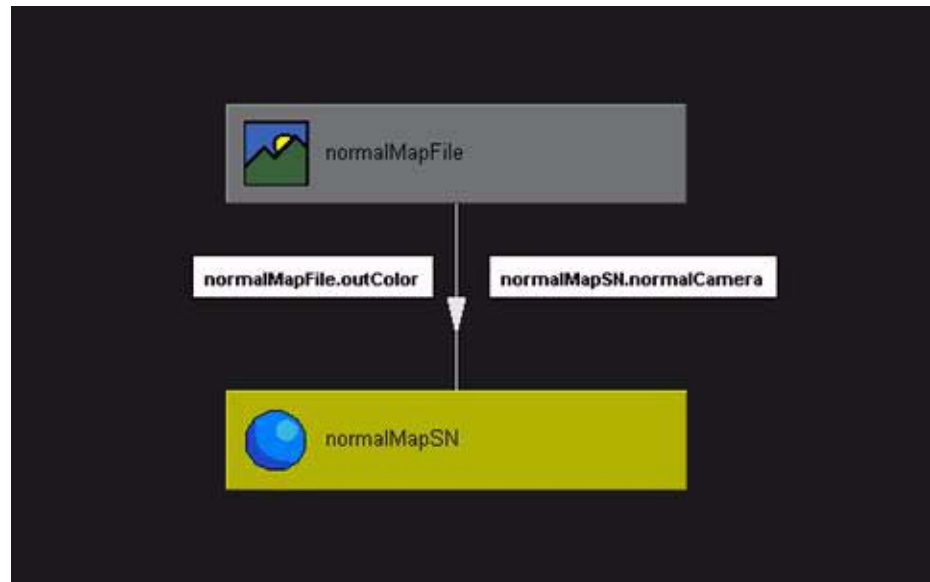


FIGURE 2-27. Node connection of normal map

In order to view the normal map on the model in Maya's viewer, you need to create a custom normal map shader. To create the shader, connect the outColor attribute of the normal map image file to the shader's normalCamera attribute (see Figure 2-27).

By using the createNormalMapShader script, you can automate this process.

- 1 Load the bodyStart.ma file.
- 2 Go to Window > General Editors > Script Editor.
- 3 Go to File > Source Script and open createNormalMapShader.mel from the scripts folder in the project directory.

- 4 Once the script is sourced, type `createNormalMapShader` and hit enter on the numerical keypad. The command will generate the normal map shader.

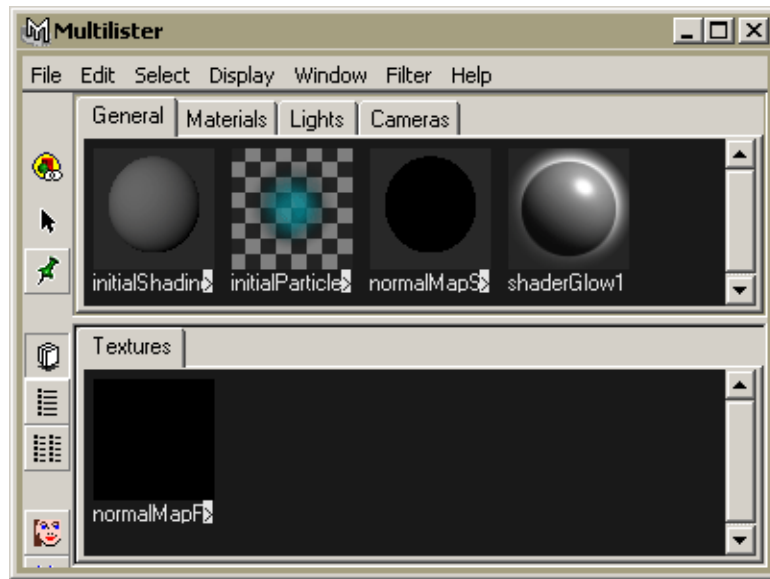


FIGURE 2-28. New normal map shader shown in HyperShade

- 5 Display the attribute editor for the `normalMapFile` node. This can be done in the HyperGraph. Select `Rendering > Show Textures` then right-click on the `normalMapFile` node and select `normalMapFile...` to display the attribute editor.
- 6 In the attribute editor, select the `normalMapFile` tab. Click on the folder icon next to "Image Name". Select the file you created with `TextureKiln`.
- 7 Open HyperShade. Drag and drop the `normalMapSN` material onto the body.

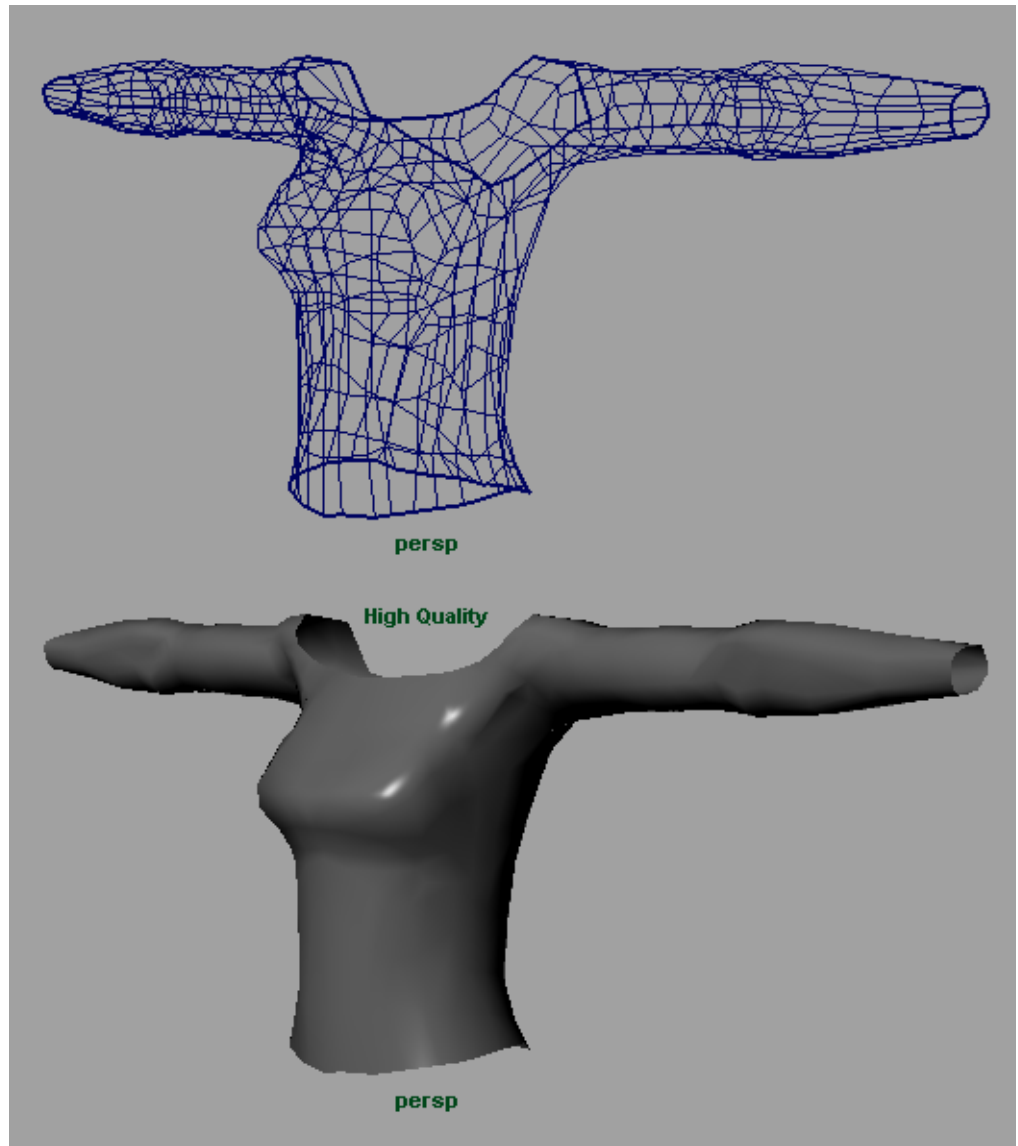


FIGURE 2-29. Torso displayed as wireframe and with smooth shading.

- 8 Go to the Shading menu on the viewer window and turn on High Quality Rendering, Smooth Shade All and Hardware Texturing to see the normal map result (Figure 2-29).

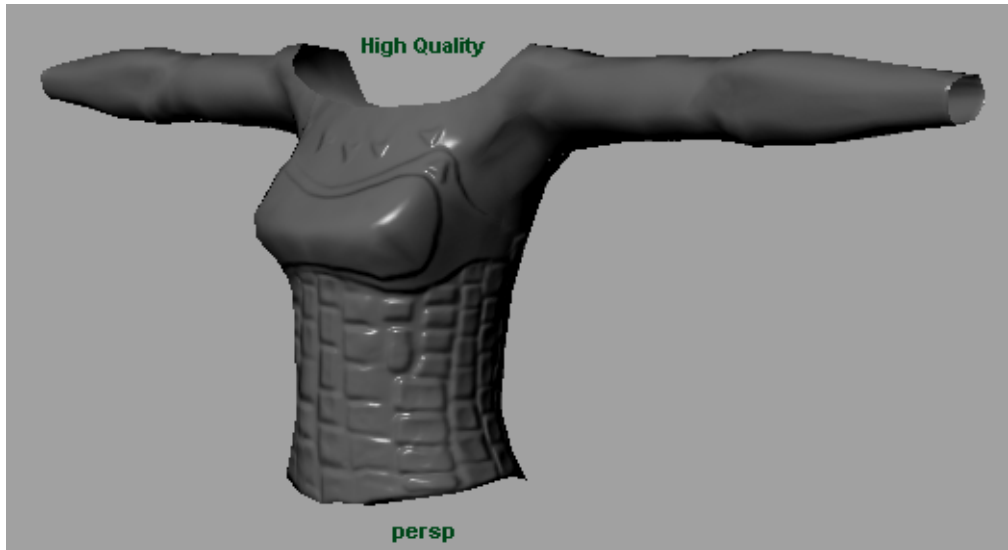


FIGURE 2-30. Torso display with normal map.

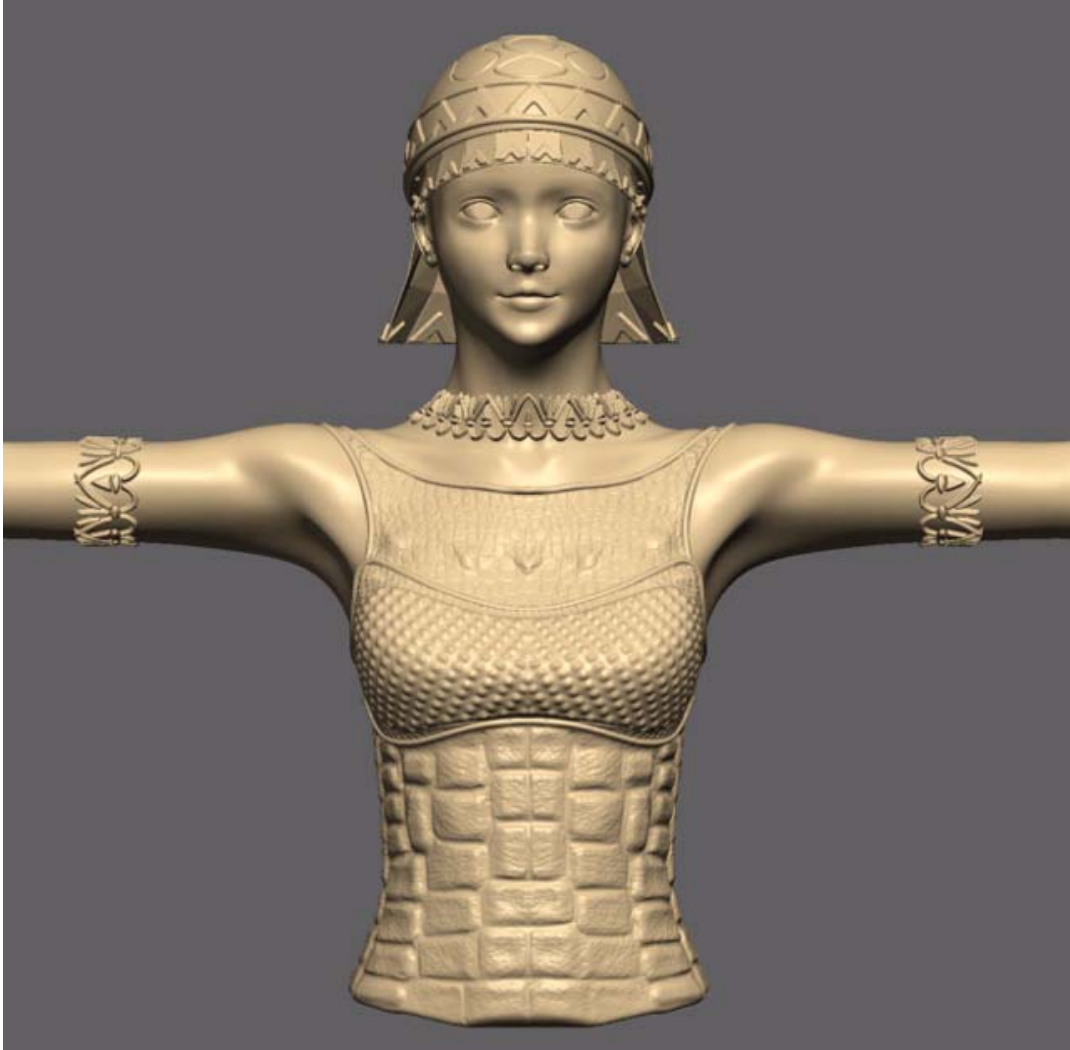


FIGURE 2-31. Armor has been detailed using various tools and additional pieces of the model have been created using the same workflow.

Maya to ClayTools

Adding Detail to a Maya Model



This chapter describes the workflow process of working from Maya to ClayTools to develop a low polygon, normal mapped object.

The core principle of this workflow is the notion of extracting high-detail surface information and “baking” it into a map that's applied to low-res geometry. This process is called normal mapping.

This workflow is advanced in nature because it demonstrates round-trip modeling of a low-resolution model and a high-resolution counterpart. We will start in Maya with a model of a low-resolution demon polymesh. We will then export a Poly Smoothed version of the demon and import it as virtual clay in ClayTools. ClayTools will be leveraged for adding detail to the demon model, such as musculature, veins, bumps, horns, spikes, teeth, tongue, and skin details. We'll then export a downsampled version of the demon to be used

as a 3D reference in Maya for further refinement of the low-resolution demon model. This refined UV mapped model will become the low-resolution target for a normal map and the ClayTools model will be the detailed source. The completion of the workflow will show using the TextureKiln to bake a normal map from the densely detailed virtual clay, which will then be applied in Maya to the low-resolution demon model.

Part 1: Exporting Maya Models and Importing into ClayTools for Detailing

Step 1: Preparing to export the low-res model

We will begin with a low-res polymesh demon model for which we want to create a detailed counterpart.

1 Load the 01startInMaya.mb file.

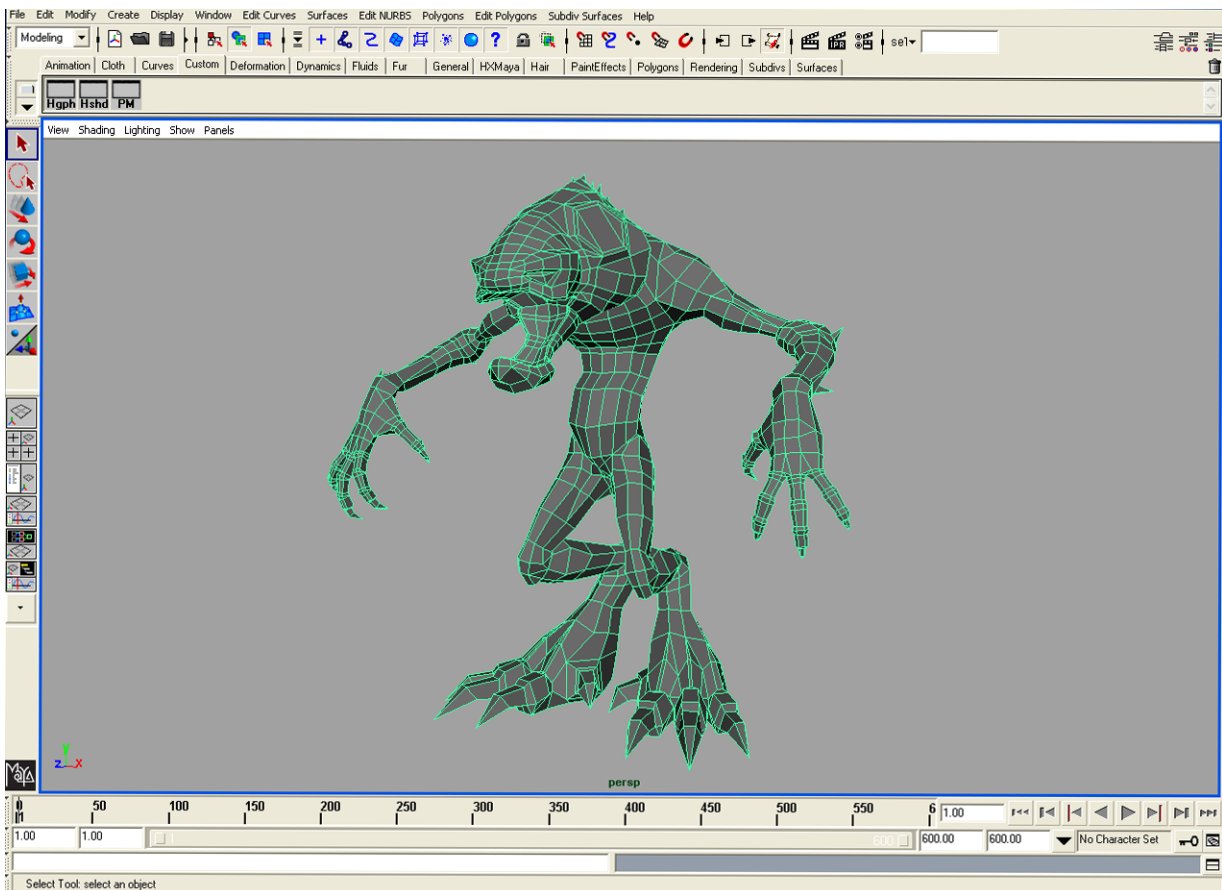


FIGURE 3-1. The low resolution demon model

2 Make a copy of the demon mesh directly on top of the existing demon mesh.

For organic detail modeling, it is recommended to smooth out any faceting that will not be desired in the high detail model. The smoothed result will provide a better starting place when the mesh is converted to clay in ClayTools.

3 Perform a Polygons > Smooth operation. Note this may take some time.

A good rule is to increase the number of subdivision levels or number of smooth operations until you no longer have discernible facets. Use the facet viewport display to judge your iterative step results. From a short distance, the mesh should appear smooth. Here we have increased the number of subdivision levels to 3.

3 ADDING DETAIL TO A MAYA MODEL

Part 1: Exporting Maya Models and Importing into ClayTools for Detailing

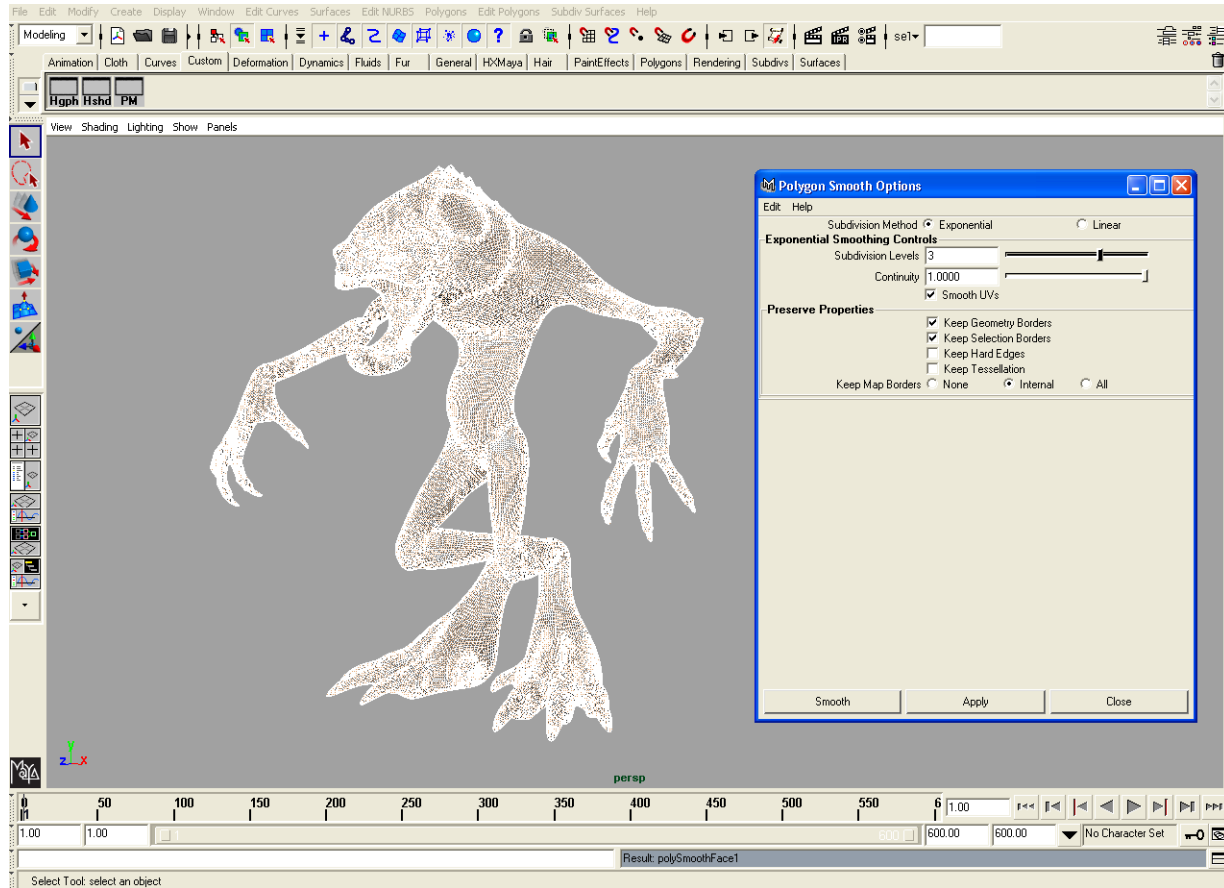


FIGURE 3-2. Polygon smoothing applied to model to provide a smooth surface for detailing.

It is recommended to preview the model in flat shading mode within Maya to ensure that visible faceting has been eliminated. Upon export the smoothed mesh should be deleted from Maya.

World units must be consistent

Both Maya and ClayTools should be set to consistent world units in order to avoid unnecessary rescaling of units. In ClayTools, this option is found under Options. In Maya, this setting is found under the main toolbar heading, Windows > Settings/Preferences > Preferences > Settings. In this particular workflow it is preferable to use centimeters, as this is the native unit of measure in Maya. Not adhering to this may cause data to be scaled incorrectly due to unit conversion methods used by the OBJ import/export in Maya.

Step 2: Exporting the low-res model from Maya

After prepping the model, the next step is to export the model as a dense polygonal mesh. ClayTools supports Stereo lithography (.stl), both binary and ascii, as well as Wavefront Object (.obj). For this workflow we will export as obj.

- In Maya select File > Export or Export Selected and select Wavefront (obj) as the file format. Upon export, the OBJ Exporter popup dialog will appear.

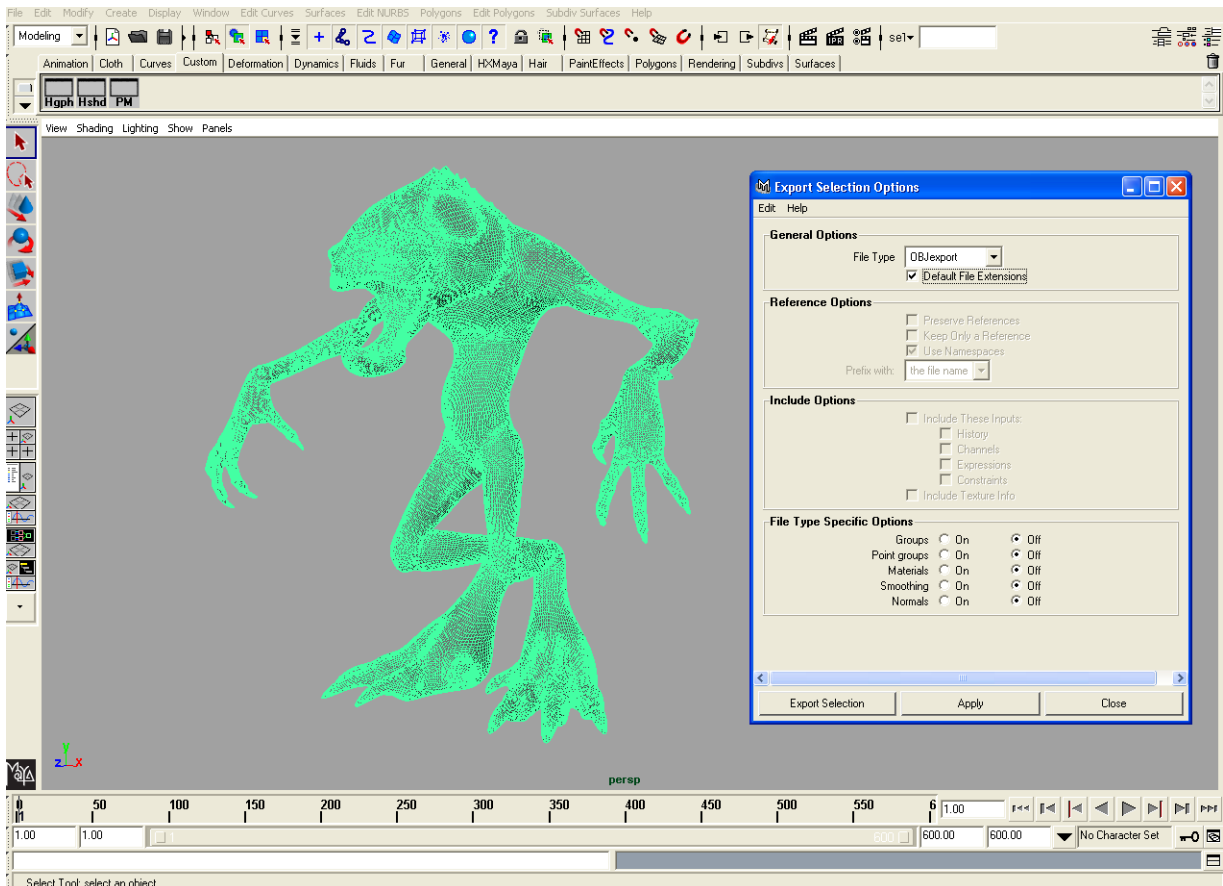


FIGURE 3-3. Export as OBJ format. Note that though the file type specific options are turned off in the above image, it is of no consequence in this example.

Step 3: Importing the low-res model to ClayTools.

The next step is to import the model into ClayTools. This can be done using File > Import > Model. The following images walk you through the process.

What if you lose detail upon import?

If you lose detail when importing a model into ClayTools, you can try importing it again at a finer level of clay coarseness. Typically, Add Detail or Add Fine Detail levels will be a sufficient starting place when detailing a model. The finer the clay coarseness, the more detail you will capture at the cost of higher memory usage and lower performance. Clay coarseness of a ClayTools model is similar in that way to the pixel resolution of a bitmap image. You can set the clay coarseness on the Import dynabar during the import file process

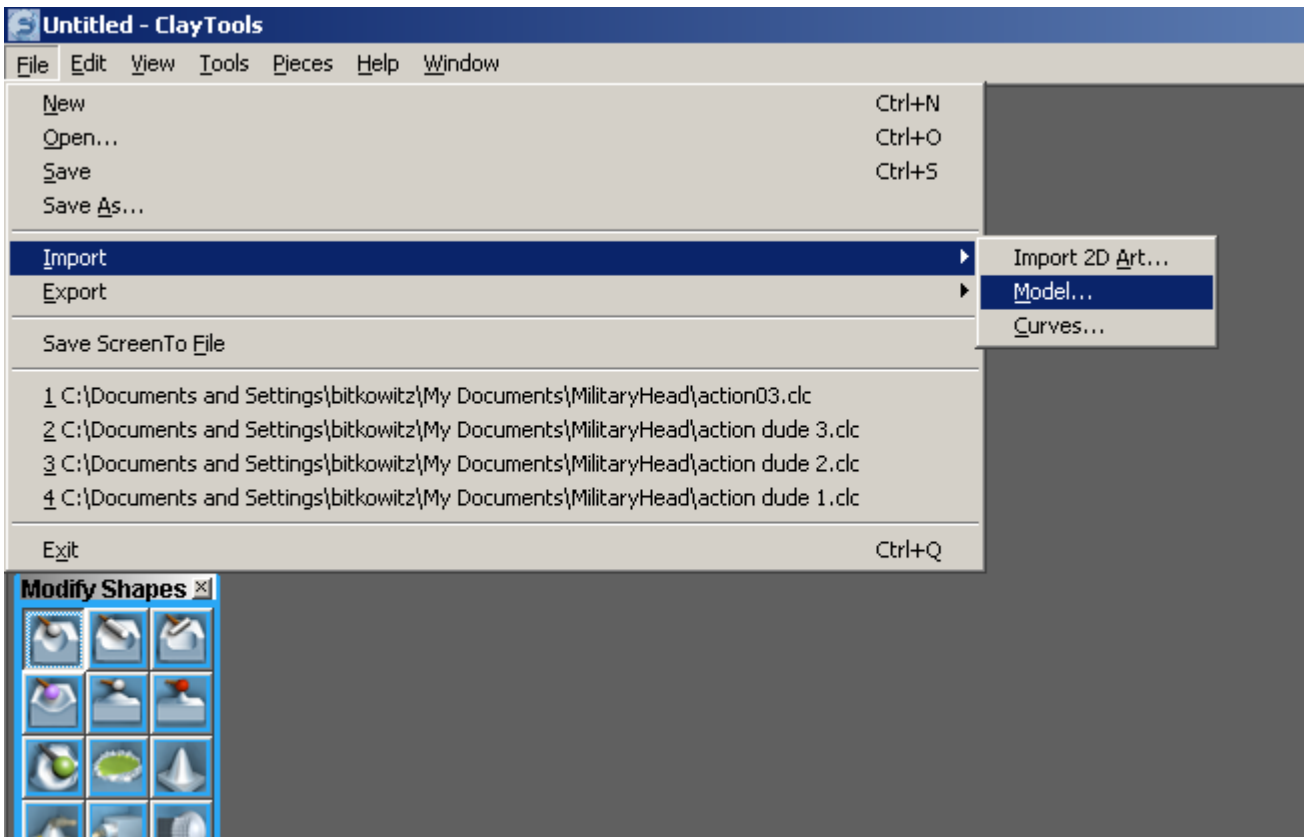


FIGURE 3-4. ClayTools File > Import > Model

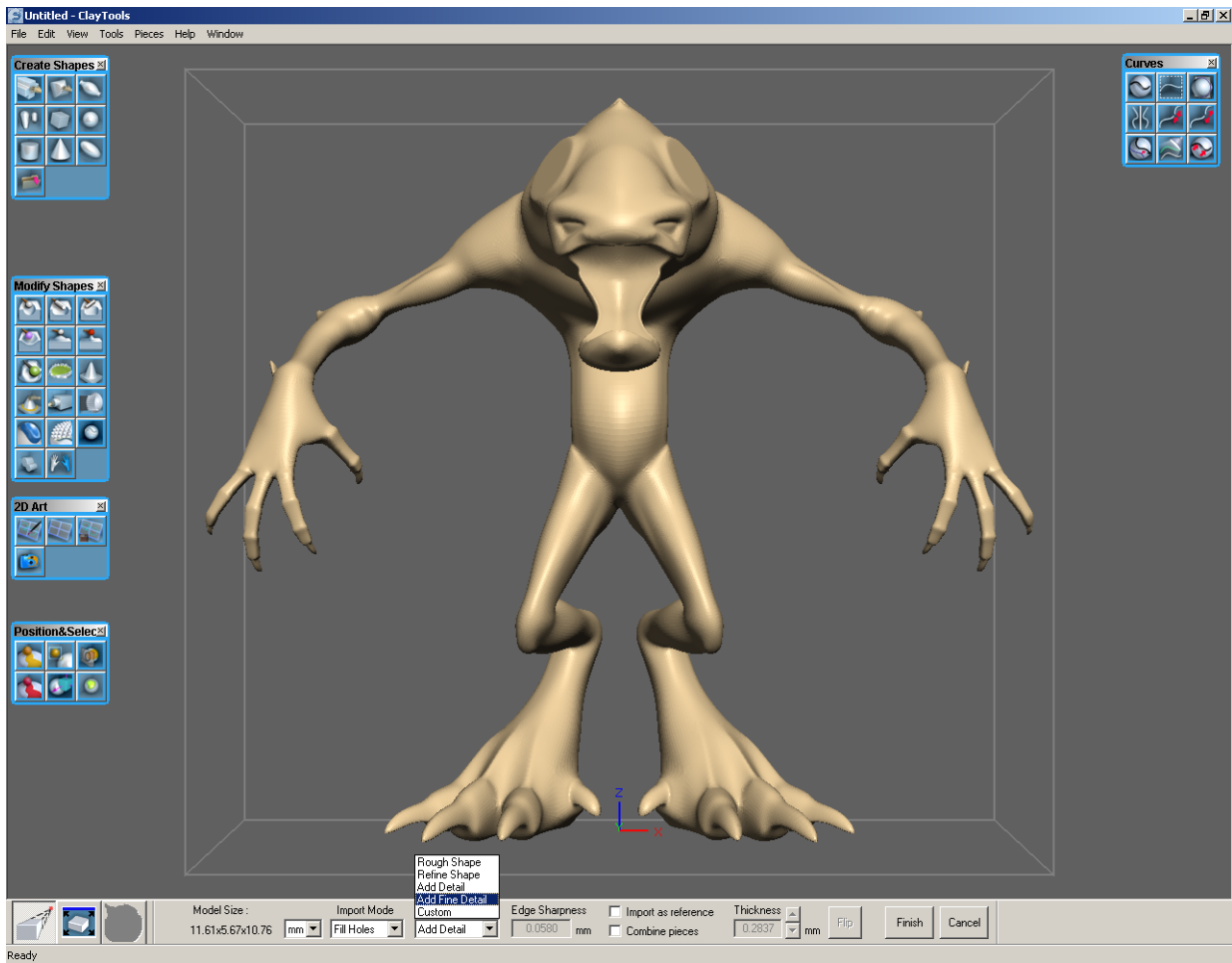


FIGURE 3-5. Import File Info is set in the dynabar.

The Edge Sharpness is set to .01mm. This means that each square millimeter of virtual clay is the size of the grid of voxels that are .01mm in size. It is the size of the smallest surface feature.

About Voxels

A voxel, an abbreviation of “volume element”, can be thought of as a three-dimensional pixel. It is a unit of volume that can be represented numerically by its specific position in x, y, and z coordinates.

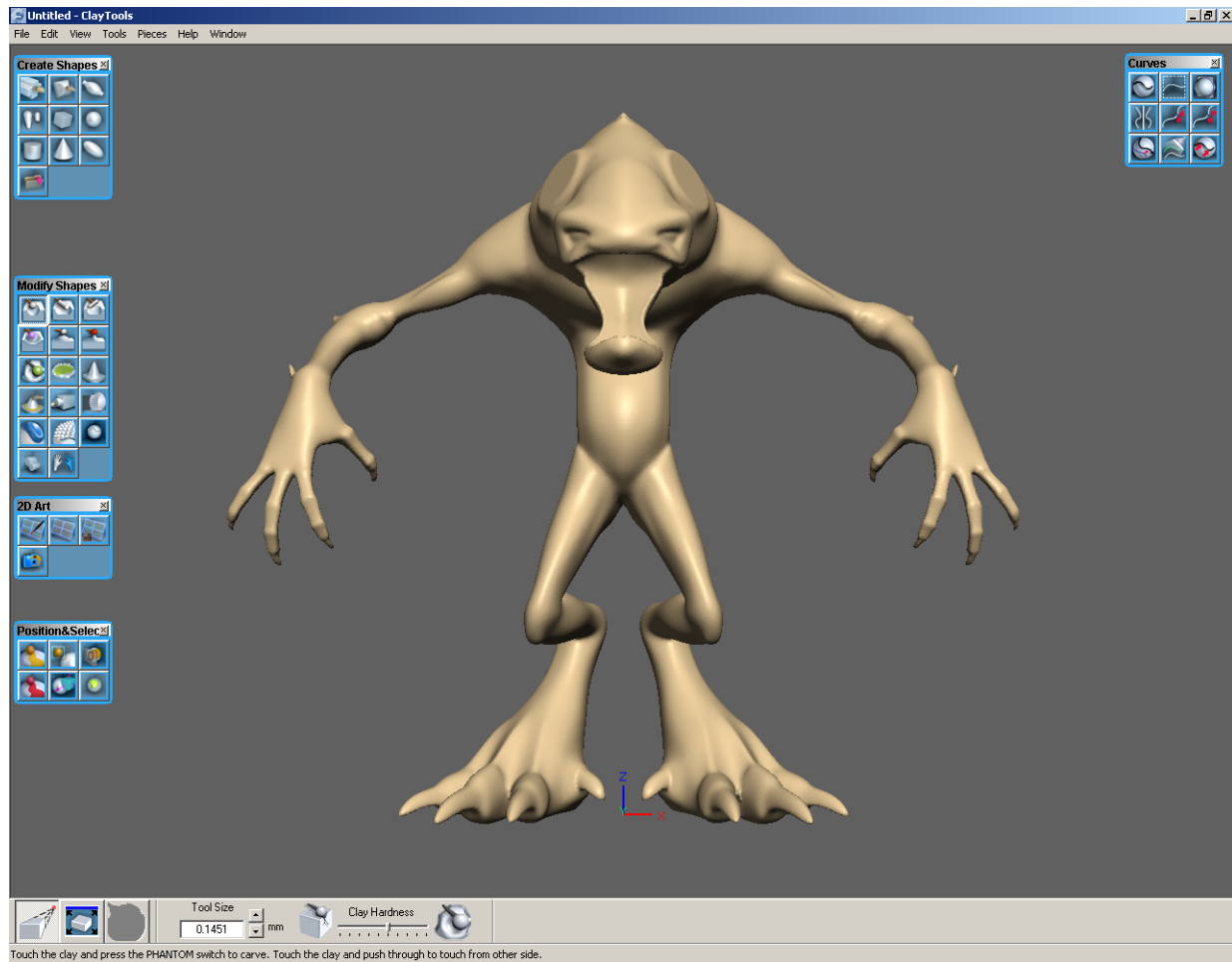


FIGURE 3-6. The initial demon model imported into ClayTools and converted to virtual clay.

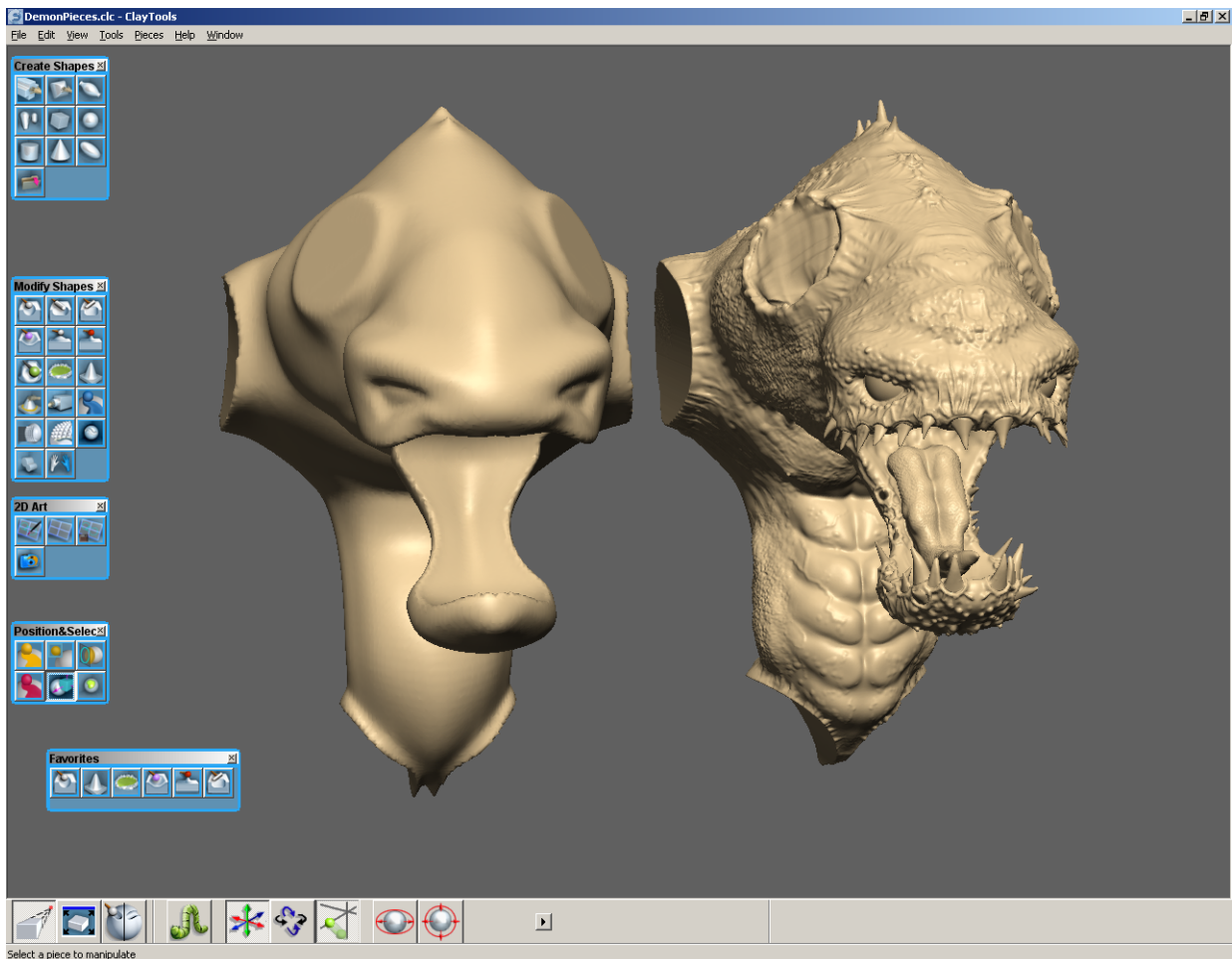


FIGURE 3-7. An array of torsos in successive stages of detail.

Here, the detailing process is presented with two torsos in successive stages of detail. The voxel density is amazing; capturing the most minute details.

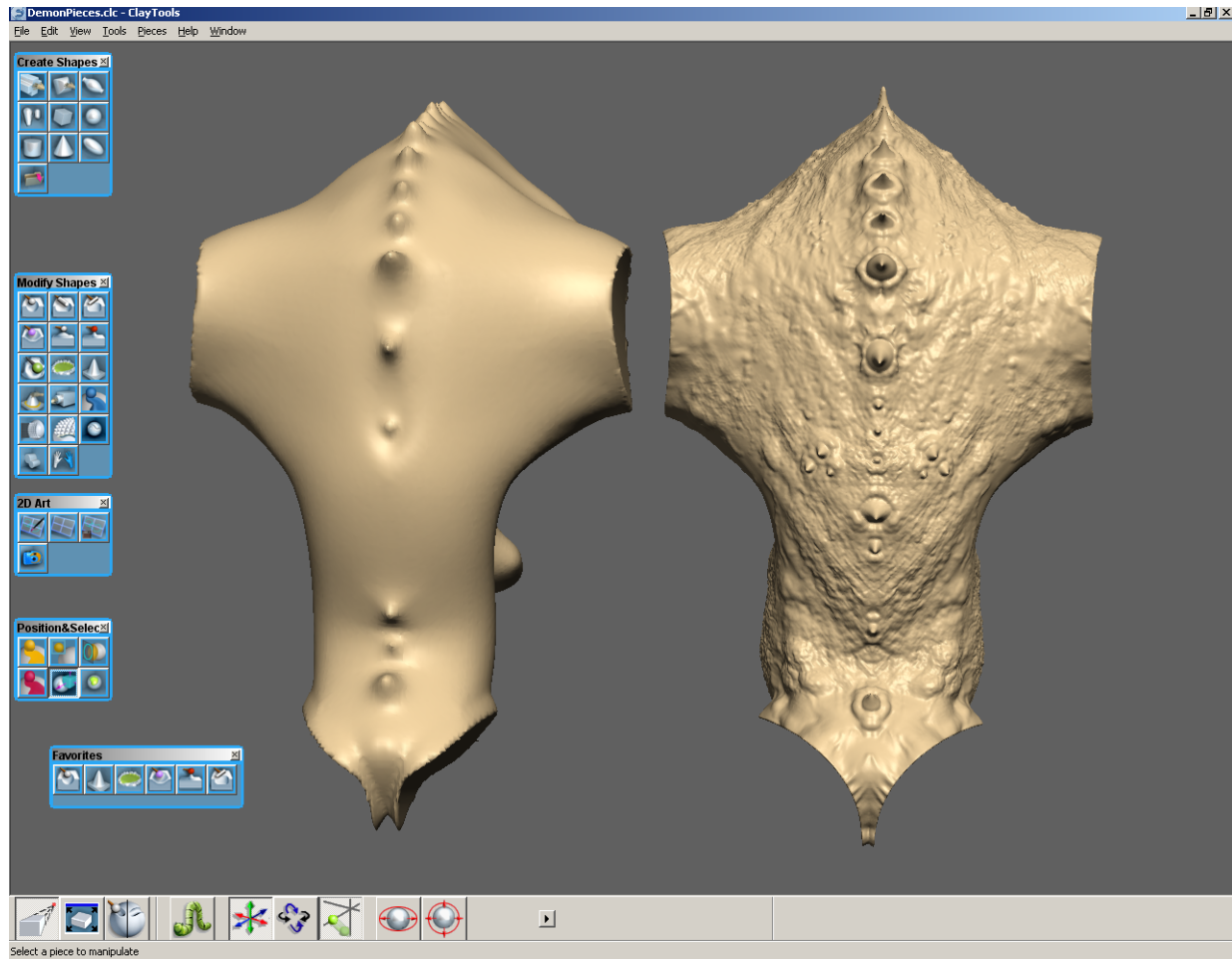


FIGURE 3-8. The same torsos shown from the back view.

ClayTools can be exercised in a variety of ways to produce musculature, skin details, veins, teeth, horns, etc.

Detailing Tips and Tricks:

Coarse to Fine: Details should be added in a progressively coarse to fine nature. Stage the process to define primary details first, like musculature. Work in as much of that gross form as possible before stepping up to a higher resolution. Change the clay coarseness in custom increments for defining smaller features. Skin details can be embossed into the clay at a very fine clay resolution.

Working with pieces: It is recommended to utilize multiple pieces when detailing this model in order to improve performance and interactivity at high resolution. Splitting a model up can be achieved quite easily by defining a clay selection and then cut / paste to new piece. Alternatively, the “Separate with Curve” feature can be used to split the model into parts based on curves drawn around the arms and legs.

It is best practice to introduce a small amount of overlap between pieces when separating them so that they can be recombined later without producing a visible seam. This can be accomplished by copying a selection to a new piece and then deleting a slightly smaller selection from the original piece.

Pieces can be managed through the ObjectList from the View menu. Once a piece is detailed, it can readily be recombined with other pieces by clicking on the piece in the ObjectList and choosing “Combine Into”.

Mirror: Since this model will be symmetrical, it is recommended to only detail one arm and one leg. The detailed demon can be mirrored at the end using the Mirror command to produce a symmetrical result.



FIGURE 3-9. The model has been detailed up beautifully, realistically, and the results are extremely tactile, to say the least.

Part 3: Refine the Model and Assign UV Maps in Maya

As you can see in the final detailed model, some new structural features were added which did not exist in the original low-resolution mesh model, such as the horns, teeth, tongue, and some other protrusions. In order to get the most convincing normal mapped result, we will need to ensure that the low-resolution mesh closely approximates the most visible silhouette features.

For the purpose of refining the low-resolution mesh, we will export a downsampled version of the final demon model. Since we are working with virtual clay, it's fast to choose a different resolution for the volume and generate a coarse approximation which can be used as a 3D reference inside Maya.

As a first step, take note of the current number of triangles in the model if you were to export it. Go to File > Export > Model.

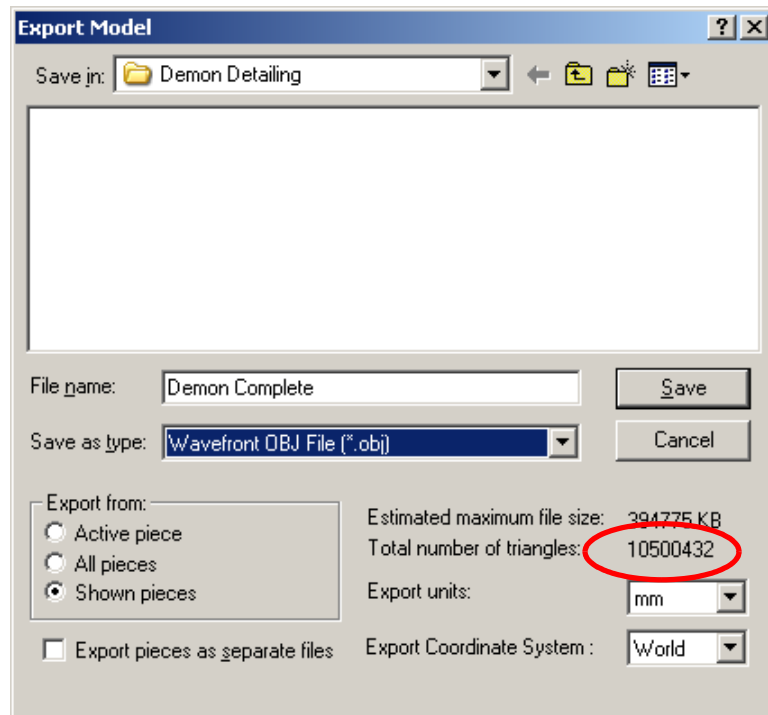


FIGURE 3-10. Location of triangle polygon count information.

Note that the total number of triangles is in excess of 10 million! This is too large and densely detailed to serve as a usable reference for refining the low-resolution mesh. It is preferable to instead export a medium resolution reference, which represents the most important silhouette features.

There are several ways to reduce the ClayTools model to process a more efficient reference.

Change Clay Coarseness

The first option to try is to change the clay coarseness. Try reducing the model resolution in steps and ensure that the model integrity is maintained. Typically, reducing the clay coarseness to “add detail” coarseness will be sufficient and result in a model within the range that Maya can handle.

Backup Your File Before Reducing Clay coarseness

Because of the inherent risk of losing detail when reducing clay coarseness, it is advisable to make a backup copy of your original, high-res, model before proceeding with reducing clay coarseness.

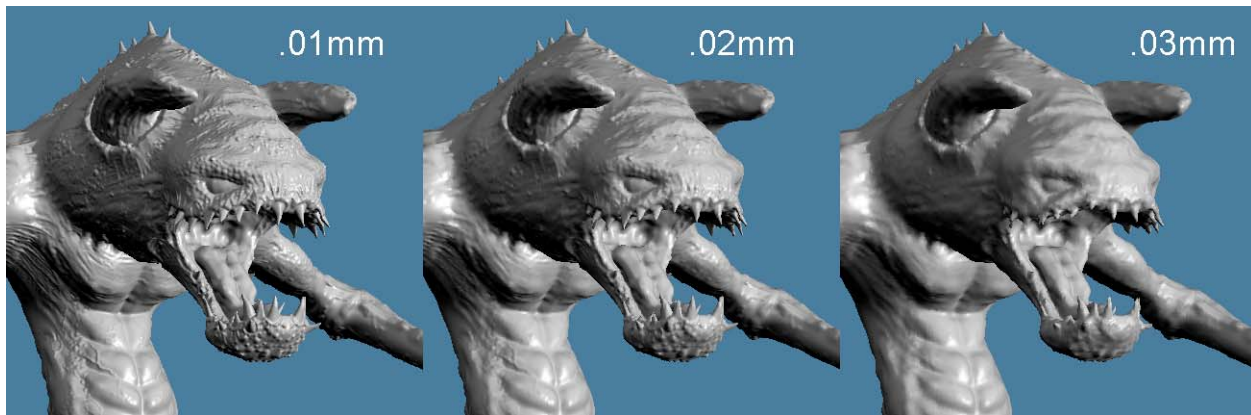


FIGURE 3-11. The model shown at various clay coarseness settings.

Mesh Optimization via Reduce for Export

If further reduction is desired, the “Reduce For Export” feature can be used to perform an automatic mesh optimization and reach a target triangle count.

Import the reference model into the Maya scene containing original low-resolution demon mesh. The reference model should appear coincident with the original demon mesh.

It is recommended to set a different shader for the 3D reference model to make it either see-through or a different color. This will allow you to more readily see the low-resolution mesh vertices and edges that are occluded by the reference model.

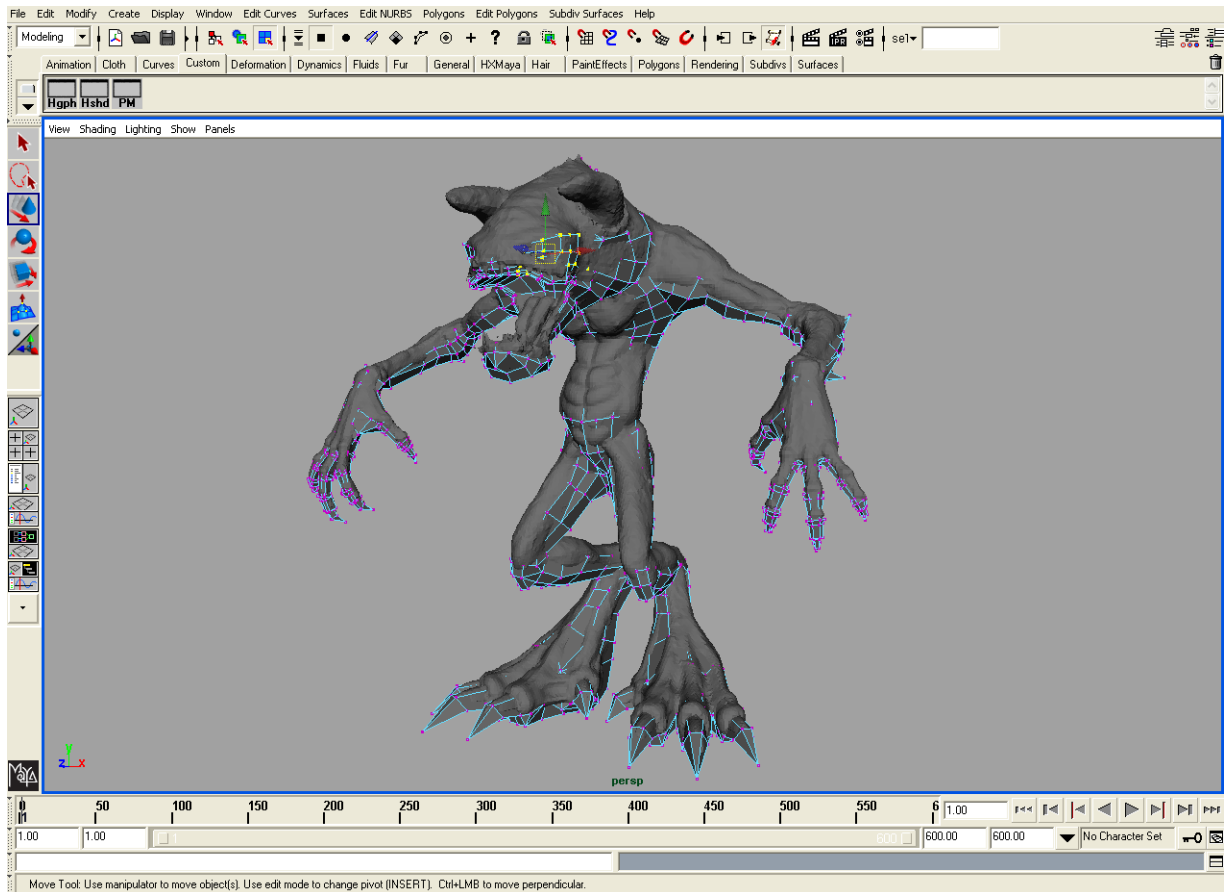


FIGURE 3-12. Low-res reference model aligned with Maya model for addition of new features to Maya model. In this case the horns had been added in ClayTools and the Maya model needs to be modified to capture these new additions.

Use your method of choice for modeling in any additional feature. Remember, it's only important to capture the silhouette features from the 3D reference model. Concave features that don't contribute to the silhouette can be safely ignored, since the normal map will adequately represent them.

The HapticExtender plug-in can also be invaluable in this process for moving vertices onto the surface of the reference model. For instance, you can quickly grab vertices for the teeth and feel the model from the inside as you move each vertex to the tip of the tooth. Additionally, 3d manipulation of vertices with Soft Modification Tool can be used for reshaping the mesh in places where muscular was added.

Below the final tuned demon model, which is ready now for UV mapping.

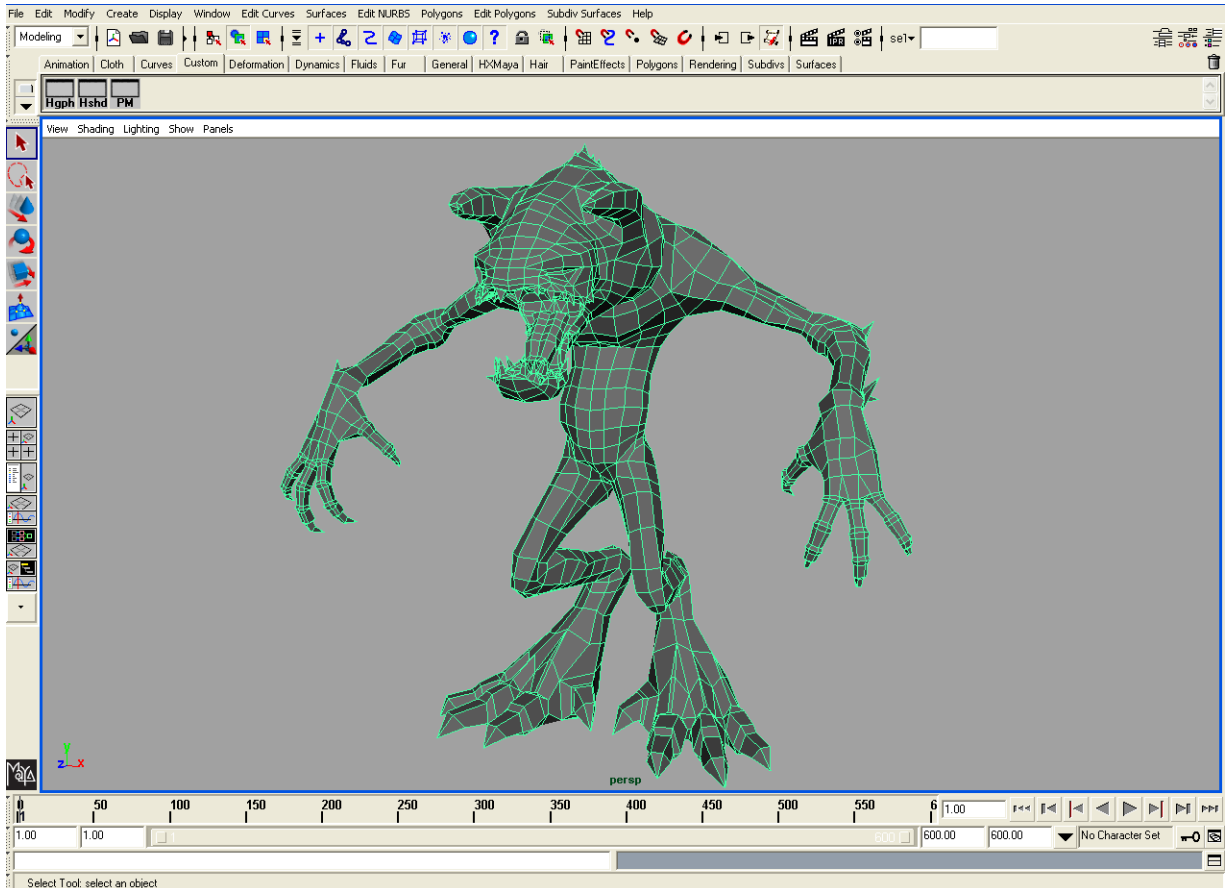


FIGURE 3-13. Modified Maya model.

Use your technique of choice for assigning UVs to the low-Resolution demon model.

This particular model is not using mirrored UVs. Please note that mirrored or flipped UVs may not be universally supported by all normal map display methods.

Be sure to check for inverted faces in the UV map before baking a tangent space normal map. A tangent space normal map is very sensitive to UV orientation.

Part 4: Baking ClayTools Detail into Texture Maps Using TextureKiln

Triangulate the model and export it as obj format. The exported triangle file is best for normal map UV reference in the TextureKiln utility. Upon export, undo the triangulation as it is no longer needed in Maya.

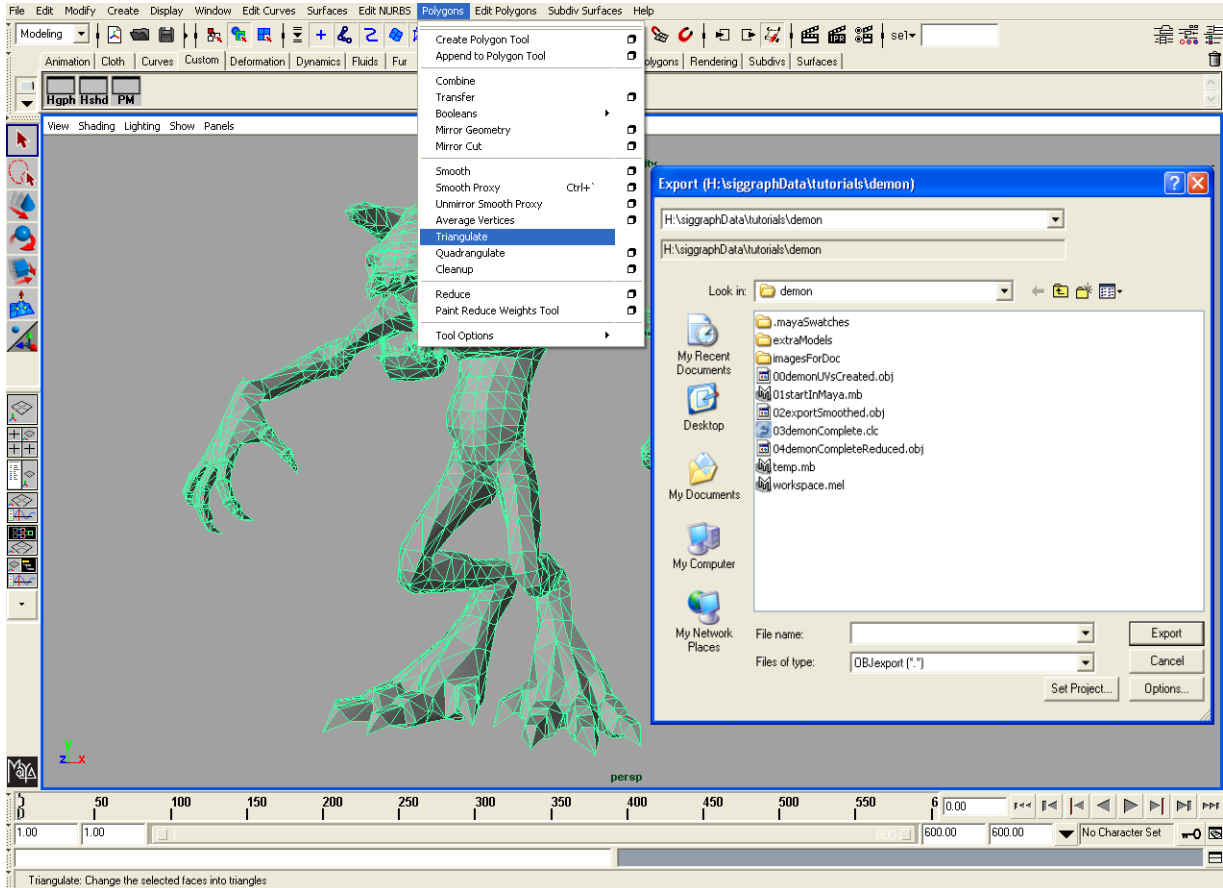


FIGURE 3-14. Polygons should be triangulated before export to provide a better reference object for ClayTools TextureKiln.

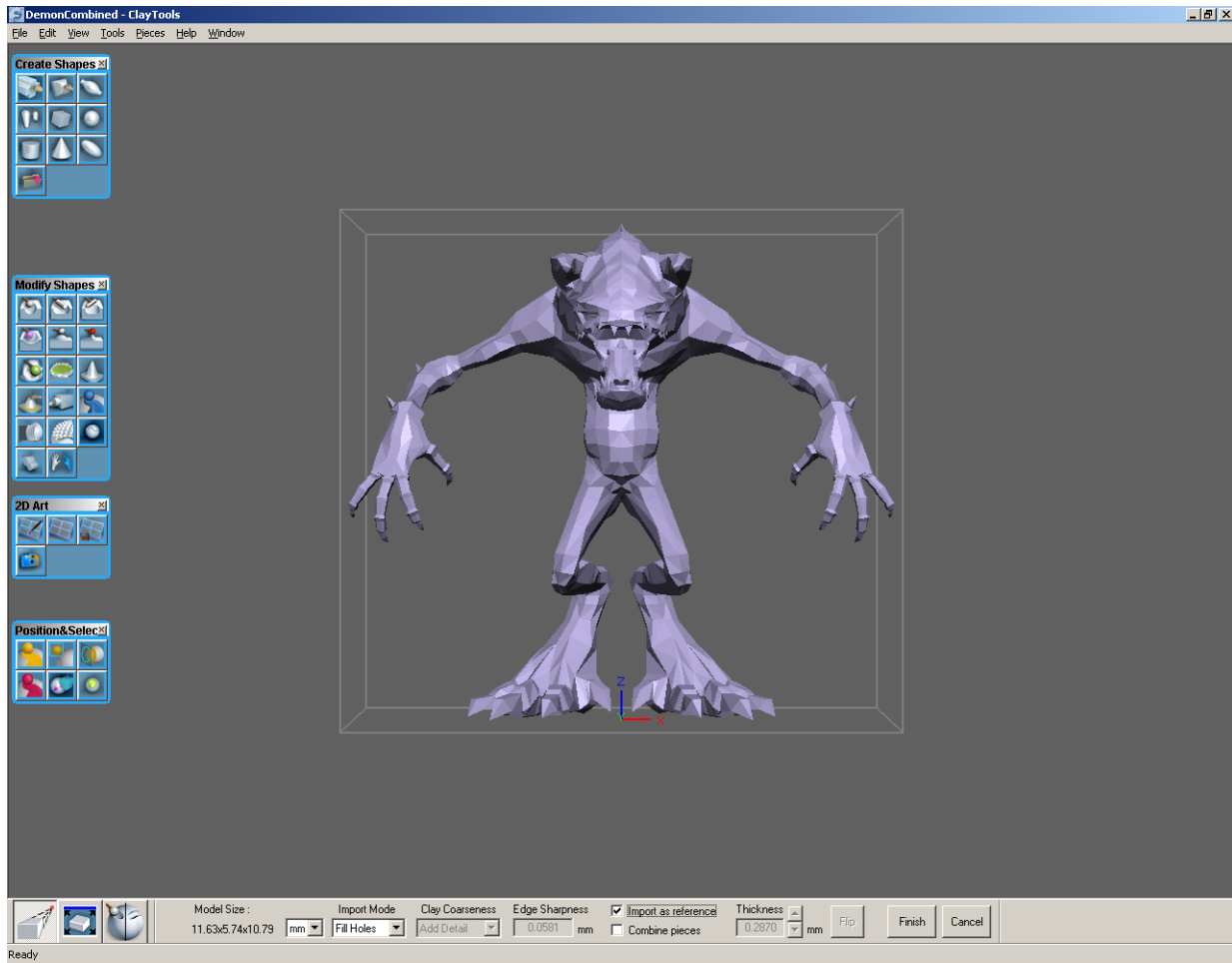


FIGURE 3-15. Triangulated model temporarily imported as a reference piece to check scale of object relative to clay piece.

As a sanity check or troubleshooting step, you can import the low-resolution OBJ model into ClayTools as a reference piece by checking “Import as reference” from the Import dynabar.

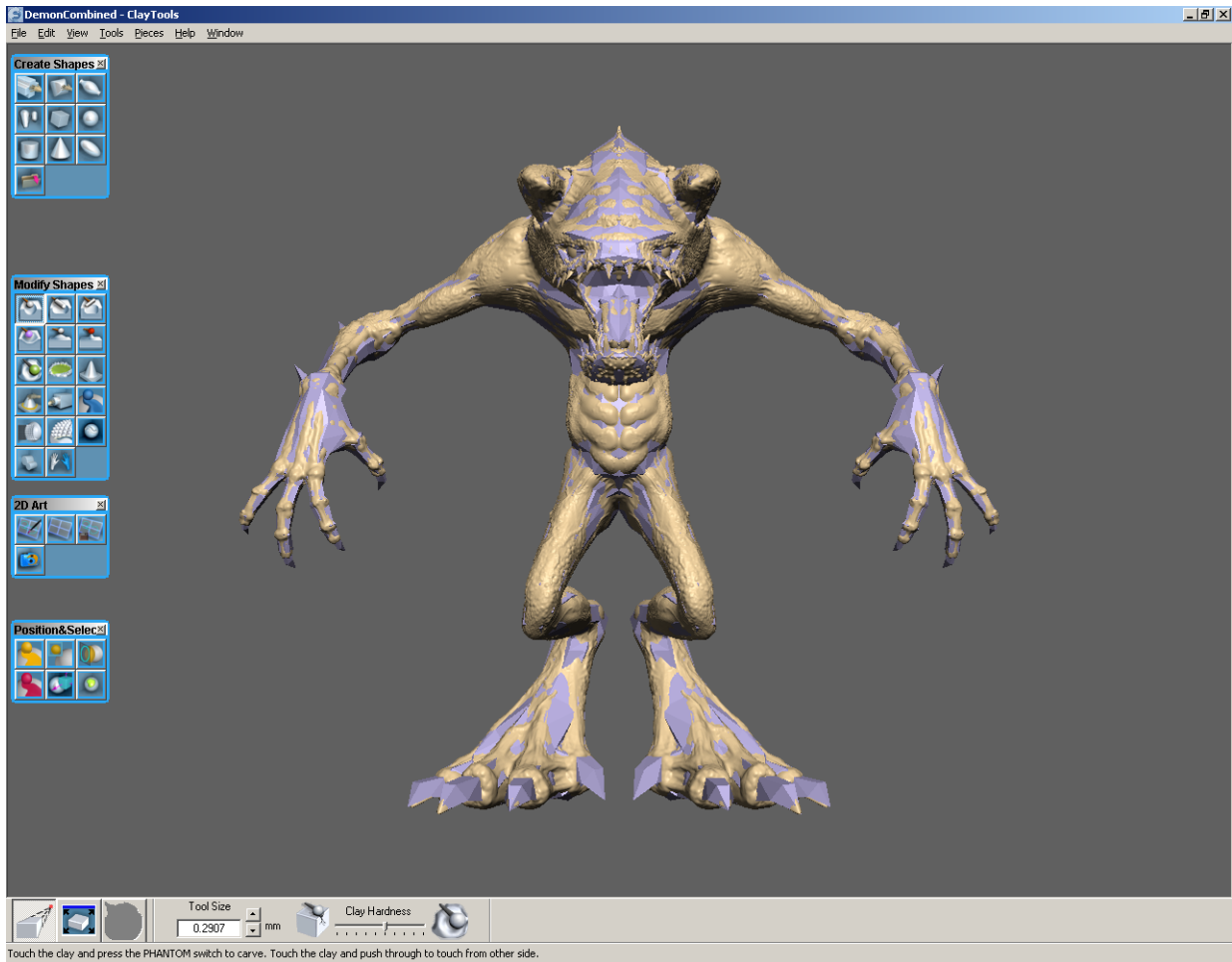


FIGURE 3-16. Reference piece collocated nicely with clay, indicating good alignment of source clay and reference geometry for TextureKiln.

If the imported reference piece is collocated with the clay piece, then things are in good shape for texture baking.

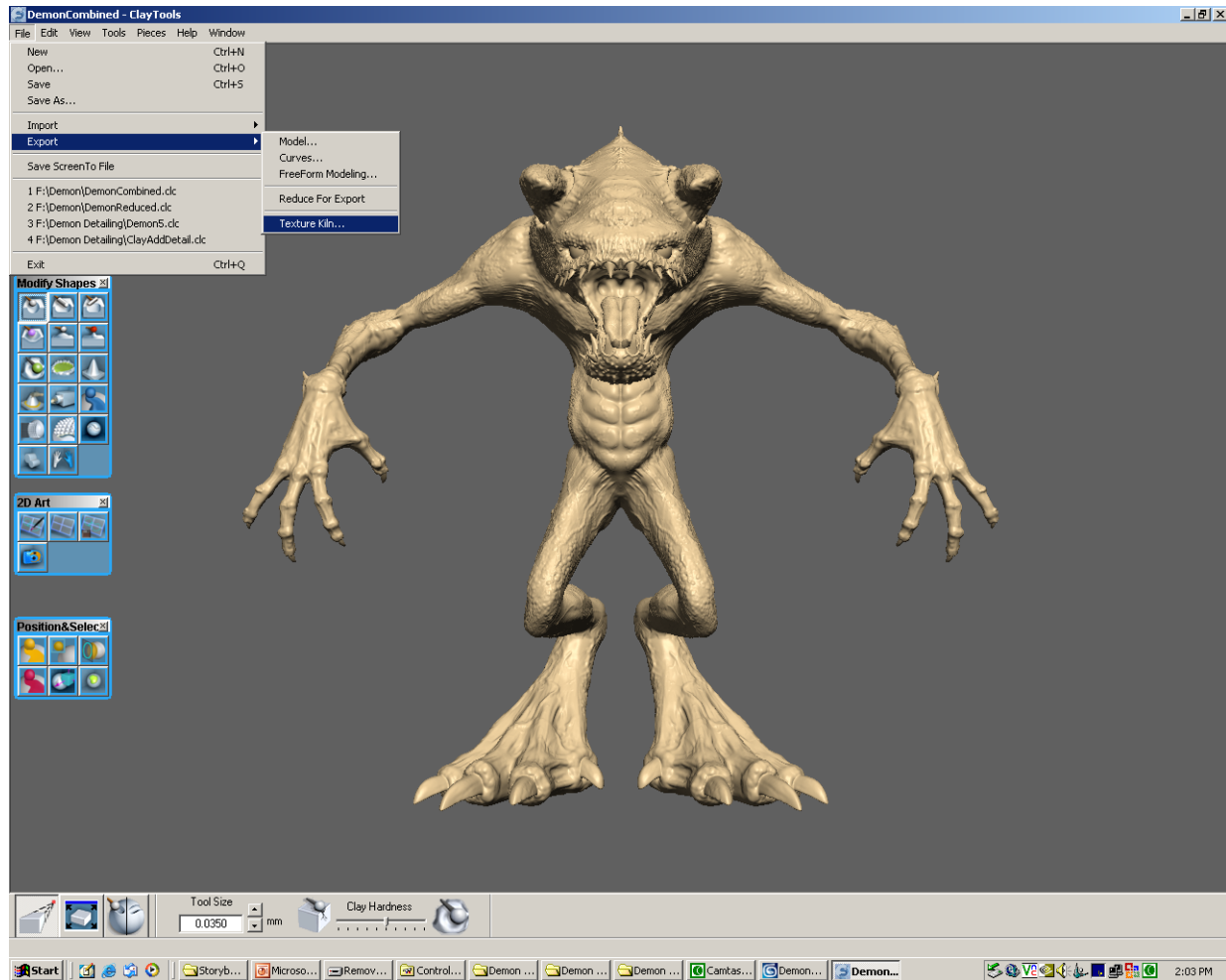


FIGURE 3-17. Use Export > TextureKiln on final detailed clay model for baking.

To bake a normal map from the detailed demon model, select File > Export > TextureKiln to invoke the TextureKiln options dialog.

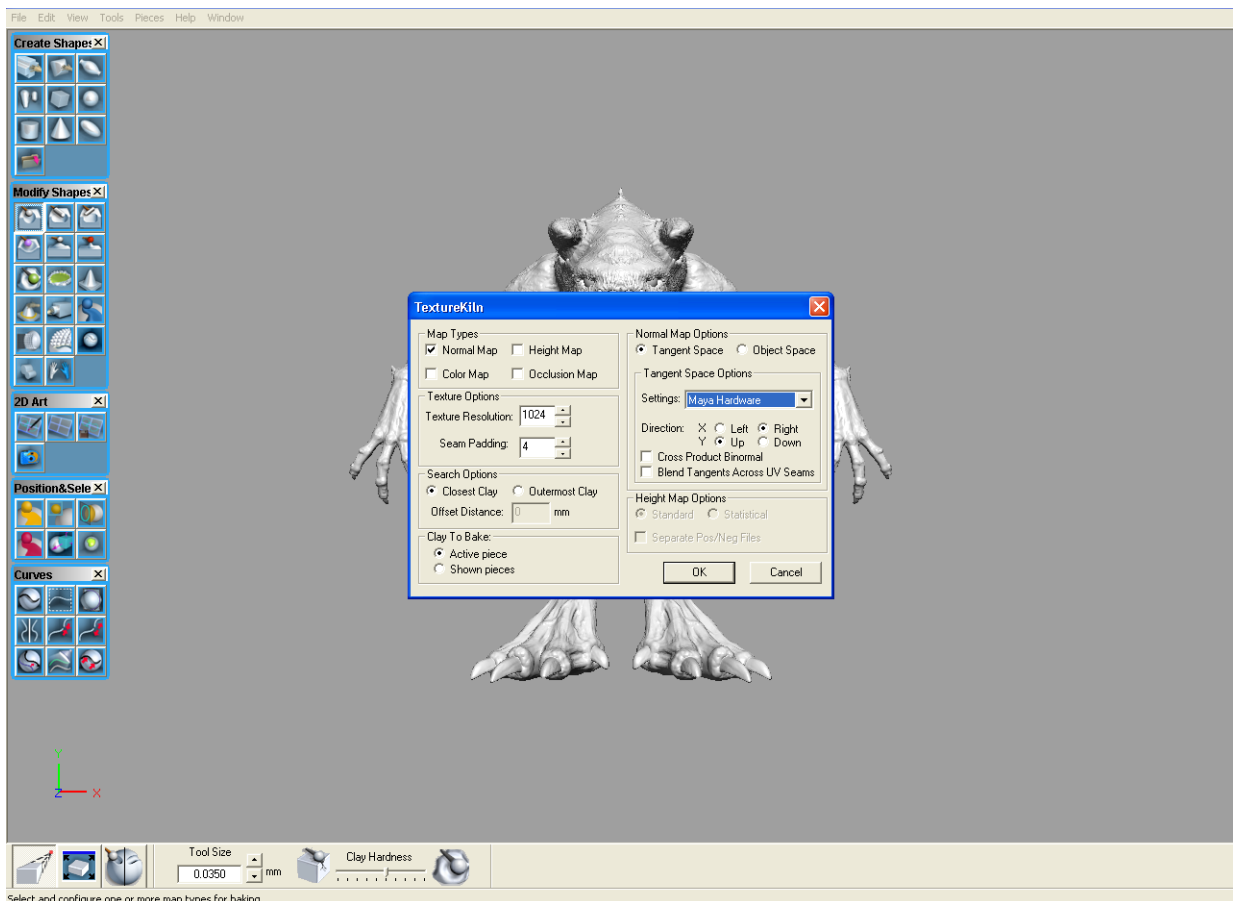


FIGURE 3-18. Settings for TextureKiln to create a Normal Map.

Check “Normal Map” from the Map Types. There are additional options available for configuring the normal map. In particular, the tangent space normal map has a few settings which are specific to the target shader to be used for displaying the normal mapped result. There is a preset option in the tangent space settings drop-down called “Maya Hardware” which is appropriate for normal map display in Maya.

In addition to the normal map, you can optionally bake an occlusion map to represent ambient shadowing patterns from the clay. An occlusion map is a great way to dirty up a diffuse texture. Please note, an occlusion map is more compute intensive than any of the other map types. It is recommended to experiment with the normal map first and ensure that you are getting the desired results from it before baking an occlusion map.

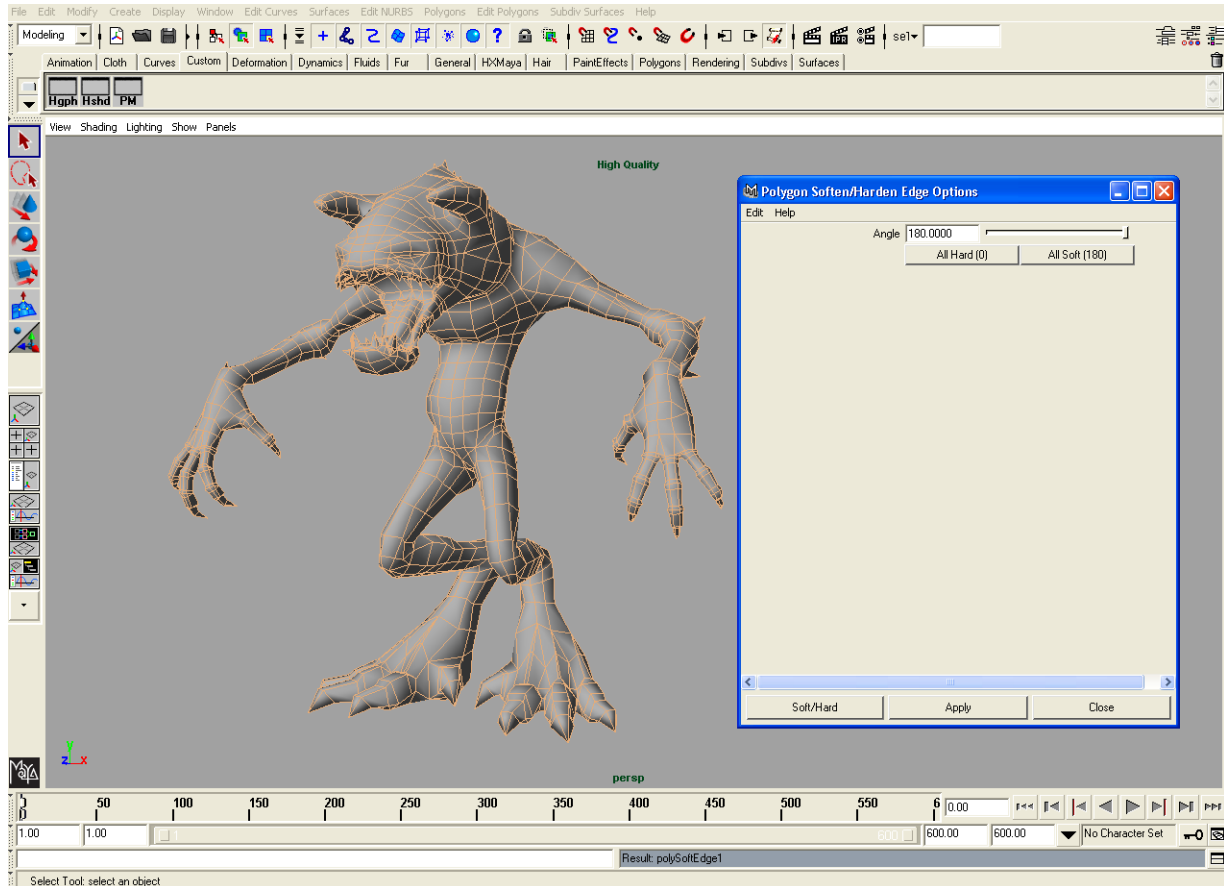


FIGURE 3-19. Soften all normals of target geometry for mapping as the actual normals will come from the normal map created in ClayTools with TextureKiln.

Before applying the normal map, make sure that all of the normals are smoothed together.

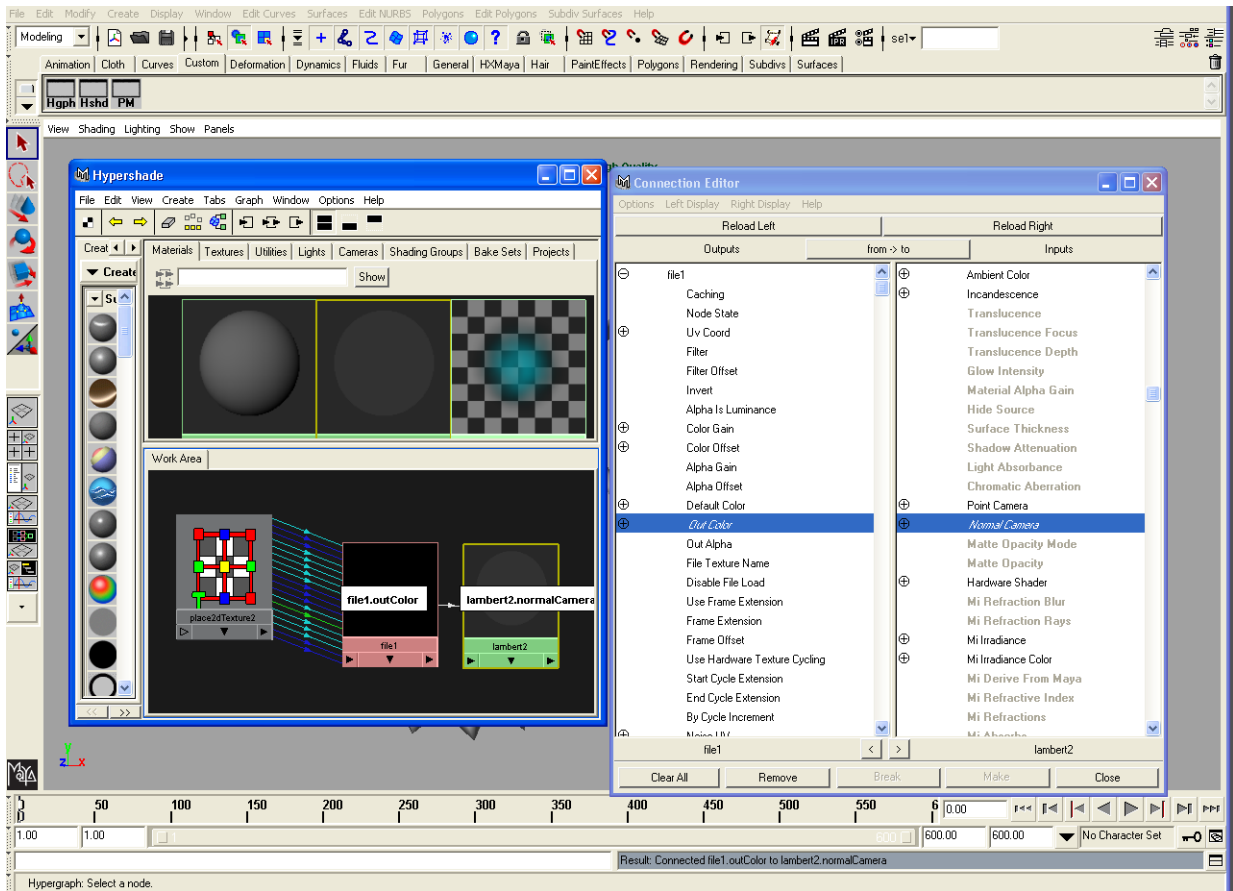
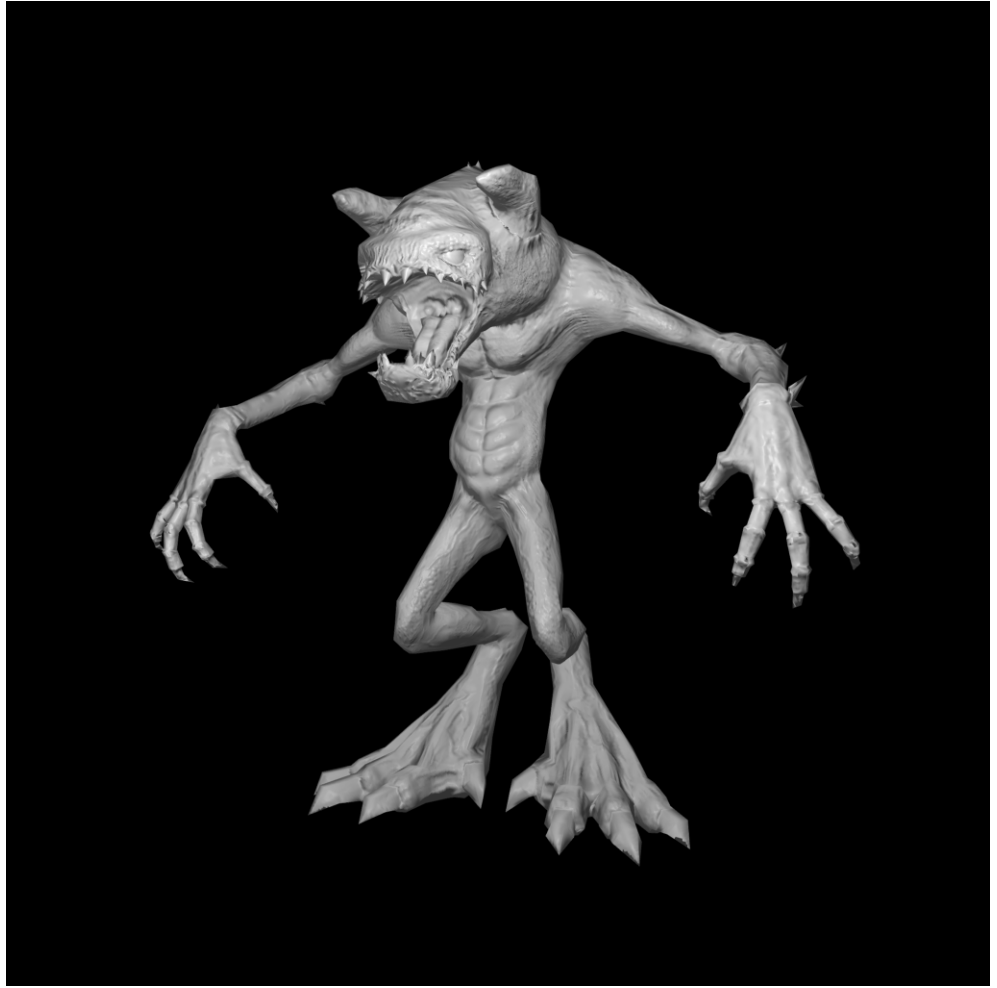


FIGURE 3-20. Connection editor showing normal map file connection to shader.

ClayTools to Maya

Creating A Character Model with ClayTools and Maya



This workflow goes through the process of working from ClayTools to Maya to create a character model. This is a workflow example with two possible downstream outcomes, games or film/video, depending on the decision branch taken at a specific point in the middle of the workflow. This workflow assumes the user is already familiar with Maya.

In this particular workflow, the model is created in ClayTools first, and then an optimized model and relevant normal or height mapping is derived from that using TextureKiln for use in downstream production.

This workflow is broken into the following parts:

World units must be consistent

Both Maya and ClayTools should be set to consistent world units in order to avoid unnecessary rescaling of units. In ClayTools, this option is found under Options. In Maya, this setting is found under the main toolbar heading Windows > Settings/Preferences > Preferences > Settings. In this particular workflow it is preferable to use centimeters, as this is the native unit of measure in Maya. Not adhering to this may cause data to be scaled incorrectly due to unit conversion methods used by the OBJ import/export in Maya.

Part 1: Creating a Curve Network in ClayTools

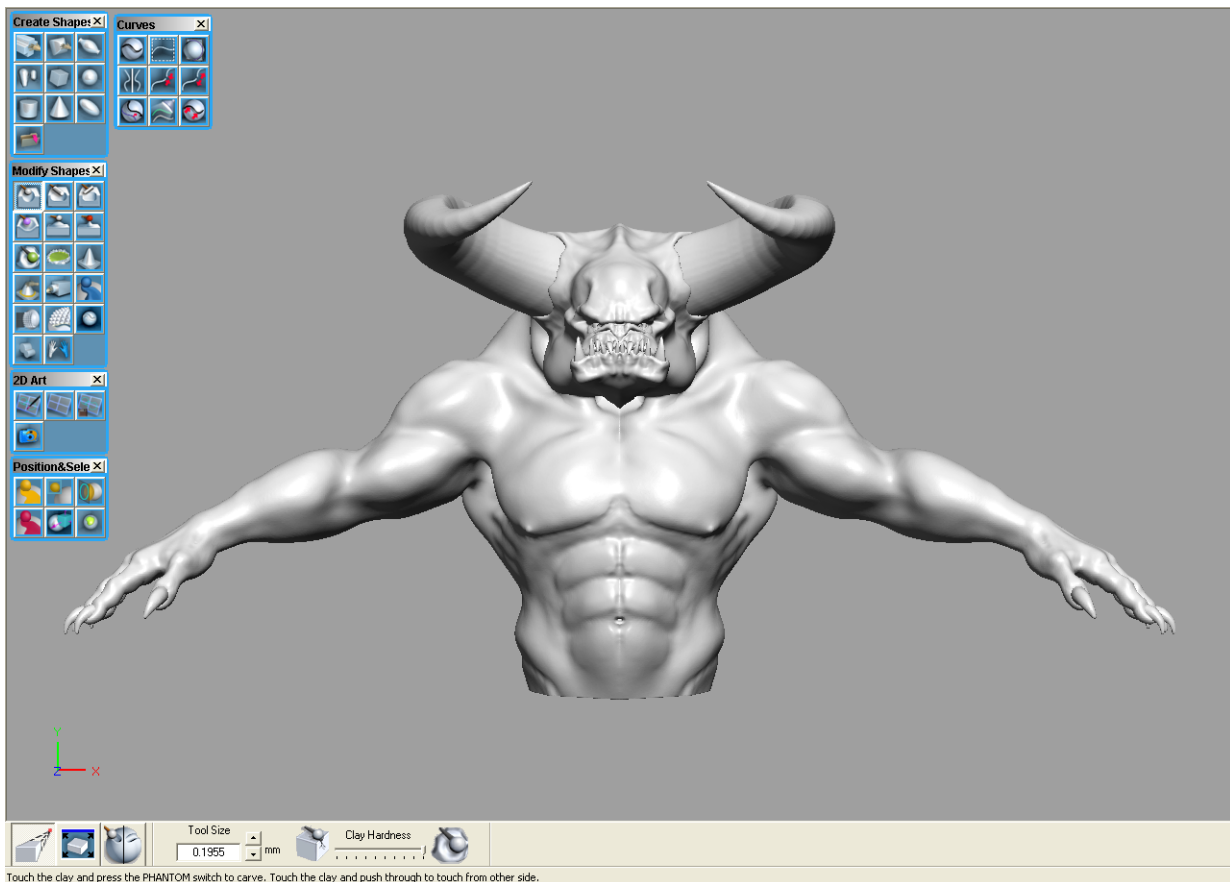


FIGURE 4-22. The overall form of the minotaur created in ClayTools in four separate pieces: torso, horns, nails and teeth.

In order to save time, two different people worked in parallel on this example. Modeler One developed the overall form of the character as seen in Figure 4-22, and before beginning the final detail, handed off a copy of the model to Modeler Two for the simultaneous development of the optimized model form. This workflow example begins at the handoff. Note that you could also finish the detail first, make a copy of the model

and apply smoothing (the mapping will pick up the detail on the original), then frame that simplified model. If time allows this method is preferred as it creates a better match between the final detailed model and the curve frame when mapping is generated.

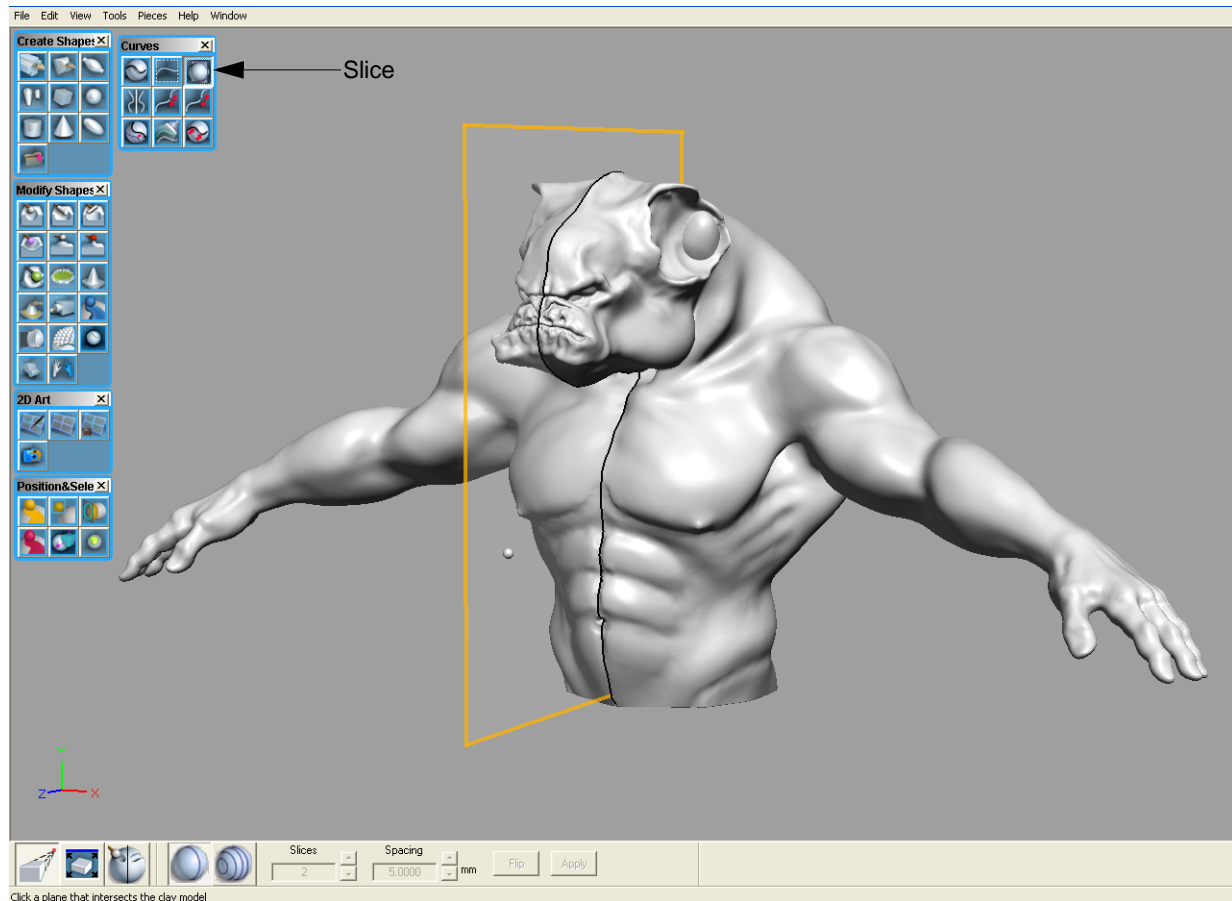


FIGURE 4-23. Horns, teeth, and nails are hidden using the Object List. The Slice tool is use to create a center line curve on the model.

While Modeler One continued on with the final detailing, Modeler Two began to lay out curves on the model to capture the basic form of the character with NURBS curves. Using the “Slice” tool (Figure 4-23), a center line curve was placed down the mirror line of the torso/head clay piece. The other pieces (horns, nails, teeth) were hidden using the Object List (shortcut Key O), until we are ready to frame out each with curves.

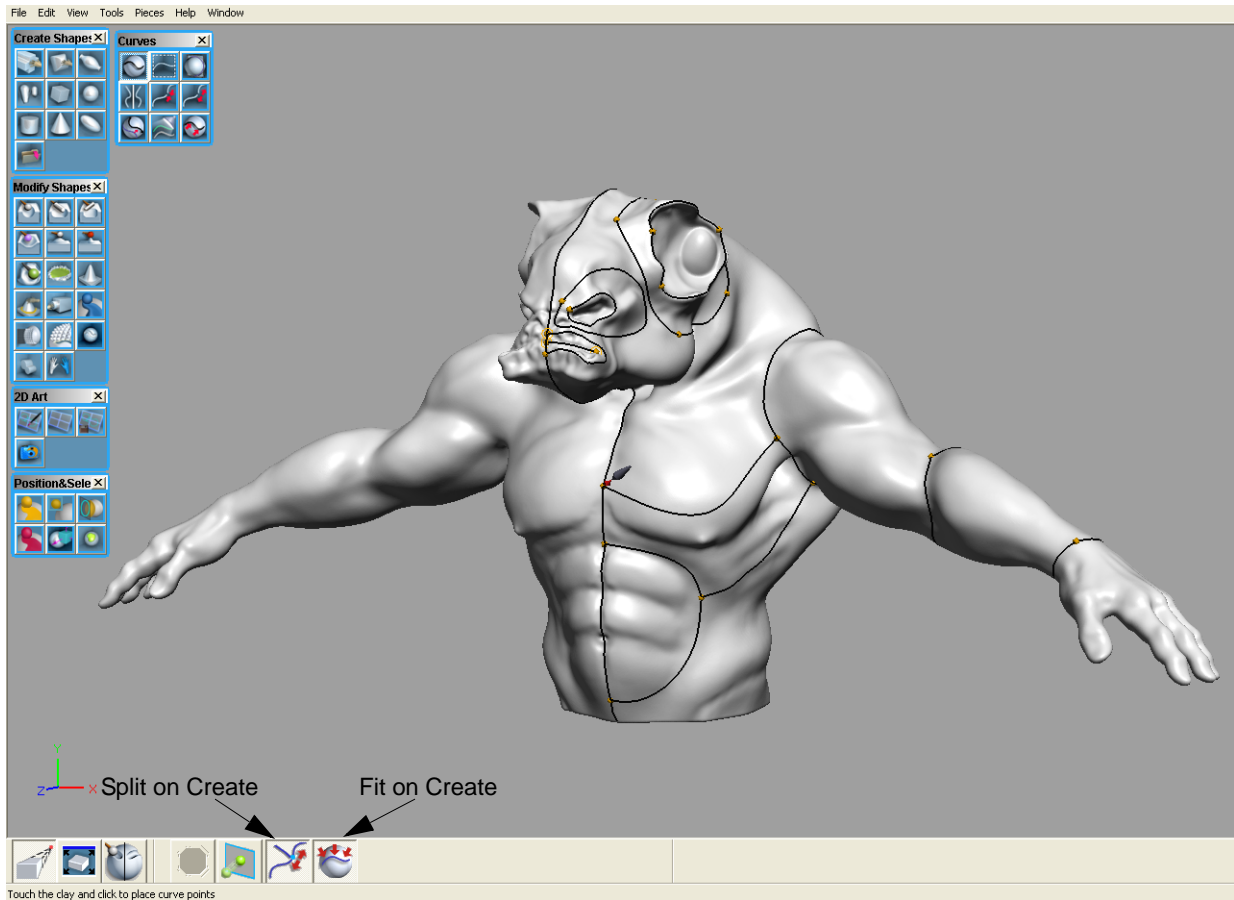


FIGURE 4-24. Curves drawn fit to clay to capture the form of the character

Key features were framed out with edge loops of curves that were fit to clay, using the “Fit to Clay” option on the Dynabar, so these animate-able areas of the model topology could be determined easily. Since the model can be touched, sensing the actual features and outlining them with curves is extremely fast. Note that because you can feel the detail, you can trace curves along valleys in the model surface as well as pop inside the model to trace along edges of muscle or features such as the rims of the head where the horns join it. The model is then covered with four-sided curve boundaries using the curve tool with the

options “Split on Create” set on the dynabar (Figure 4-24), which will become patches in Maya. Four-sided is preferred over three. Though three may work in some downstream pipelines, they should be avoided.

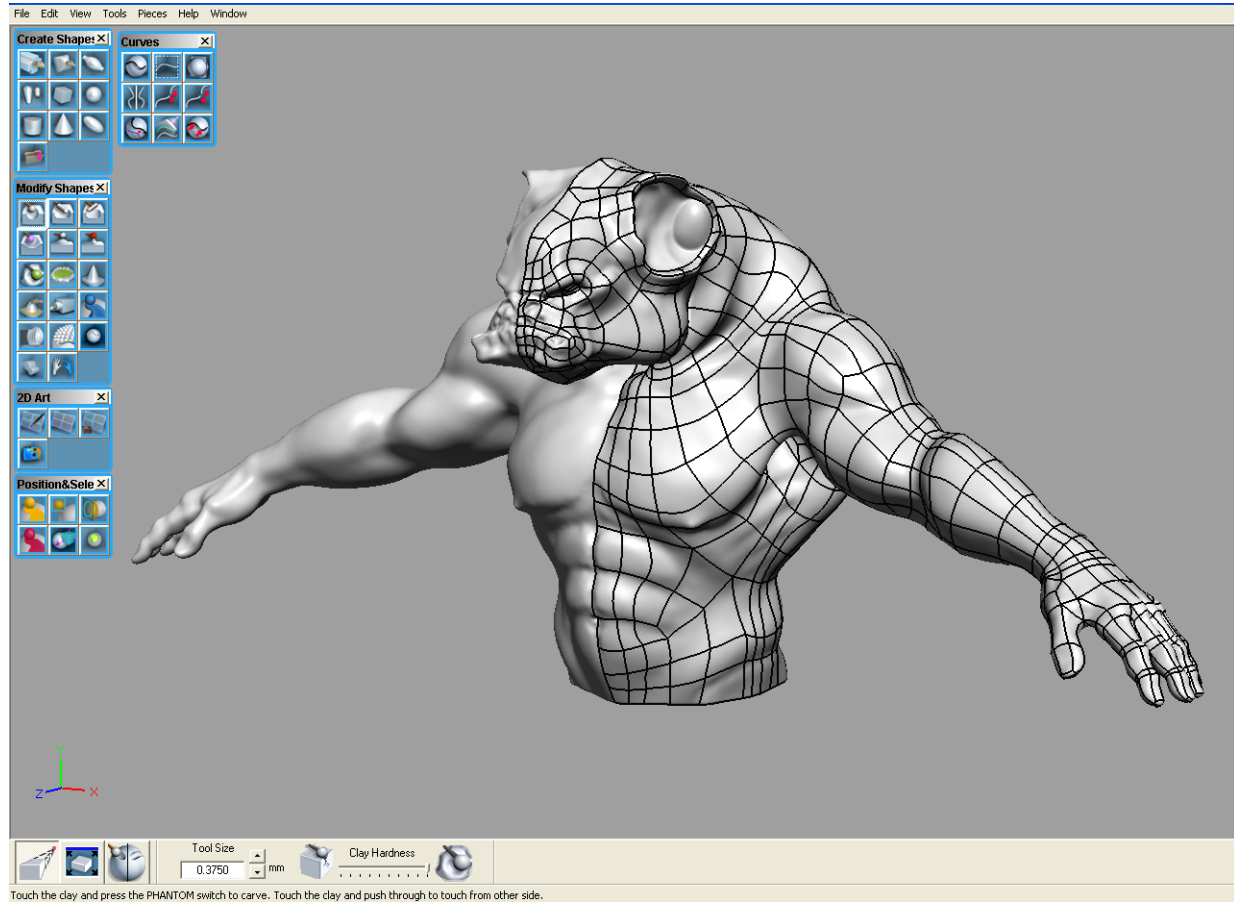


FIGURE 4-25. A curve network completely frames out one half of the torso and head.

In Figure 4-25, half of the model is completely framed out with four sided boundaries. Because these curves will be mirrored in Maya, only half of each piece needs to be done.

Tip At any point in the process, curves can be edited with the Select tool and refit to the surface of the model using the “Fit to Clay” tool. Take time to review the model and make sure the framework consists of only four sided boundaries

(some three-sided are acceptable, but not preferable). Note that because you can see and feel the model (haptics), it is much easier to lay out a well defined and elegant topology.

The other pieces (horns, nails, and teeth) are completed in the same way by making each piece active (and therefore touchable) and tracing the form. In this way, curves are created in relation to each piece, and can be exported as a separate IGES file, using File > Export > Curves by using the Object List and the Show Only context to show one piece and its curves at a time

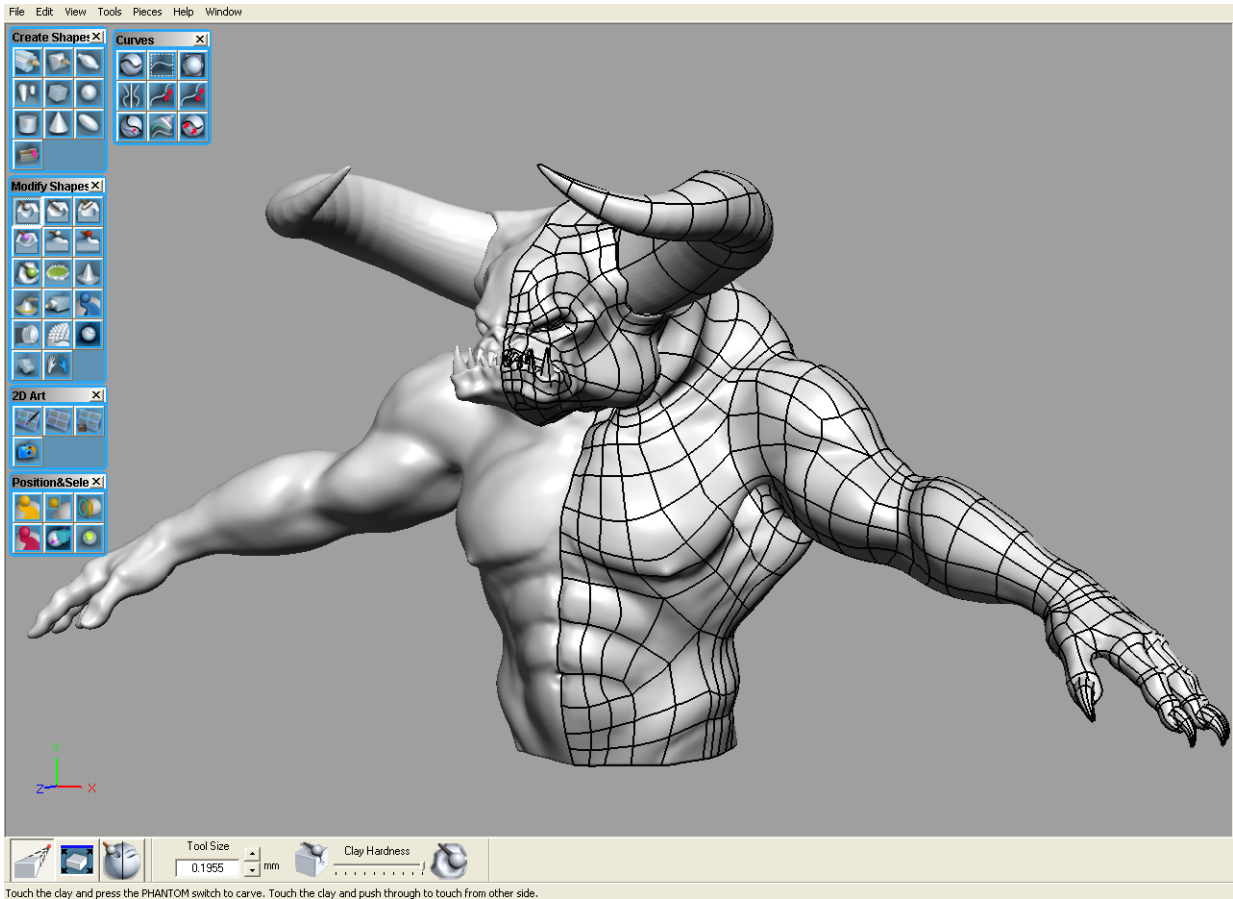


FIGURE 4-26. The curve network for each piece of the model has been created and is made visible using the object list

Part 2: Surfacing the Curve Frame in Maya

Making sure that a common unit of measure is used between ClayTools and Maya (in this case centimeters), each part of the model is imported into Maya as IGES curves. Examine the curve frame and observe closely to see that all curves form a 4-sided boundary. This is necessary for using the Boundary Surface tool in Maya.

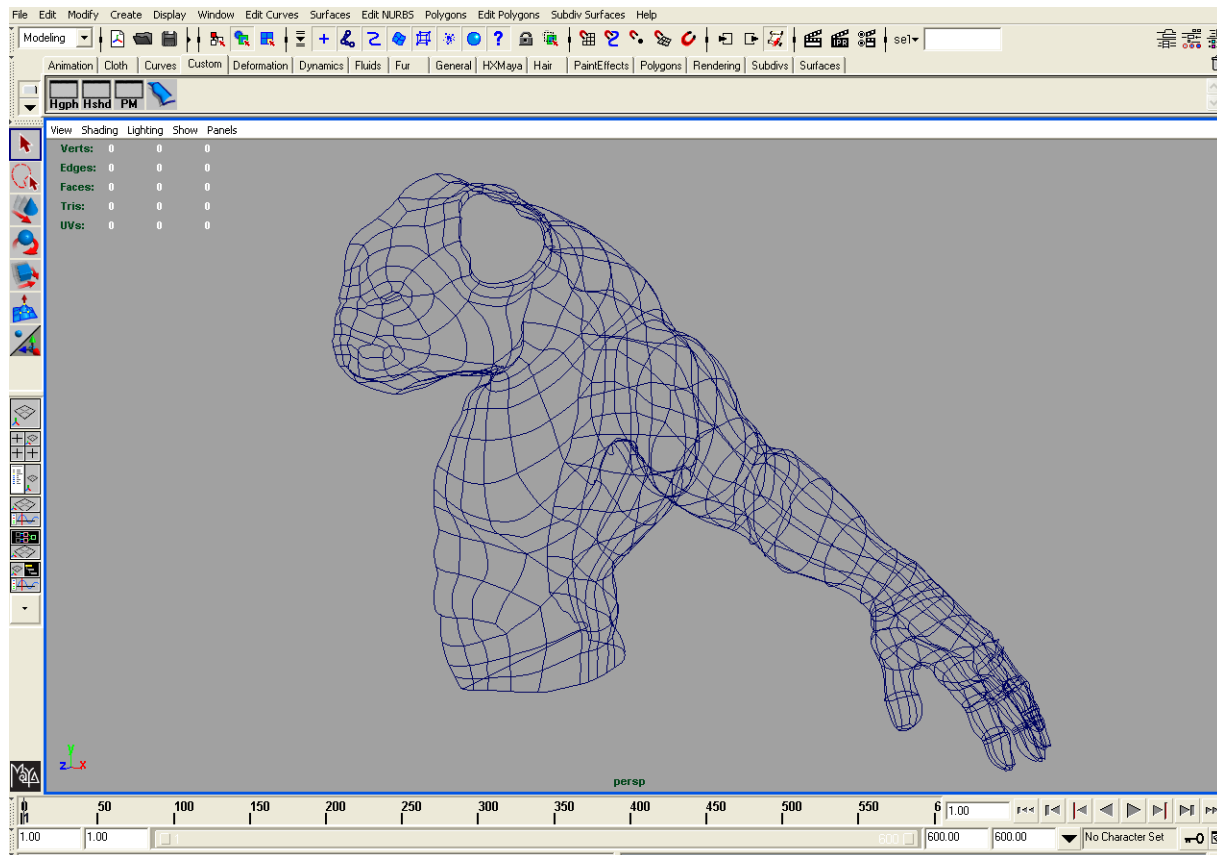


FIGURE 4-27. Curve network of torso and head only is imported into Maya.

Use the Boundary Surface tool to cover the model frame with surfaces. Set the option to Common End Points > Required; it will help in building surfaces in the proper boundaries.

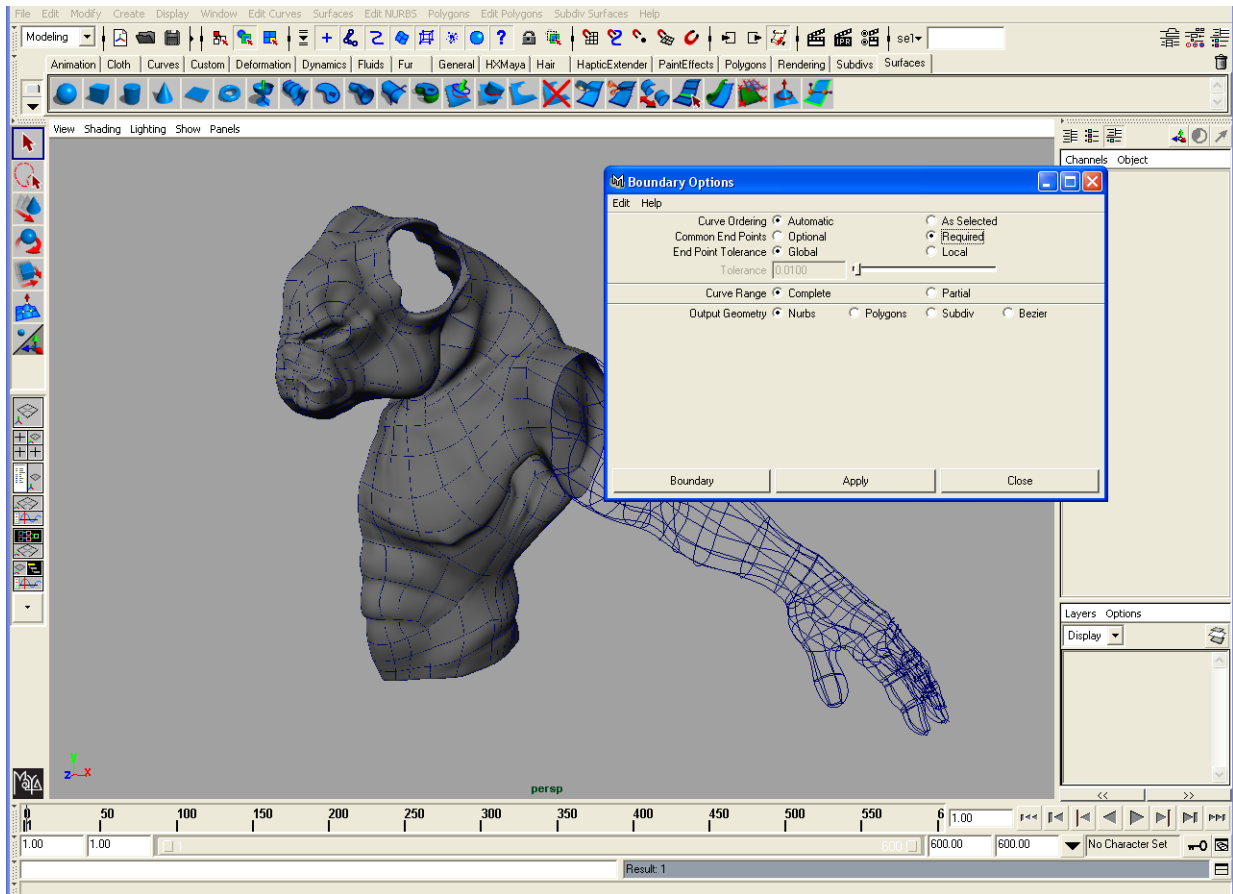


FIGURE 4-28. Boundary Surface tool used in Maya.

Once the surfaces are completed, use the Edit NURBS > Rebuild Surfaces tool to rebuild the surfaces to uniform parameterization. This will allow the proper conversion to a uniform polygon mesh.

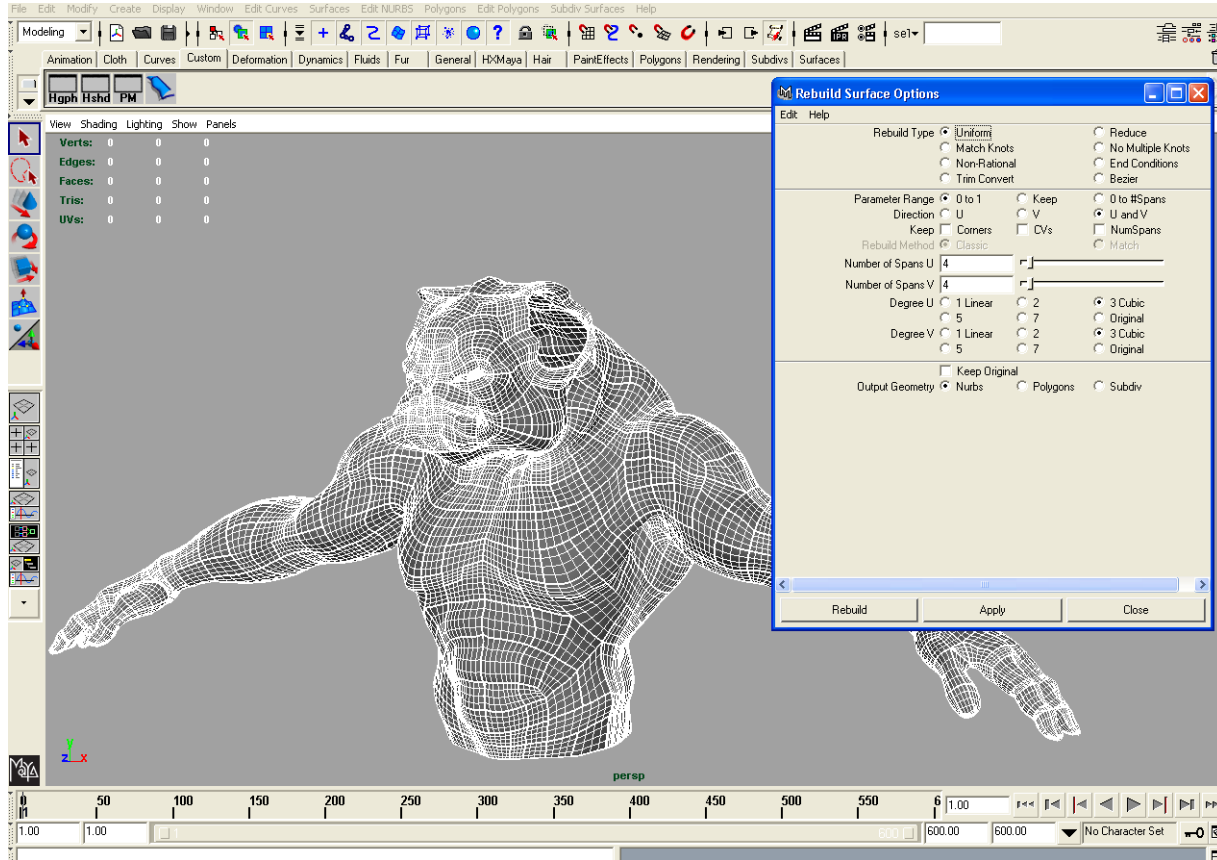


FIGURE 4-29. Uniform parameterization is achieved by rebuilding the surfaces.

Once the surfaces are uniform, use **Modify > Convert Surfaces to Polygons**, with the **Attach Multiple Mesh** option selected. The **Merge Tolerance** may need some experimentation for best results depending on the model.

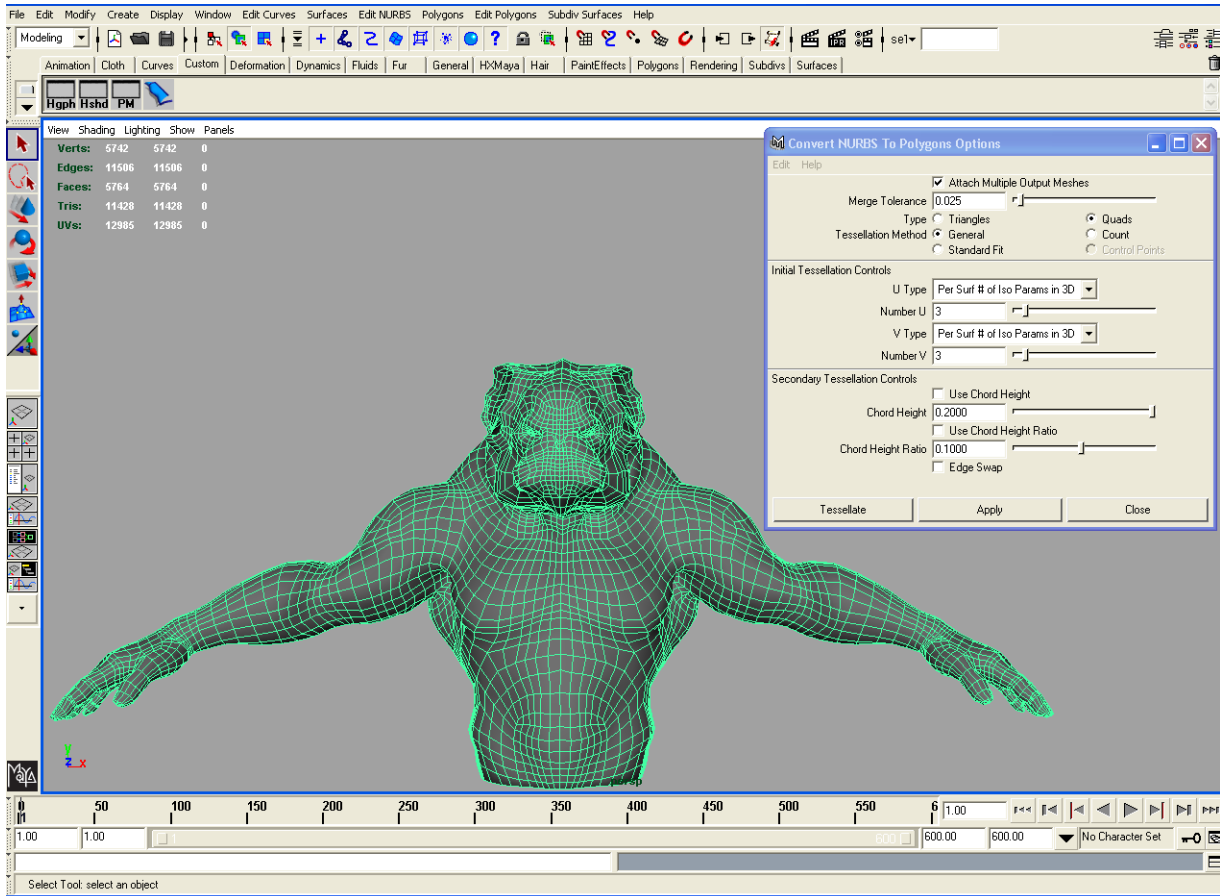


FIGURE 4-30. Surfaces are converted to polygons

Use the parameters to control the density of the mesh as needed for the intended downstream application. Games will have a fairly light mesh, while film and video may be slightly more dense and may be converted later to subD surfaces for rendering.

Repeat the process for each of the pieces until all pieces are a separate polygon mesh. Evaluate the shading of each, making sure all polygon normals are all pointing out in the same direction. Good normals are critical in proper map generation.

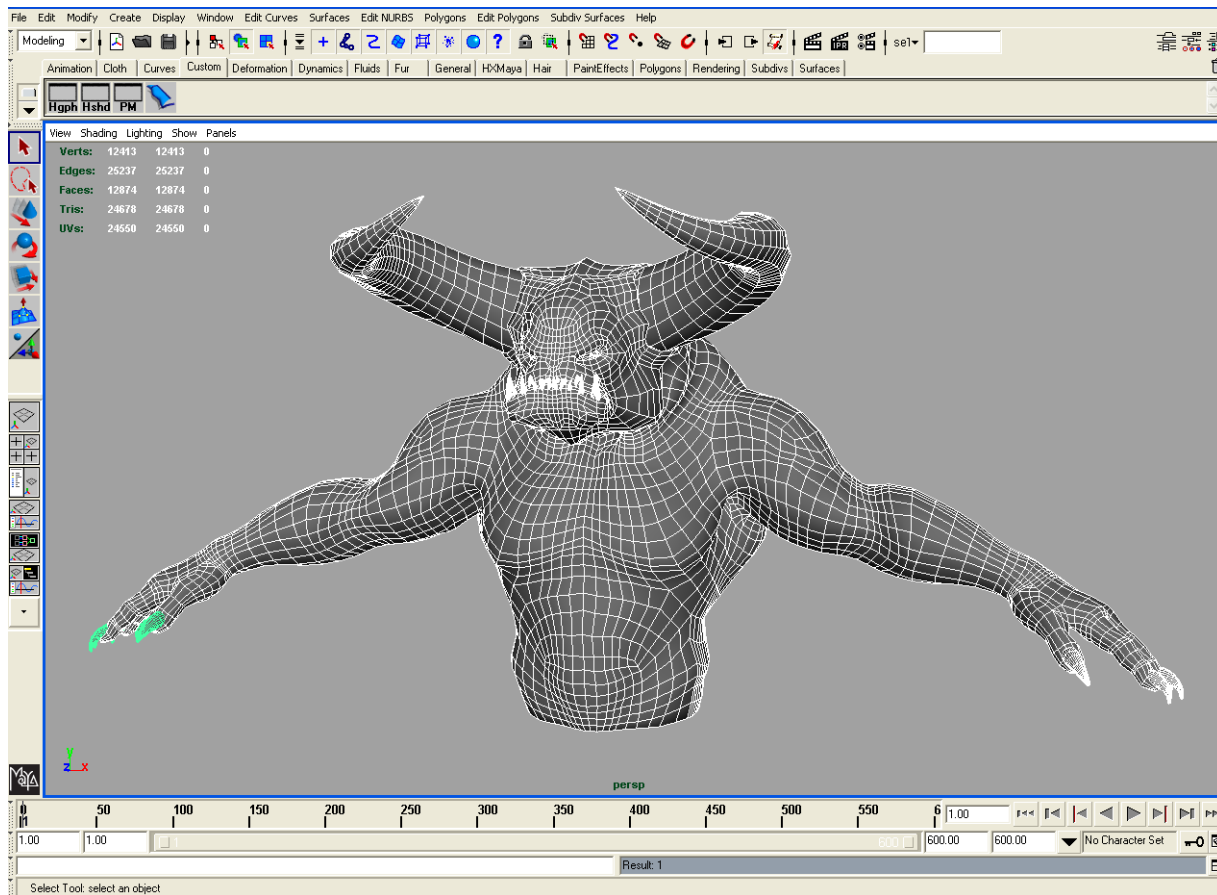


FIGURE 4-31. Each of the pieces is imported into Maya and surfaced individually

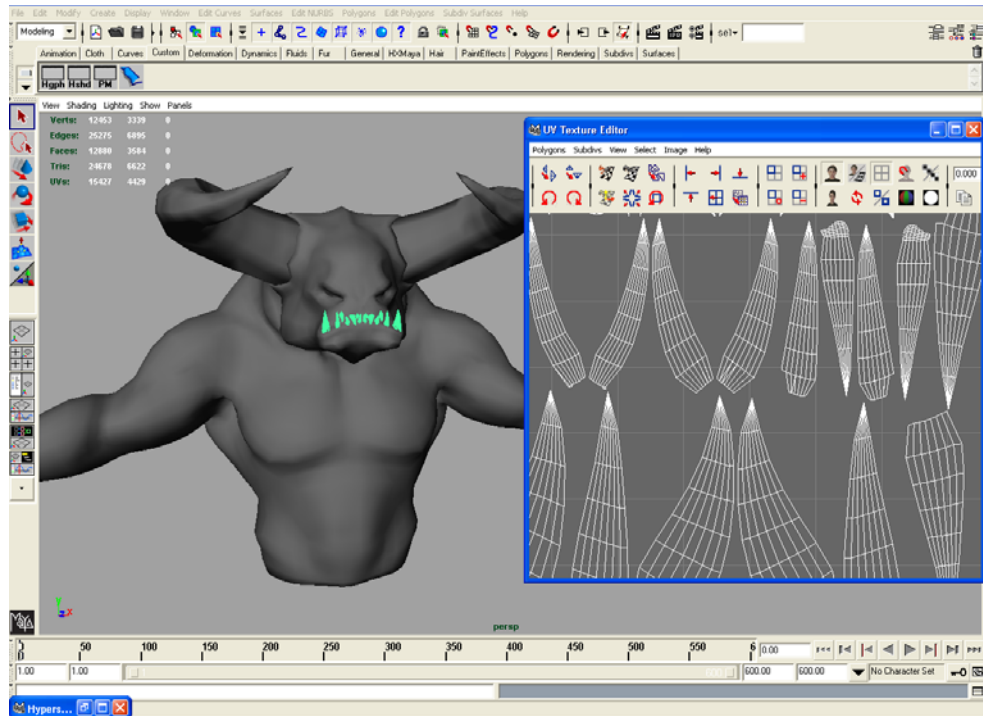


FIGURE 4-32. UV Mapping of the teeth.

For each piece, use the Maya tools for creating proper UV mapping. In Figure 4-32 the teeth are shown in the UV Texture Editor. Backup your file at this time and then temporarily make a copy of each piece, triangulate it and export each copy as an OBJ file on completion of the UV mapping. Each of the OBJ files will be used to provide the UV mapping to the ClayTools TextureKiln function for the creation of the Normal, Occlusion or Height maps, depending on the intended downstream pipeline. You may delete the

triangulated copies from Maya after export as they will just be used in ClayTools for UV reference. In the next section we will create Normal Maps. If you are interested in Height Maps jump to “Part 3B: Creating Height Maps in ClayTools” on page 4-20.

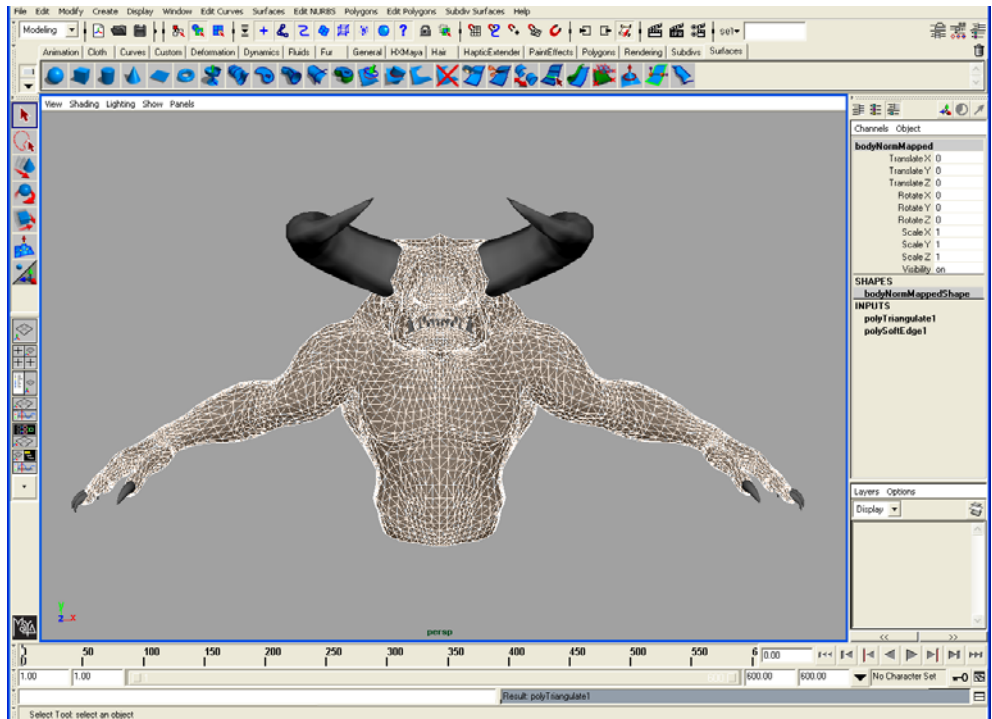


FIGURE 4-33. Triangulated copy of the model used for export to ClayTools for baking

Once the UV mapping and triangulation is completed on each piece, it is time to capture the detail from the highly-detailed finished pieces in ClayTools. Here we see the model at a finished level of detail that was complete by Modeler One.

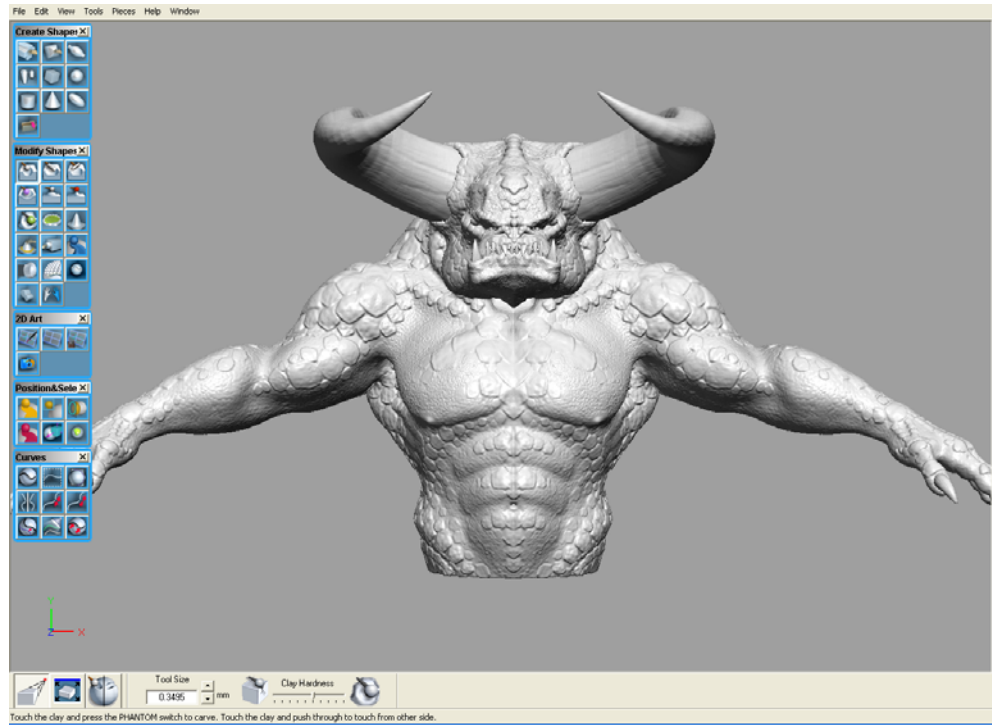


FIGURE 4-34. Front view of detailed model in ClayTools

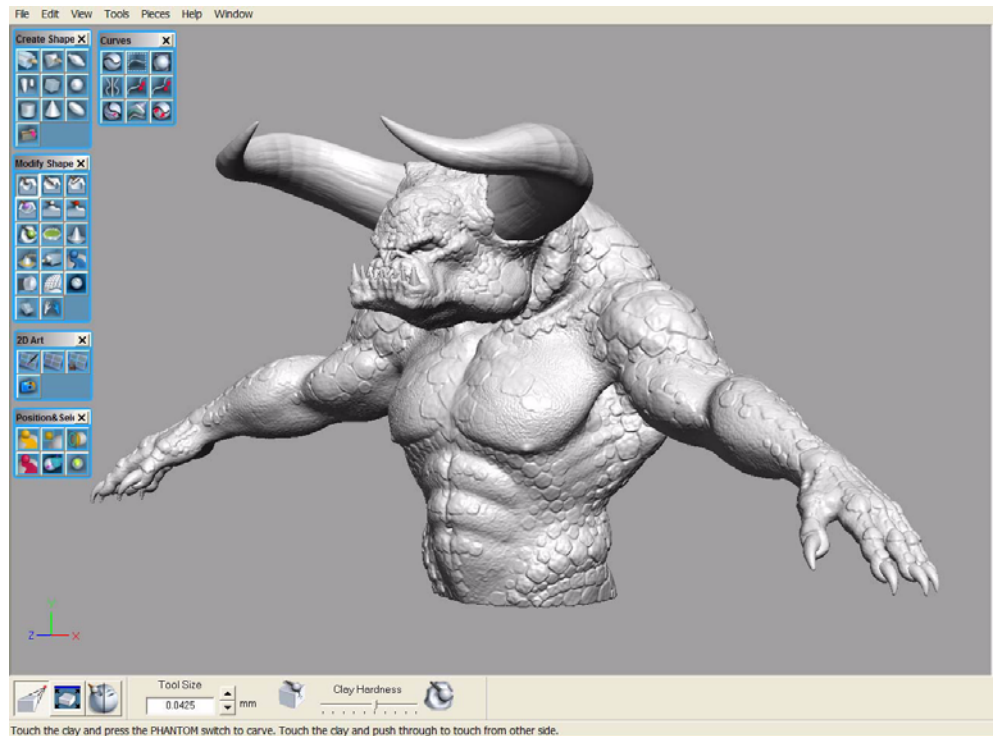


FIGURE 4-35. 3/4 view of detailed model in ClayTools.

Using File > Export > TextureKiln, create either Normal, Occlusion or Height mapping. In this example below, a Normal map (An example for creating height maps begins on page 4-20) for Maya Hardware at a resolution of 1024 is being created for each piece individually by referring to the active piece. After setting the options as below, and choosing OK, the reference UV OBJ file is requested and the map is generated.

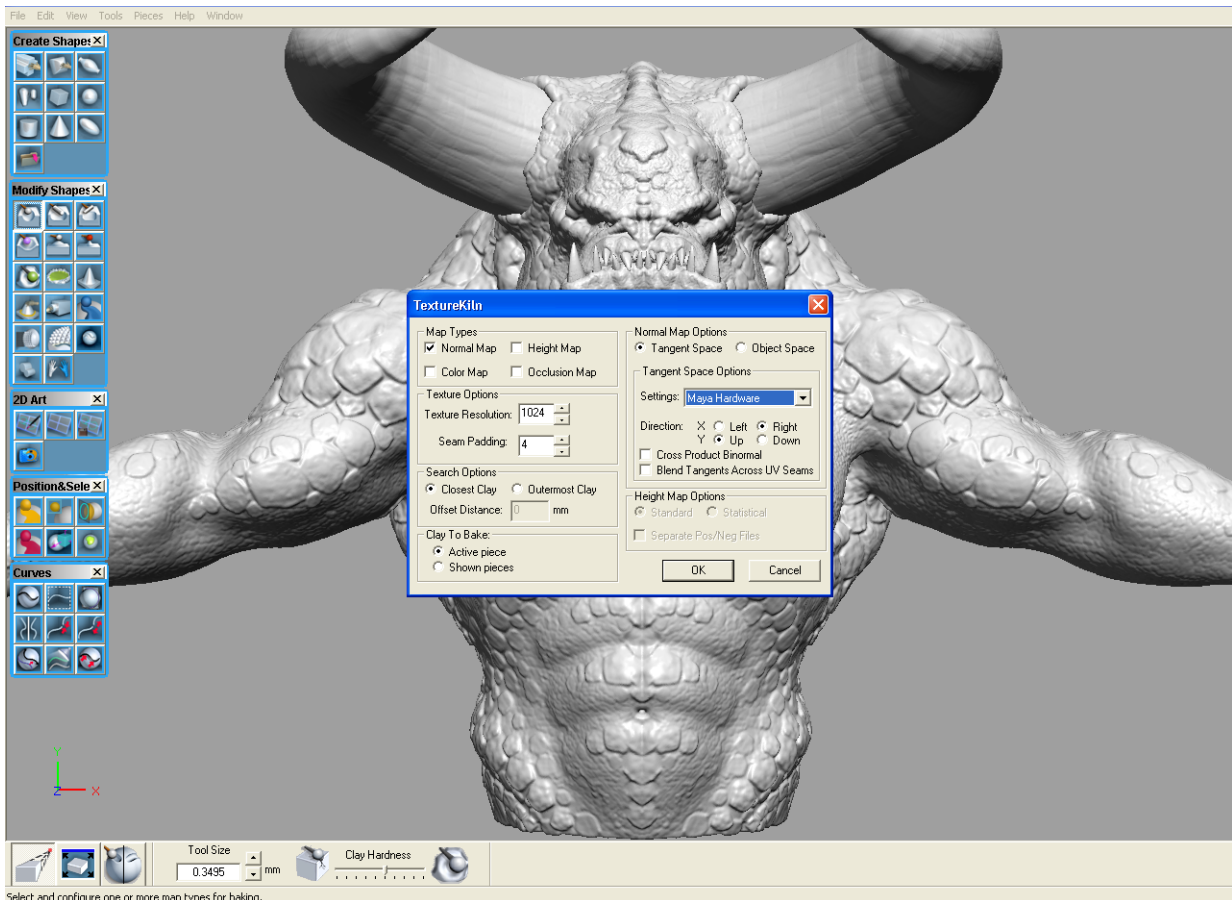


FIGURE 4-36. TextureKiln is used to create a normal map.

Applying Normal Maps

Once the Normal map is generated for each piece, a shader for each piece is created in Maya and the Normal map file texture is connected to the Normal Camera input using the connection editor (middle mouse drag the file texture over the shader, choose Other from the pop up, then connect the Out Color of the file to the Normal Camera of the shader).

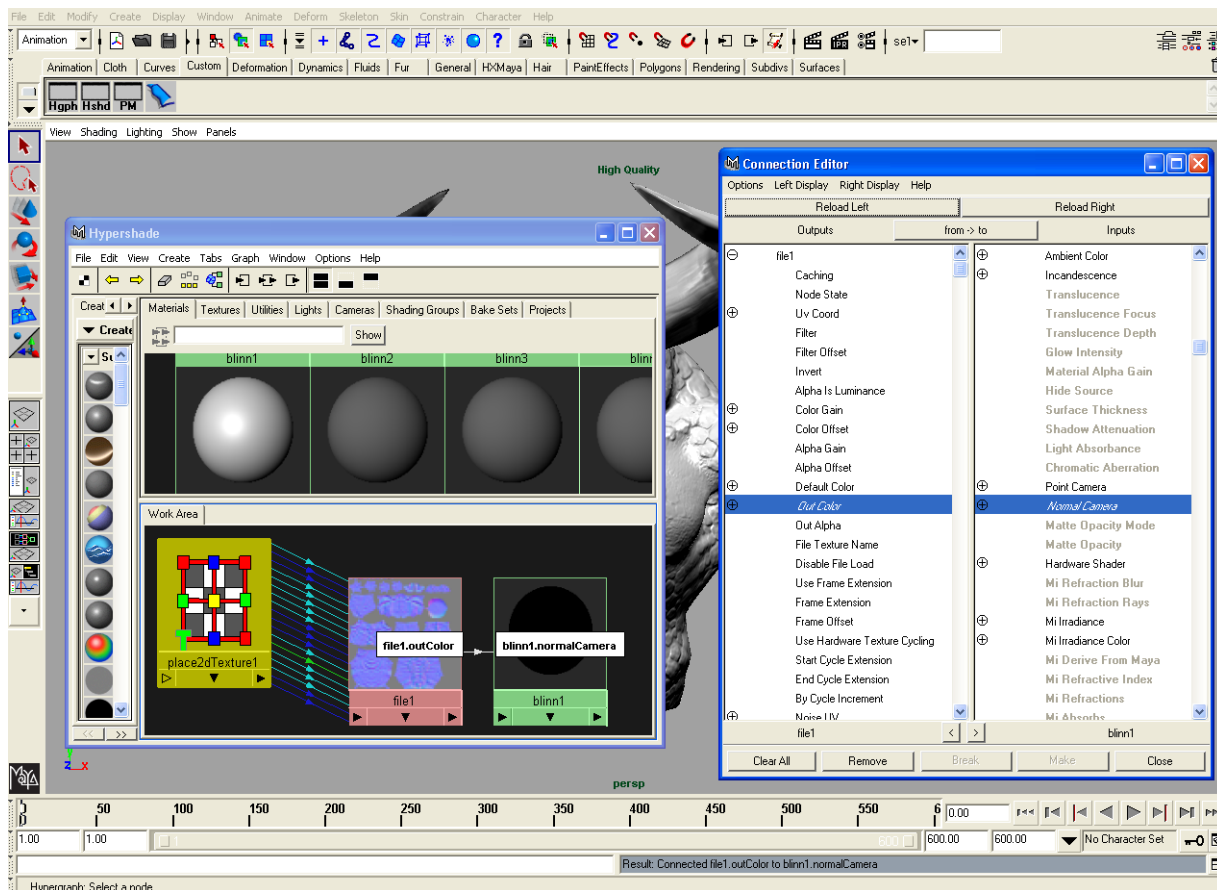


FIGURE 4-37. Shader is created and connected in Maya.

For displaying the normal map, make sure the viewing panel uses Shading > High Quality Shading, Smooth Shade All, and Hardware Texturing. Below is the normal map example test of each piece.

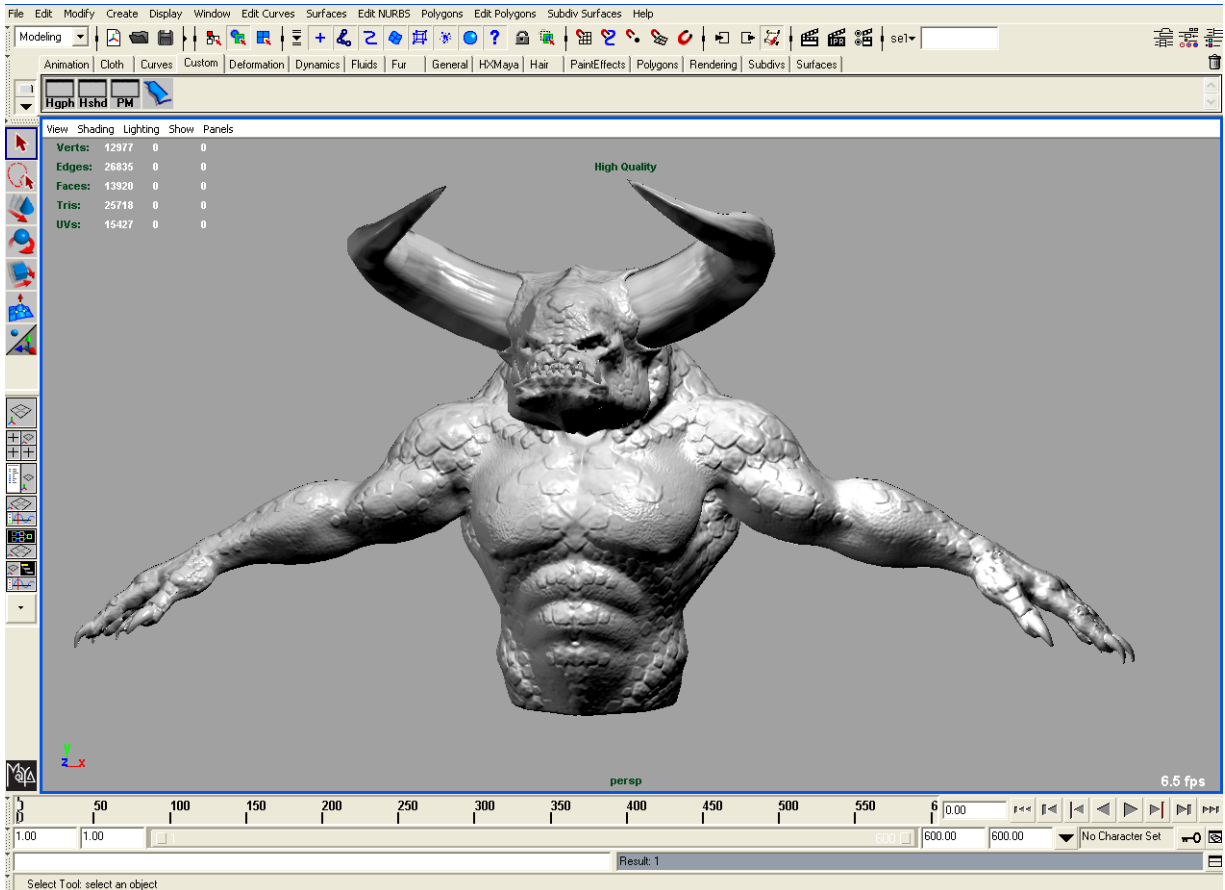


FIGURE 4-38. Complete model shown with Normal Maps in Maya.

Next follows an example of displacement mapping using the same model and Boundary surfaces generated in Maya.

Building for a height map is much the same as for normal mapping; beginning with a similar polymesh as before with proper normals and UV mapping.

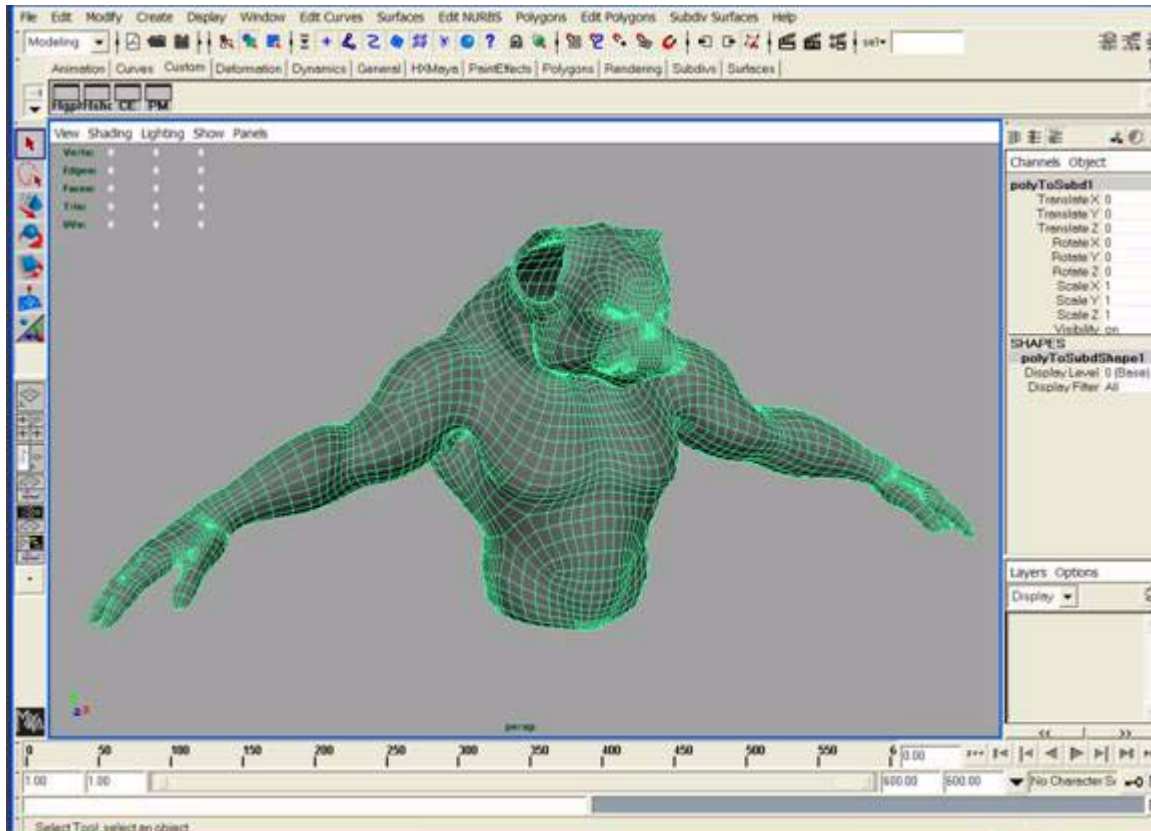


FIGURE 4-39. Polymesh of model

Back up your Maya file and make a temporary copy of each piece and triangulate and smooth it so no faceting is visible on the surface of the shaded object. Export these as OBJ files, which will be used to provide UV reference to ClayTools during the Height map generation, and can be deleted from Maya after exporting them.

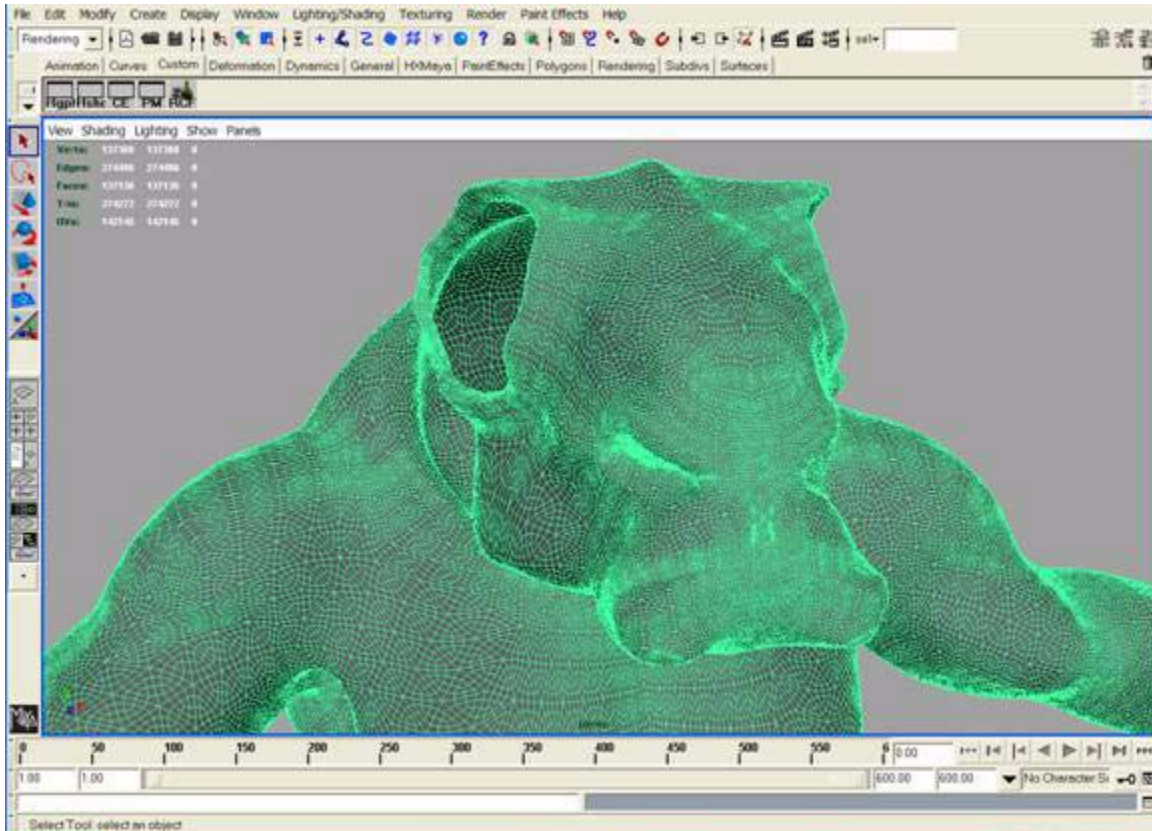
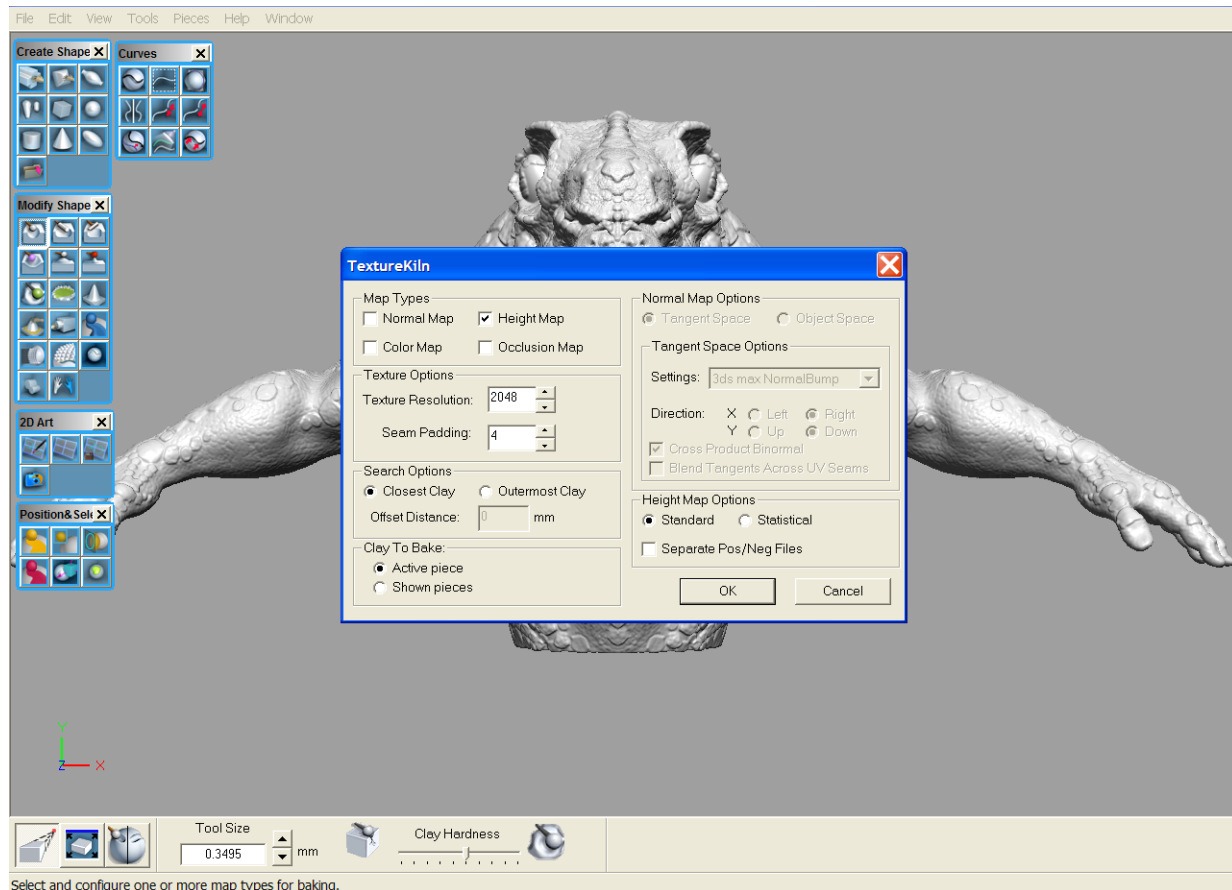


FIGURE 4-40. Each piece is smoothed to removed faceting on the surface

Use TextureKiln in ClayTools to generate the height map for each detailed piece of the highly-detailed model created by Modeler One (see Figure 4-34), referring to the OBJ files with the UV coordinates saved from Maya. Here the height map is being saved at 2048 pixels for the active piece. The Standard method (as opposed to Statistical) is being used. Depending on how closely the UV model OBJ file follows the contour of the clay piece will dictate which method to use.



In this case, Standard achieved the most usable results, though Photoshop® was used to adjust the levels to a more contrasted range. Because the curve frame was created on a simple model, which was fairly different in contour than the detailed clay final model, some range of the height values was lost.

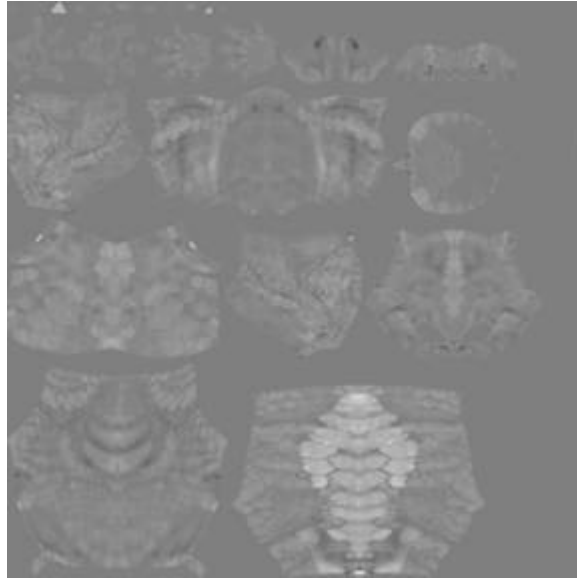


FIGURE 4-41. Due to the differences in the two models the height map generated lacks some contrast.

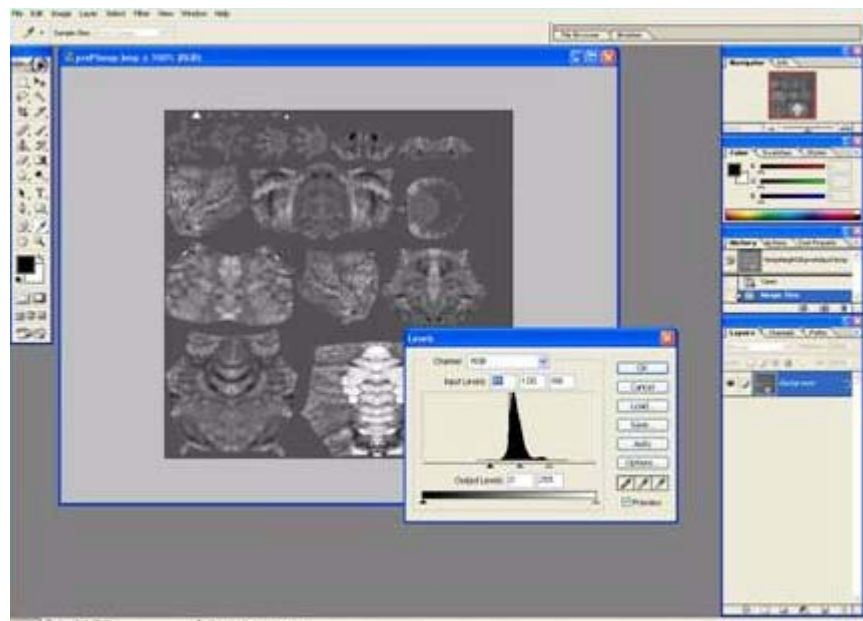
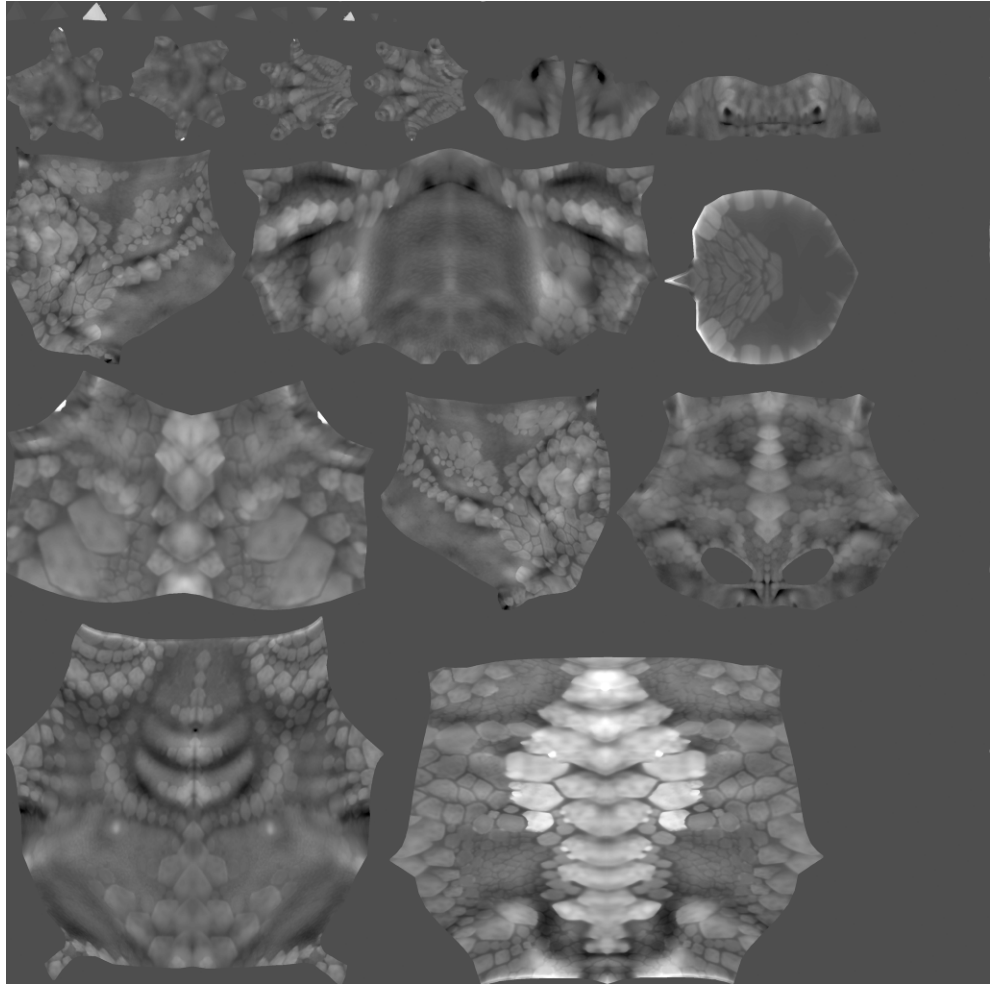


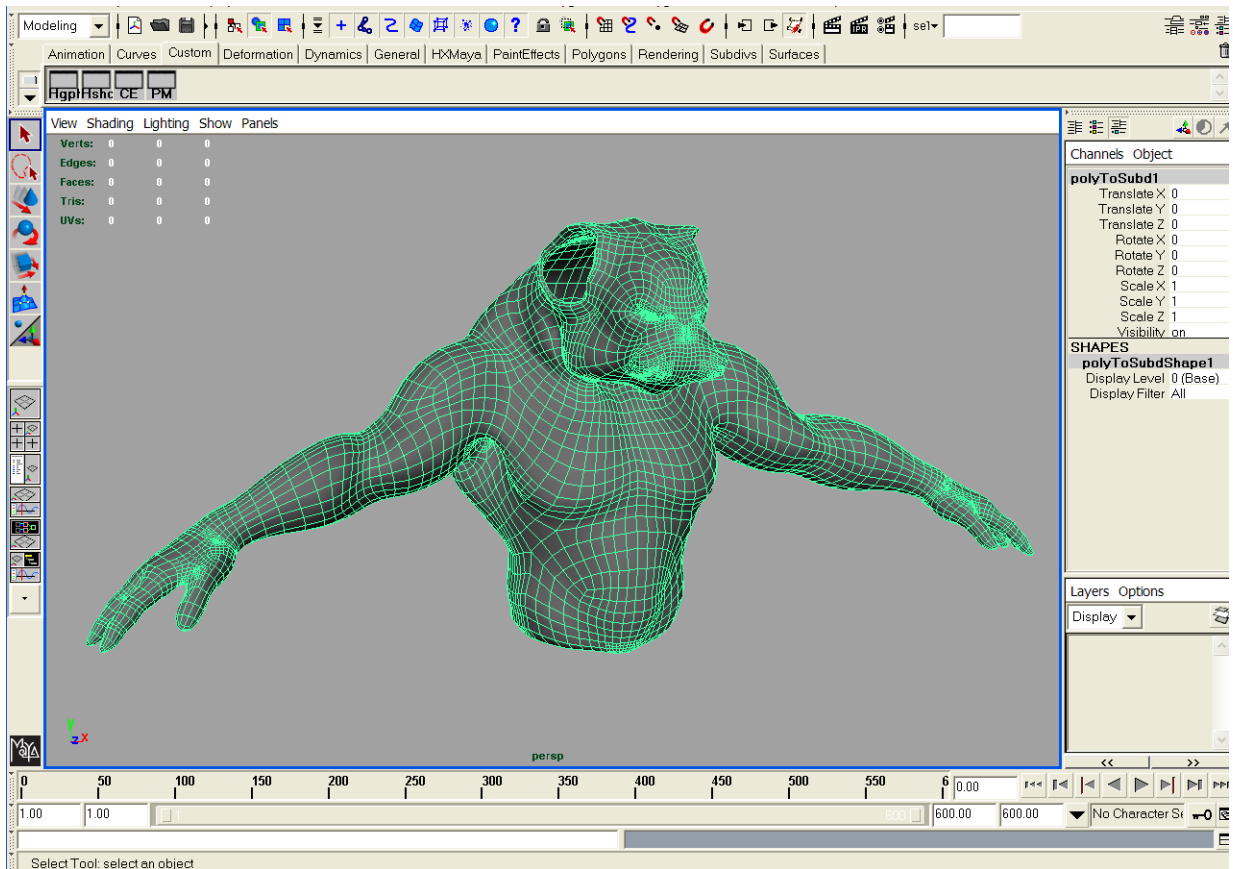
FIGURE 4-42. Photoshop is used to adjust the levels.

Adjusting the file in Photoshop brought the levels back to a wider range. Creating the curve frame on the model when it was closer to finish would have made this adjustment unnecessary.



Applying Height Maps

Before the maps are applied, the polygons are converted to SubD surfaces for the Maya renderer. The polygons could also be rendered in Maya, mental ray® or RenderMan®.

Once the file maps have been created, connect the file textures to the shaders on each piece. Below, the mapping has been connected to the displacement as well as bump channels, and the Alpha Gain and Alpha Offset have been used to adjust the displacement map.

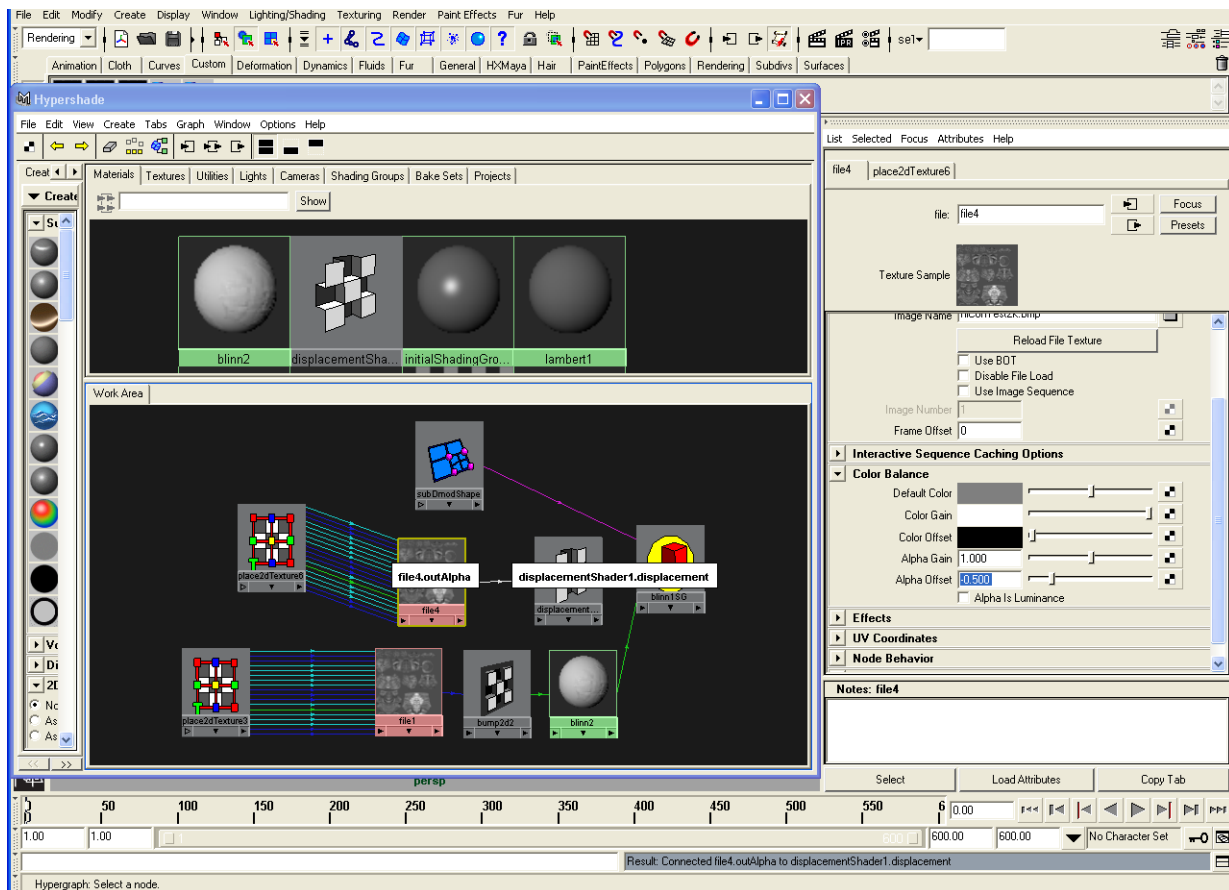




FIGURE 4-43. Test rendering the SubD surfaces in the Maya renderer provided these results on a first test.

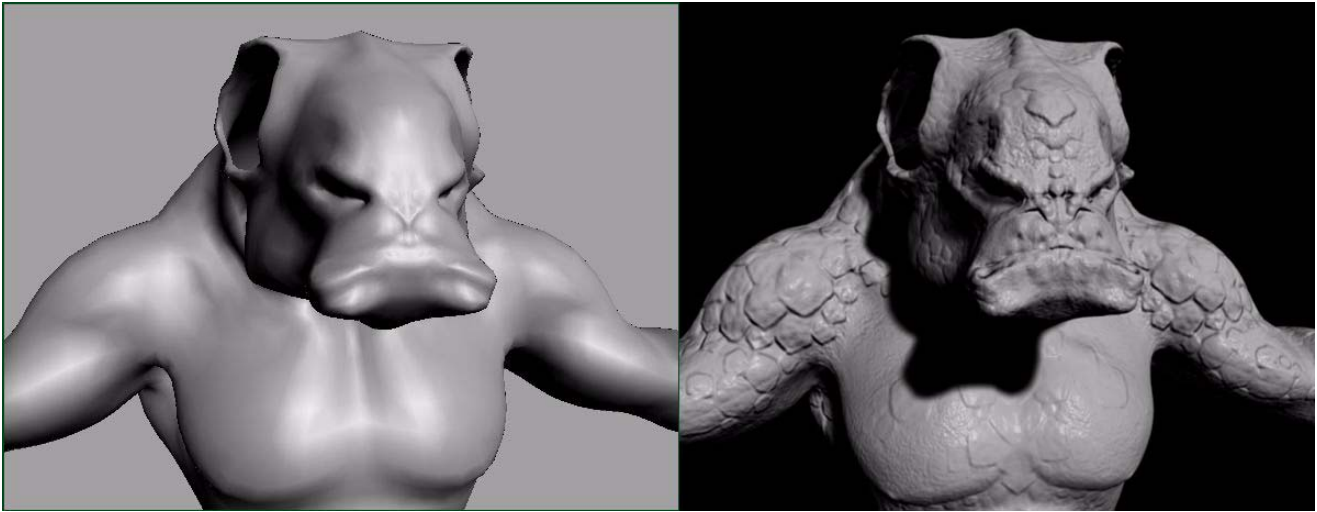


FIGURE 4-44. Comparing the basic form of the torso/head on the left to the rendering of the low-poly model with texture map applied on the right.
